PREA Audit of the Youth Residential Centers

The Prison Rape Elimination Act (PREA) was established in 2003 by President George W. Bush. In 2012, the Justice Department established national PREA standards to eliminate sexual abuse in all confinement facilities. Youth Residential Centers (YRCII's) that contract with the Department of Corrections-Juvenile Services were audited during a three-year cycle from August 2013 to August 2016. The PREA audit process is very involved and takes dedication and commitment on the behalf of the YRCII staff and the juvenile population that YRCII's serve.

- The first part of the process is a pre-audit questionnaire completed by the YRCII. Facilities answered an array of questions that cover the forty-four standards they are accountable for. They provided their auditors with information on policies, procedures, training, and community partners in the questionnaire.
- Next, the facilities had an on-site portion to the PREA audit process. Auditors took tours of the YRCII's across the state. They interviewed a wide range of staff and youth living at the facilities. Auditors verified that PREA standards requested in the pre-questionnaire were part of the culture and practice of the youth residential centers, not just part of policy and procedure.; auditors looked to see that were

The final step in the audit process is to issue a final report on PREA compliance to each facility audited.

After what was no doubt a grueling and often times challenging audit for the YRCII's; all Kansas YRCII's have passed their PREA audits and are in compliance! The PREA team at KDOC is happy to say that our YRCII's are ROCKSTARS! The work that they do as part of the juvenile justice system is important. The efforts that YRCII's do to prevent, detect, and respond to PREA concerns is outstanding.

Indiana to Begin Evening Reporting Program for Juvenile Offenders

In recent years, Kokomo attorney Erik May has worked to alter the philosophies and complications surrounding secure detention for juvenile offenders, a goal which is set to soon see major progress. Since 2012, in eight JDAI counties, admissions to detention has dropped by an average of 44.7 percent and average daily populations in detention reduced by 40.7 percent by the end of 2012, according to the Indiana's Division of Youth Services.
