The Consolidated Appropriations Act (PL 116-260) was signed into law on December 27, 2020. The Supporting Foster Youth and Families through the Pandemic Act (H.R. 7947) was included in the Consolidated Appropriations Act and provides funding to every state to support youth and young adults during the COVID-19 pandemic. The Kansas Department for Children and Families (DCF) has developed the Independent Living (IL) Pandemic Relief Program to provide financial assistance to eligible individuals. Read more....

The Supreme Court has denied the appeal of a juvenile offender almost two decades after his conviction was made final. The Kansas Supreme Court says in the case of Appeal N the Matter of I.A., it held that it lacked jurisdiction to hear the appeal of a juvenile offender that challenged his conviction almost 20 years after the conviction was made final. The Juvenile Justice Corner Jim Johnson, Program Consultant **DOC - Juvenile Community Based Services**

Late last month KDOC notified local Judicial Districts (JD's) of awards made for the Fiscal Year 2022 JCAB Grant Applications (Juvenile Corrections Advisory Board Grants) made available using the funds from the ! Programs Account. With these grants, local JD's through their Juvenile Corrections Advisory Board could identify a specific area of need or a gap in services that needed to be addressed. JCAB grant funds could be used to help provide an evidence-bas gram to address that targeted area. In many cases Judicial District staff identified resources within the community and colaborated with community partners to address a shared area of concern.

For FY'22, 22 Judicial Districts submitted a total of 41 program or service proposals. Of the 41 proposals received, 39 were approved. (In FY'21, 18 JDs submitted a total of 53 proposals, and of those 38 were approved).

The Crossover Youth Practice Model - Update **Daniel Olson, CYPM Coordinator** Office of Judicial Administration

The State Policy Team (SPT) continues to work towards fully establishing the Crossover Youth Practice Model (CYPM) in 3 counties, Montgomery, Shawnee, and Sedgwick

SPT is working to identify barriers that the youth and families face. This is important to implementation of the CYPM because the process will be more fluid. It will create a uniform process across the state for agencies to follow that will benefit youth and families.

Shawnee (SNCO) and Montgomery (MGCO) Counties are developing focus groups for their area. These focus groups will be made up of past youth and parents who have been involved in either the foster care system, juvenile justice system, or both. Questions are about barriers and what was helpful to families when they were involved with the system are being developed in order to help guide the team.

They are also working on developing a Guiding Coalition. The Guiding Coalition will be made of community members or organizations who will identify resources in their local communities and to help overcome obstacles that are discovered.

The third county, Sedgwick County (SGCO), is working on an inventory of their assessment's tools used at the multiple agencies involved with the families. They are working to determine what assessments could be streamlined and decrease redundancy. SGCO has started the process of developing a "101" cross systems training for their county, so stakeholders have a better understanding of how each agency operates.

Kansas News - FY22 Approved JCAB Grants

Youth Justice Resource Center (YJRC) * Provides evidence-based programs/services (i.e. Strengthening Families, Aggression Replacement Training (ART), Moral Reconation Therapy (MRT), Crossroads and Parent Project) for justice involved youth (and/or families) that have been through Juvenile Intake and Assessment, or youth in Immediate Intervention Programs, or youth supervised by Court Services or Community Corrections and/or crossover youth.

Coordinated & Individualized Community-Based Services Provide mental health or substance abuse treatment &/or assessments, mentoring, tutoring, transportation, childcare, cell service, internet access, sport participation fees or equipment and/or clothing and housing assistance for justice involved youth (families) or youth exhibiting offender behaviors but not charged.

KCSL Oasis

Provide in-home case management to youth and family to improve family functioning and prevent out of home placement.

Boys & Girls Club of Topeka Career preparation, education assistance, financial literacy & leisure/recreation activities for justice involved or other at-risk youth.

One Heart Project Kansas *

Provides social & emotional intelligence education, mentoring, tutoring, gap skill training, employment and reentry services for justice involved and at-risk youth at an alternative school and middle school.

Behavioral Health Services **

Provides behavioral health services that include care coordination, mental health & substance abuse treatment and cognitive behavioral programming for youth accused and adjudicated as Juvenile Offenders.

Mirror, Inc. *

Provides Parent Project training for parents of justice involved youth and Teens Intervene for youth experiencing problems associated with alcohol &/or drug use.

10th JD **Mental Health for IIP Youth** * Provides psychological evaluations, individual therapy, adjunctive family therapy, medication management and case consultation for youth referred from Court Services going through diversion process.

Intensive Outpatient Program *

Provides treatment to target conduct issues, substance use/abuse, compliance issues, poor decision making, anger control and school issues for IIP referred youth and/or youth whose charges are also in the juvenile court system.

Juvenile Drug Treatment Court Support * Provides treatment and accountability to juvenile offenders on court ordered probation for drug related crimes and drug use impacting their lives and communities.

IIP Support **

Help provide staffing to support pre and post file IIP youth for first or second-time offender youth identified by DA's Office as IIP eligible.

Parent Management Training *

Provides in-home Parent Management Training-Oregon Model (Generation PMTO) and Parenting Through Change (PTC)-Reunification for youth experiencing impaired functioning at home, in the community or at school.

Program Advocate

Provides mentoring, employment services, the Giving Back Community Service Work (personal responsibility) program and life skills programing for justice involved youth. Continued next page . . .

Supreme Court Decision Could Mean Increase in **Labor Trafficking of Farmworkers**

In June of 2018, two Monterey County (CA) site inspectors visited a Salinas cannabis farm, where they encountered a small group of farmworkers who they suspected had been trafficked. The farm workers, who spoke no English, took off running when Monterey County Resource Management Agency officials approached them. They couldn't go far, though the cultivation site was fenced in The farmworkers seemed terrified, the county's prosecuting Read more.

Black Kids Can Get Caught Up in a Juvenile Justice System That Often Fails, Though Some Programs Work

Black juveniles in Florida are arrested at higher rates compared to all other ethnic groups and struggle to get into diversion programs aimed to prevent kids from entering the criminal justice system, according to the Florida Department of Juvenile Justice. The situation is problematic in part because legislation to expand the pool of youth offenders eligible for various prevention programs was vetoed by Gov. Ron DeSantis last week, because of concerns about allowing felony cases in the diversion programs. Read more...

Each year, more than 3,000 young people are referred to the Hamilton County (OH) Juvenile Court. A new initiative looks to see how those youth could be better served. For a number of years, the court has engaged in efforts to divert as many young people as possible away from detention facilities and eventual intake into the adult justice system. But challenges remain. A disproportionate number of those taken into the local juvenile justice system are people of color. Michigan Launches Task Force to Improve Youth **Outcomes in Juvenile Justice System**

A new bipartisan task force announced this month by Governor Gretchen Whitmer will develop data-driven recommendations to reform Michigan's juvenile justice system. Although **Michigan** has made recent strides in juvenile justice reform, including raising the age of criminal responsibility from 17 to 18 years old in 2019, it still has one of the highest rates of detained youth in the country, especially for low-level, noncriminal behavior. A 2017 ProPublica study found that 30 percent of detained youth in Michigan were there for noncriminal offenses, compared to 17 % Read more

Missouri Lawmakers Passed a Host of Reforms Aimed at Keeping Kids Out of Jail

Retired St. Louis (MO) Judge Evelyn Baker once sentenced a 16year-old Black boy to 241 years in prison for two armed robberies. No one was seriously injured in the robberies, but the boy "didn't express any remorse," Baker said, remembering the sentencing hearing. Now, when she thinks back, Baker deeply regrets the sentence she gave Bobby Bostic in 1997, who at 42 is still imprisoned in Jefferson City Correctional Center. "I now realize what I was dealing with was a 16year-old child, trying to pretend that he was really, really tough," Baker said. "It was adolescent bravado." Read more . . .

Research: Electronic Surveillance has Failed to Reduce Girl Recidivism in the Juvenile Justice System

In recent years, many juvenile courts have adopted house arrest with electronic surveillance tethers instead of institutional imprisonment. A new study looked at whether this approach would reduce recidivism in girls involved in the juvenile justice system. The study found that tether was unable to reduce recidivism in girls. In fact, home arrest limits access to girls' treatment programs, so they can be harmful. This study by researchers at the University of Cincinnati (UC) and Michigan State University Justice Evaluation Journal, A publication of the Academy of Criminal Justice. Read more.

11th LB/CK JD CMHC Contract

Provides life skills, cognitive groups (Crossroads Curriculum) and mental health services for juveniles with IIP's or supervised by Court Services or Community Corrections.

Expands the Jobs for America's Graduates-Kansas (JAG-K) program to serve justice-involved youth in additional schools within the JD.

13th JD **Empowered, Engaged, and Peaceful Families**Provides services to youth (families) at risk of removal from the home and placement into the foster care of juvenile justice systems.

14th JD **Program Specialist**

Provides services to youth (families) to include Moral Reconation Therapy (MRT), Parent Project, Forward Thinking and other cognitive groups.

Four County Mental Health Center Provide individual and family therapy to justice involved youth (families) for low-risk youth, who do not meet criteria for FFT.

Untamed Athletes Inc. *

Provide services to justice involved youth (families) through sports programming, academic tutoring, mentoring and life skills training.

Parent Project

Provides Parent Project training for parents of justice involved youth that come through Juvenile Intake and Assessment as an alleged JO or are under supervision as a JO.

Interventions & IIP *

Provide services to justice involved youth (families) through Forward Thinking (cognitive based) and Parent Project programing and IIP referrals.

Big Brothers Big Sisters

Provide services to justice involved youth, at-risk youth, and/or their siblings school-based, community-based, and job mentoring.

25th JD **LiveWell** Provide training for 25th JD staff, schools & community partners who work with justice-involved youth on Mental Health 1st Aid, Adverse Childhood Experiences (ACES) & trauma.

Grief Counseling

Provides grief and trauma counseling for youth who have experienced some kind of loss, paired with Moral Reconation Therapy (MRT) to address criminogenic needs

CAPS Family Mentoring Program 28th JD

Provides family mentoring services for Spanish speaking families.

29th JD **Girls Circle (Court Services)**Covers training costs for Court Services staff to become facilitators.

29th JD **Warriors4Wyandotte** Provide community-based mentoring, life skills, job preparation & tutoring for justice involved youth.

Sumner County MH

Provide youth at risk to enter the juvenile justice system behavioral health services by providing wraparound case management using the School Responder Model
