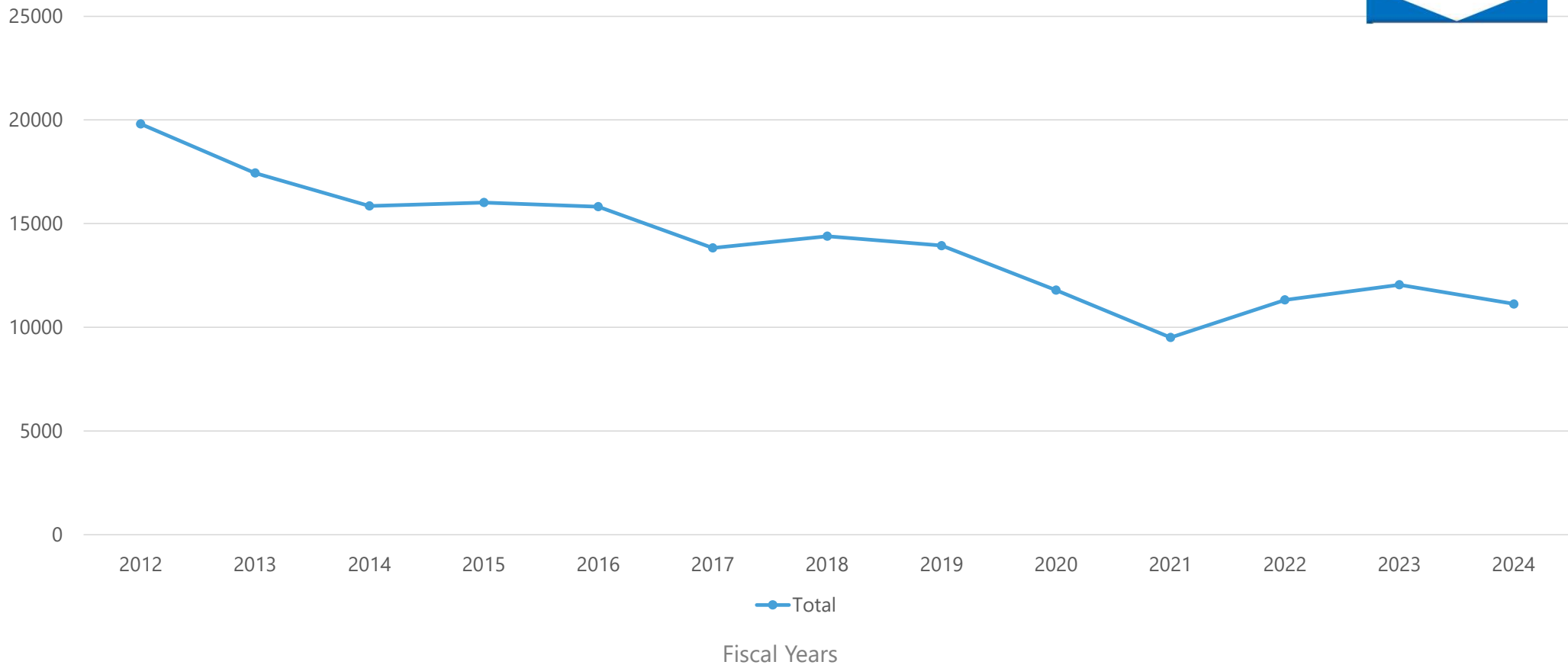

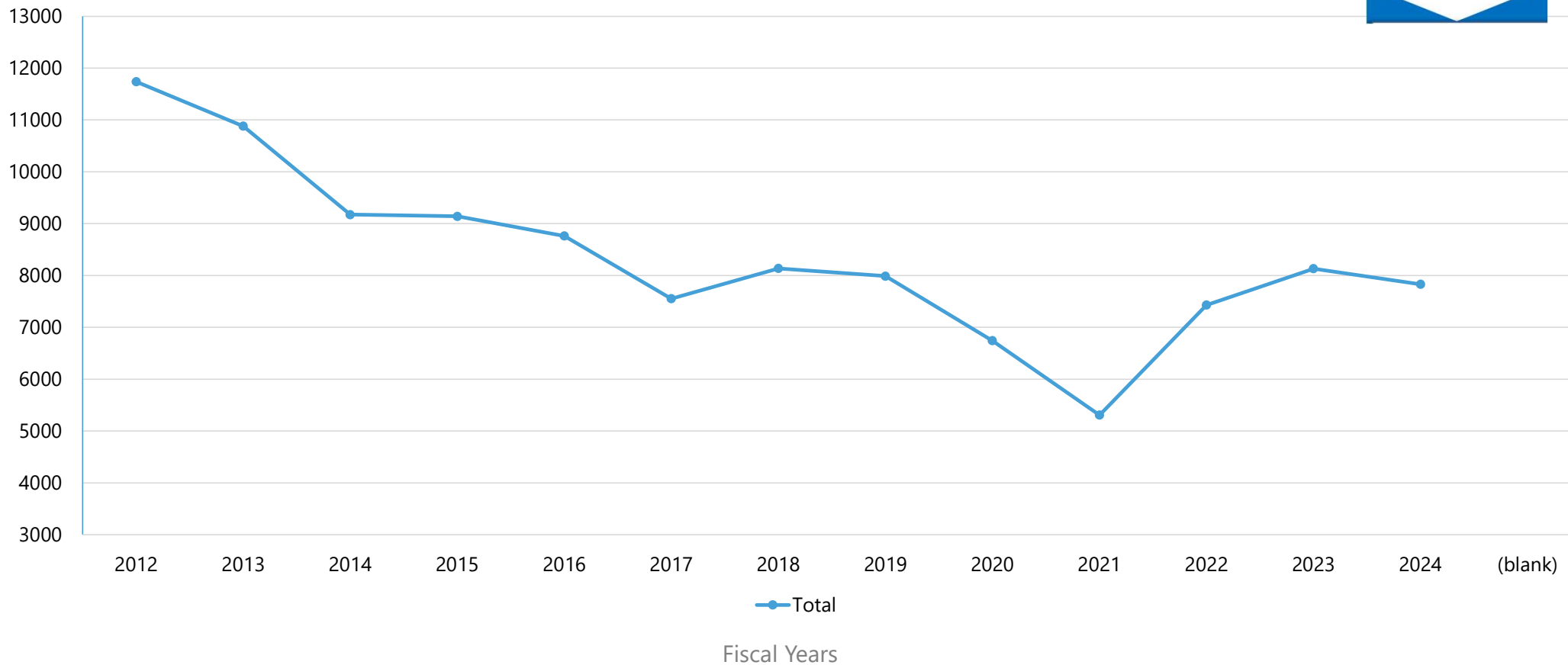

Juvenile Intakes (All Types)



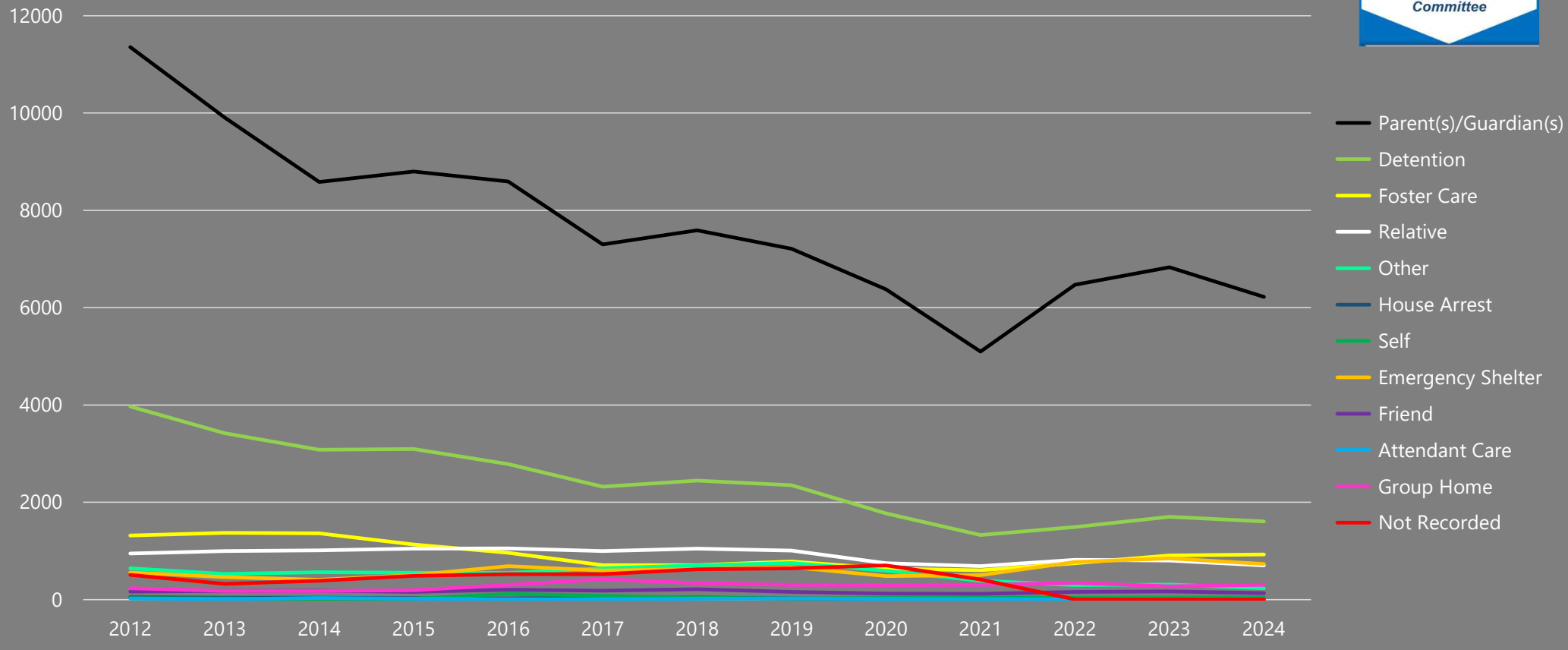

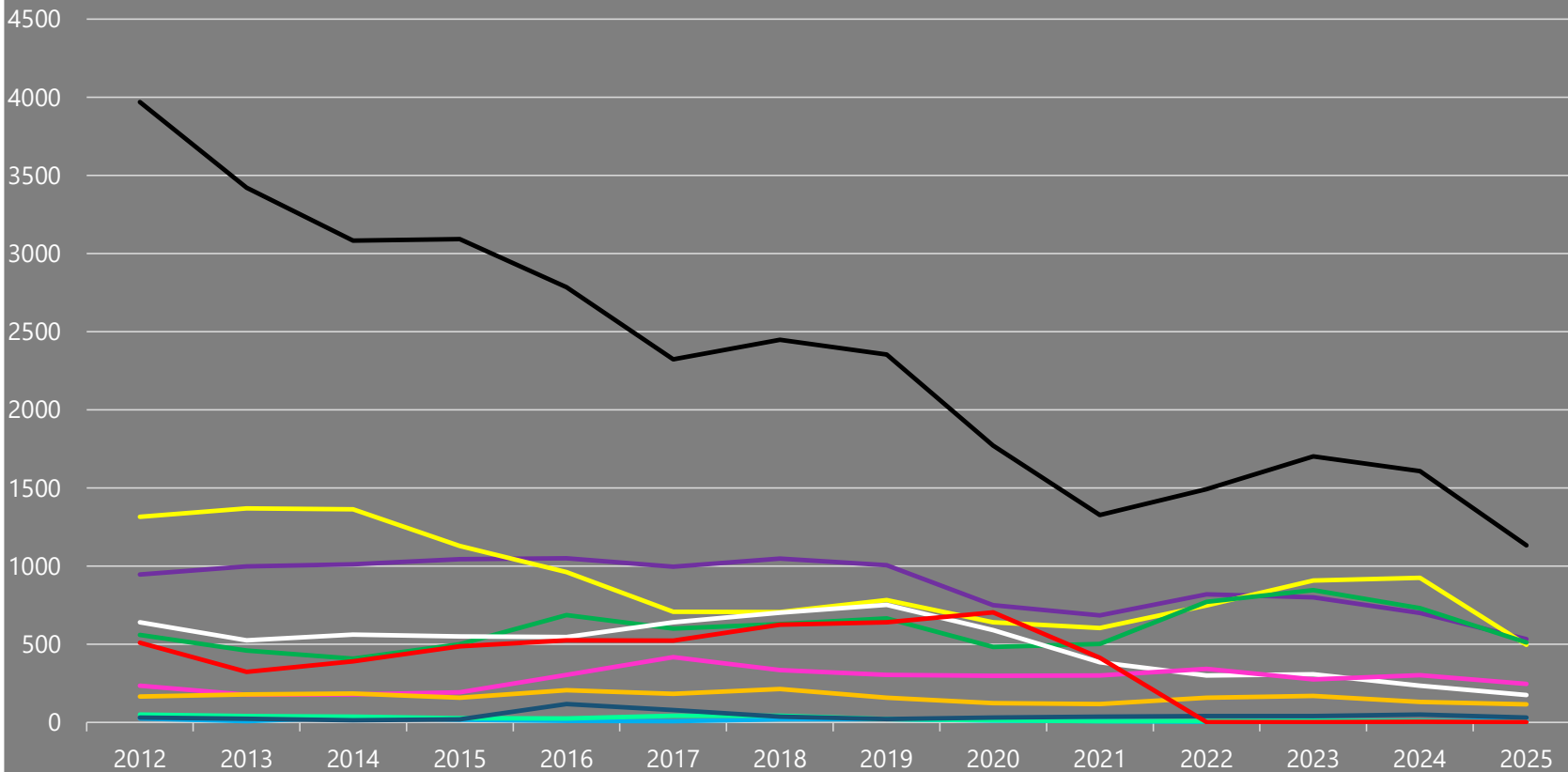

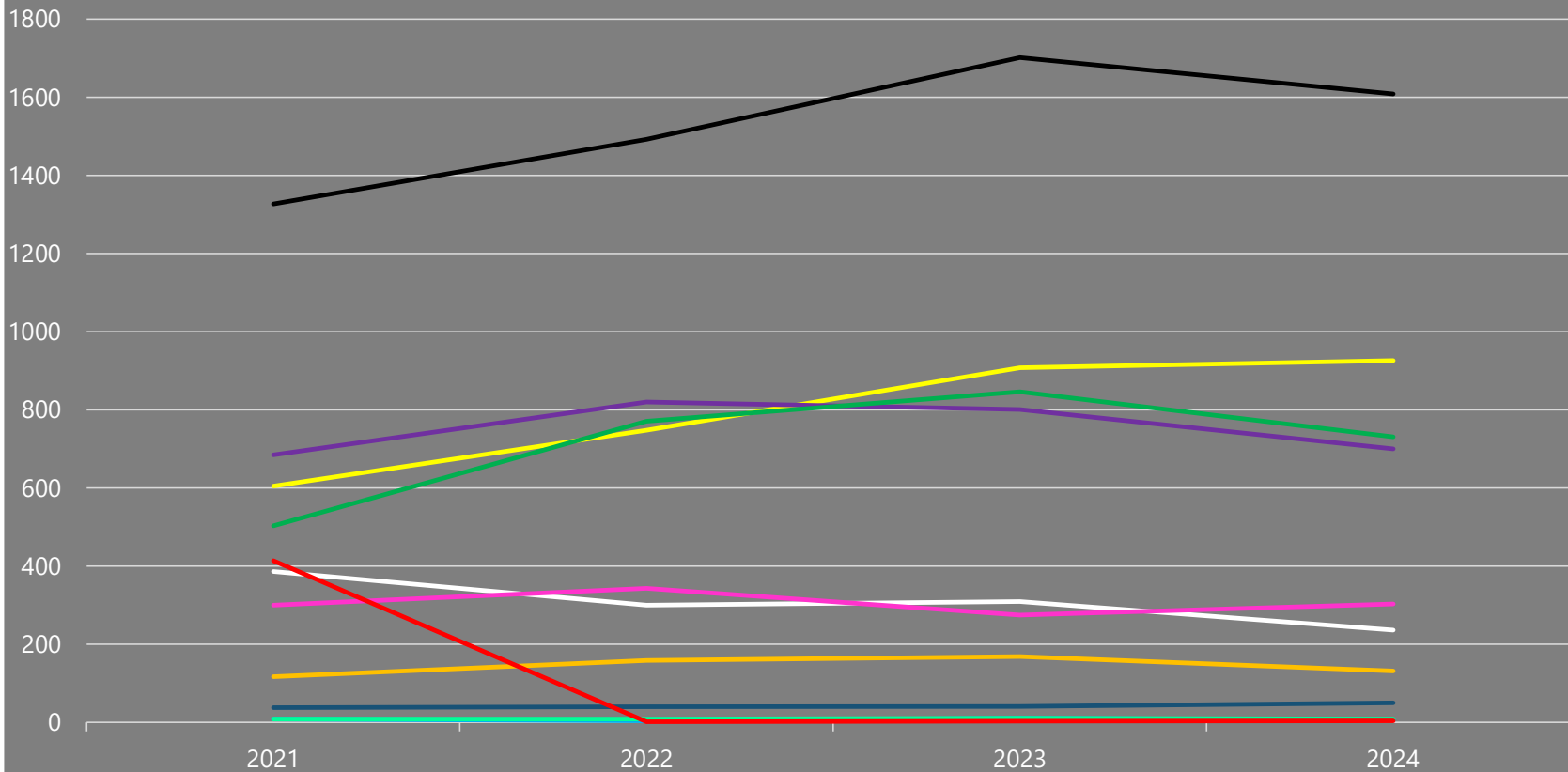

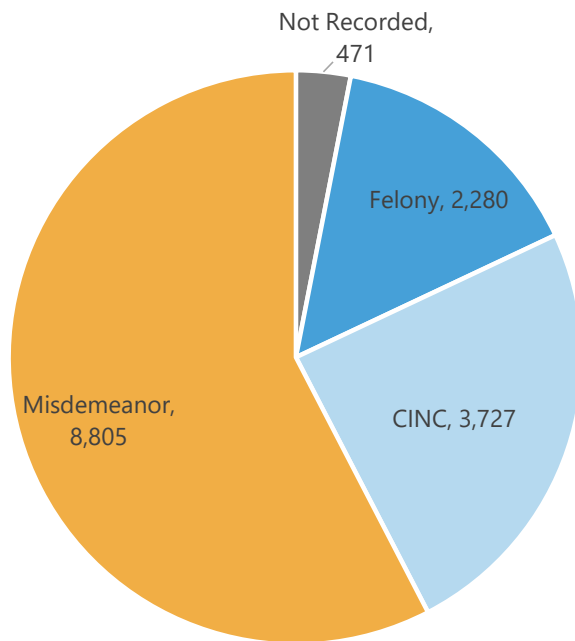

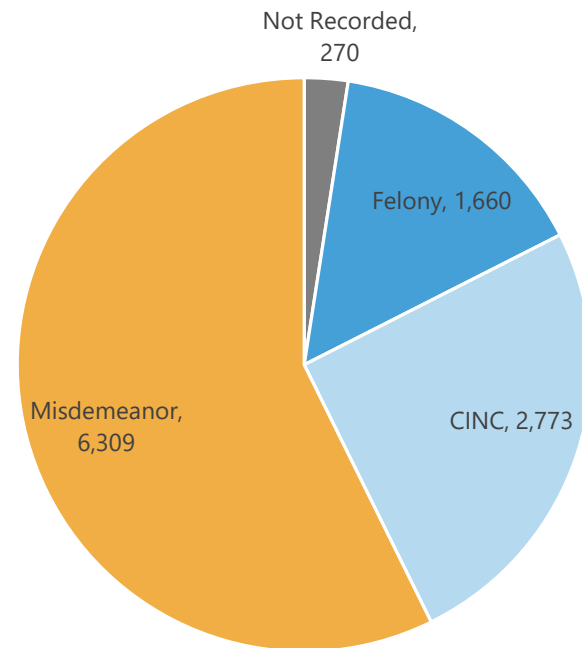

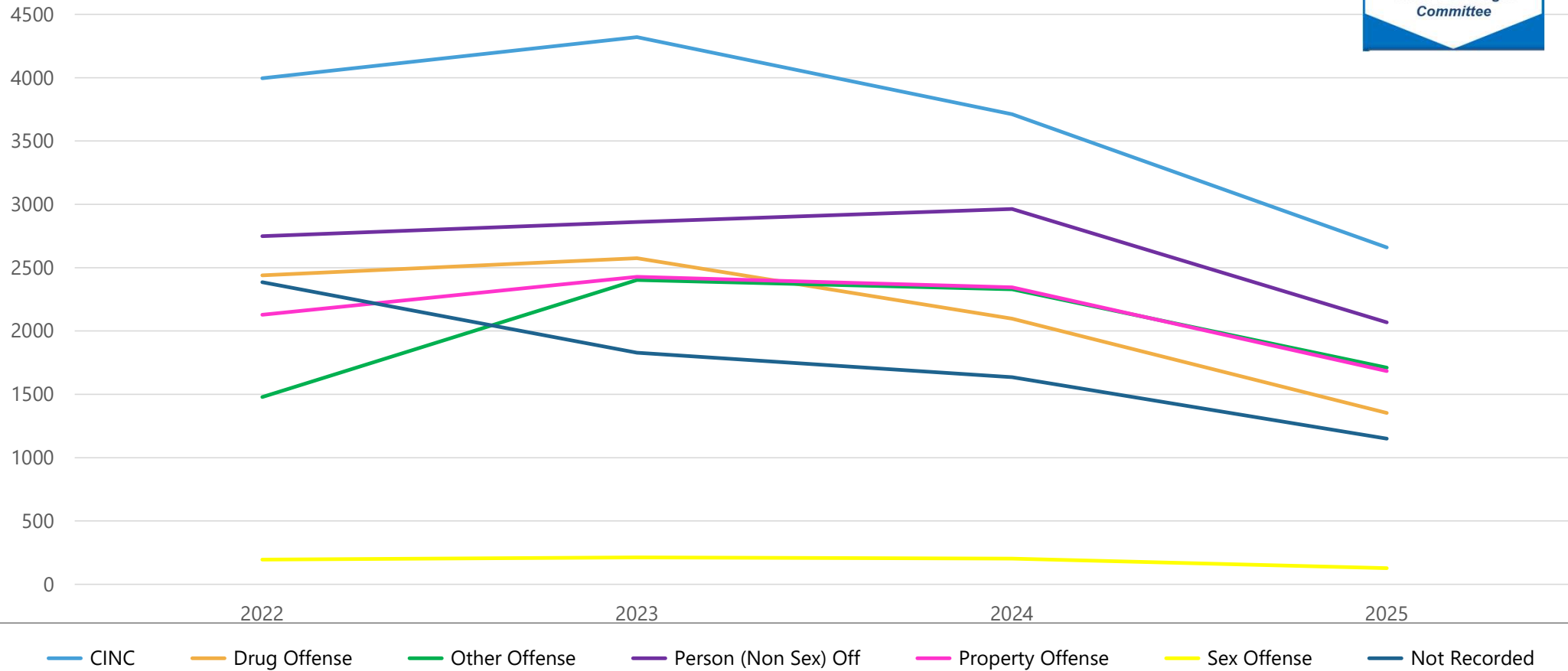

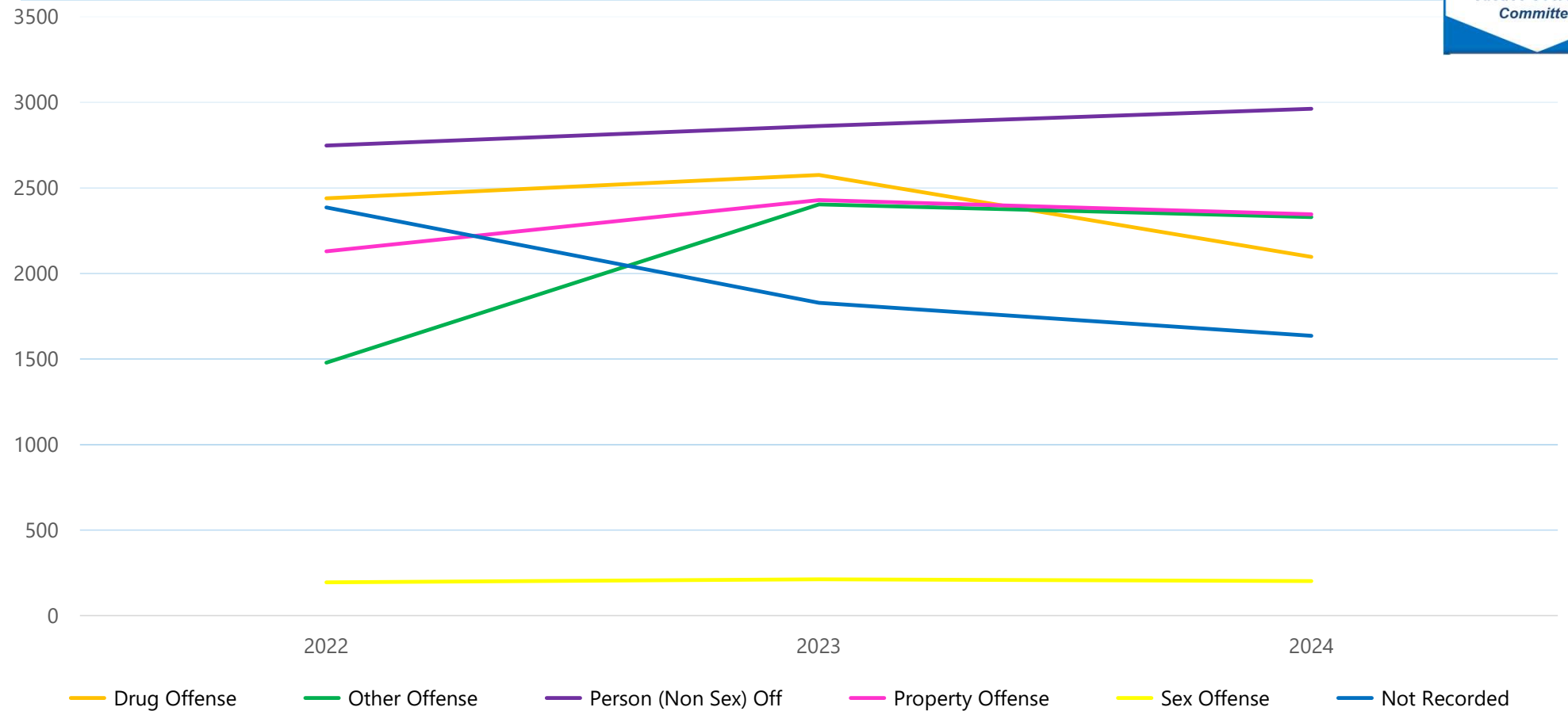

Intake by Cause/Offense Type

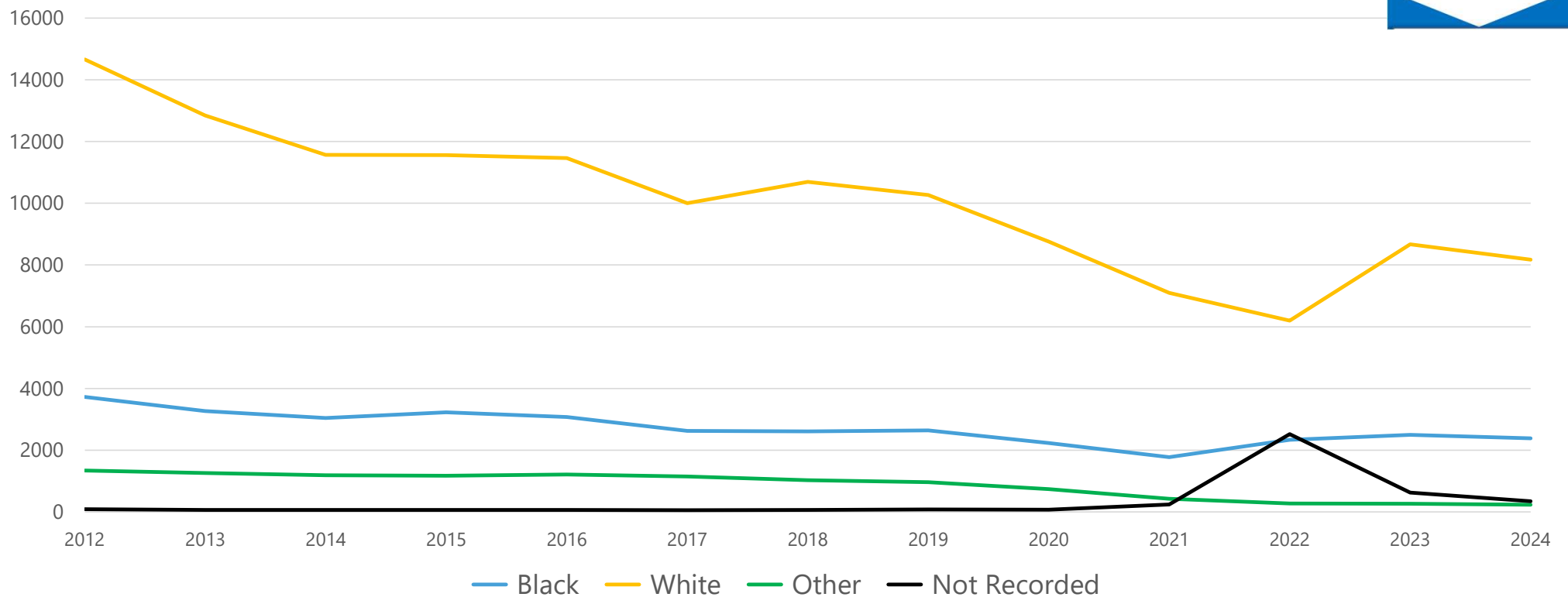

Intake by Offense Type (without CINC)



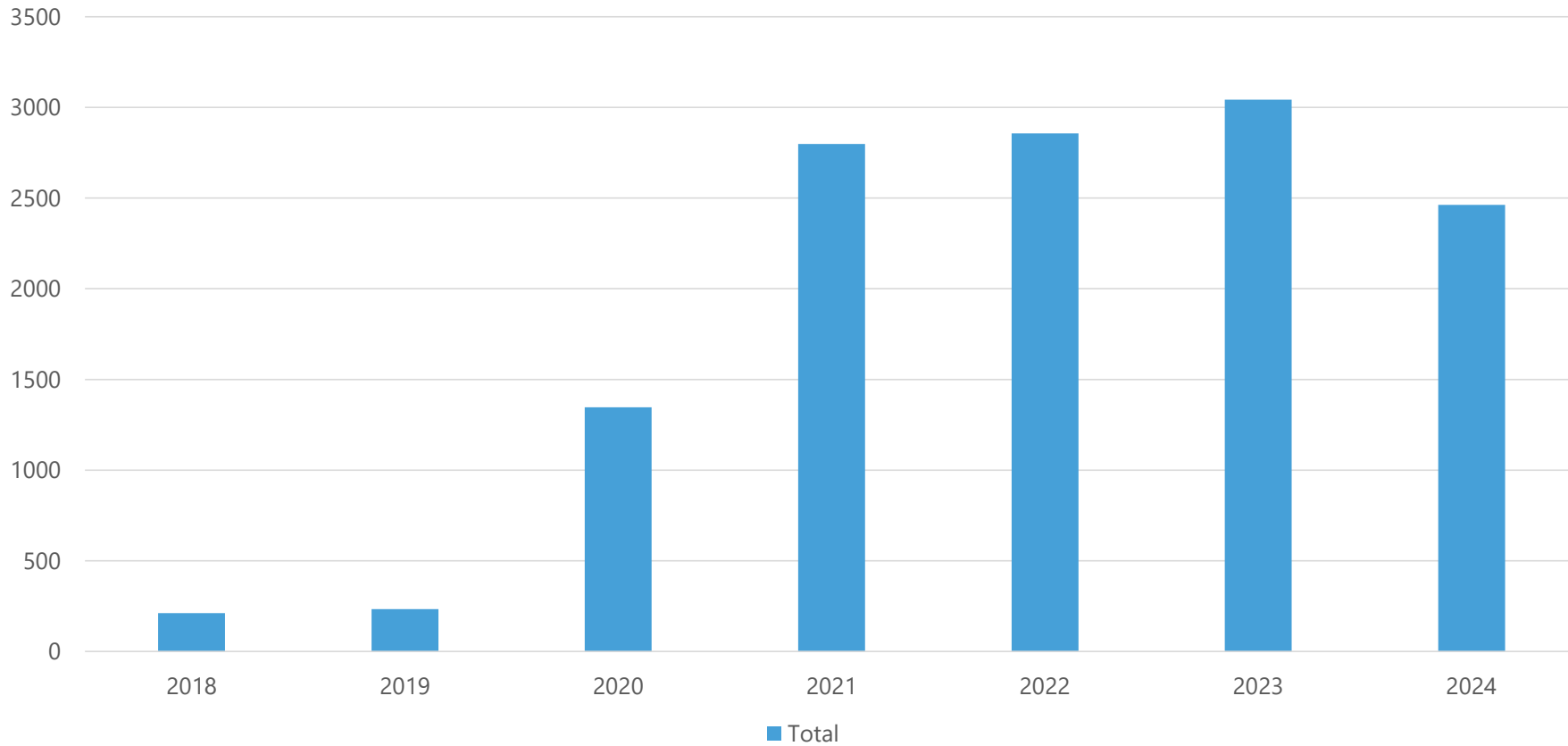

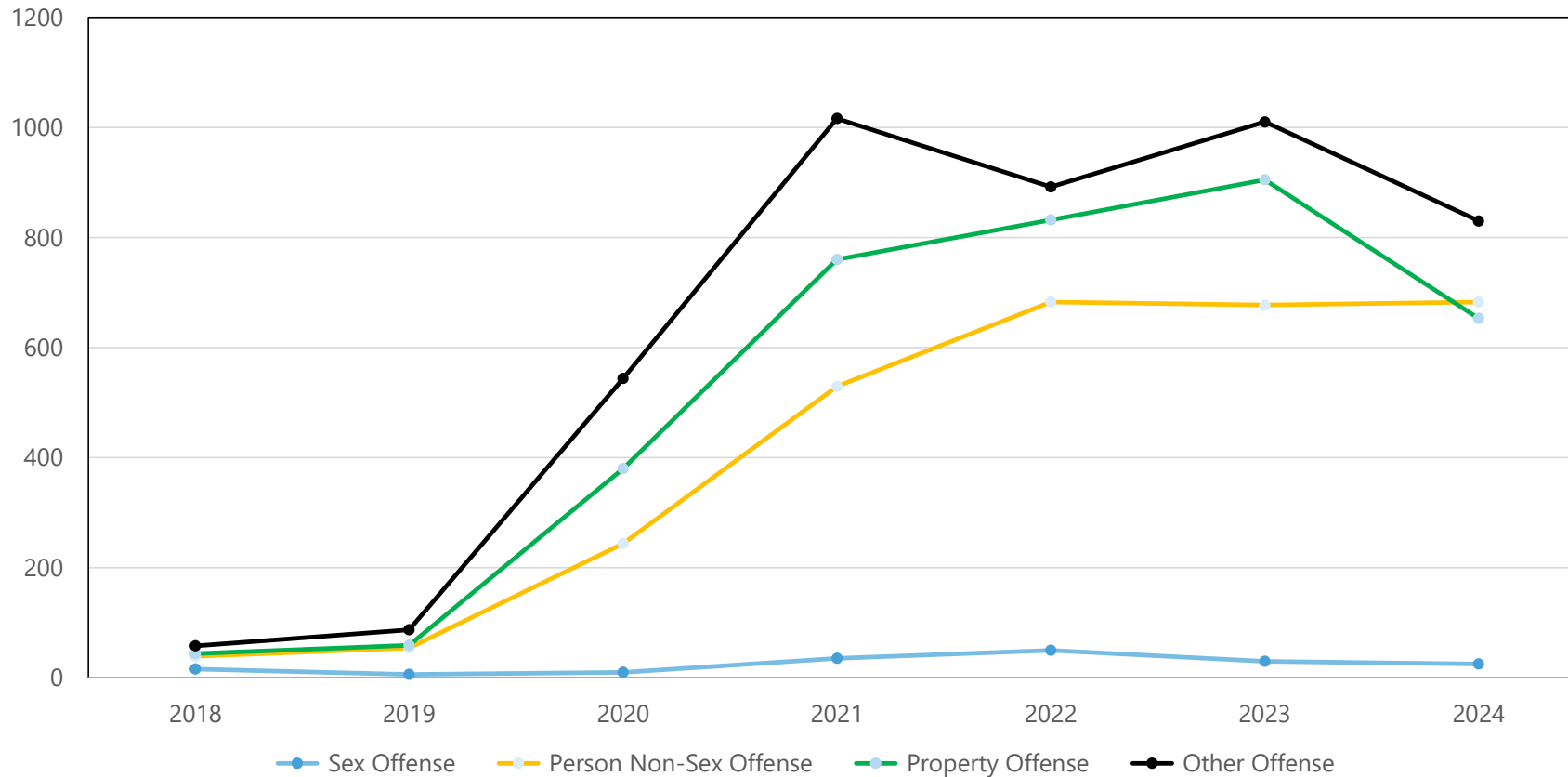

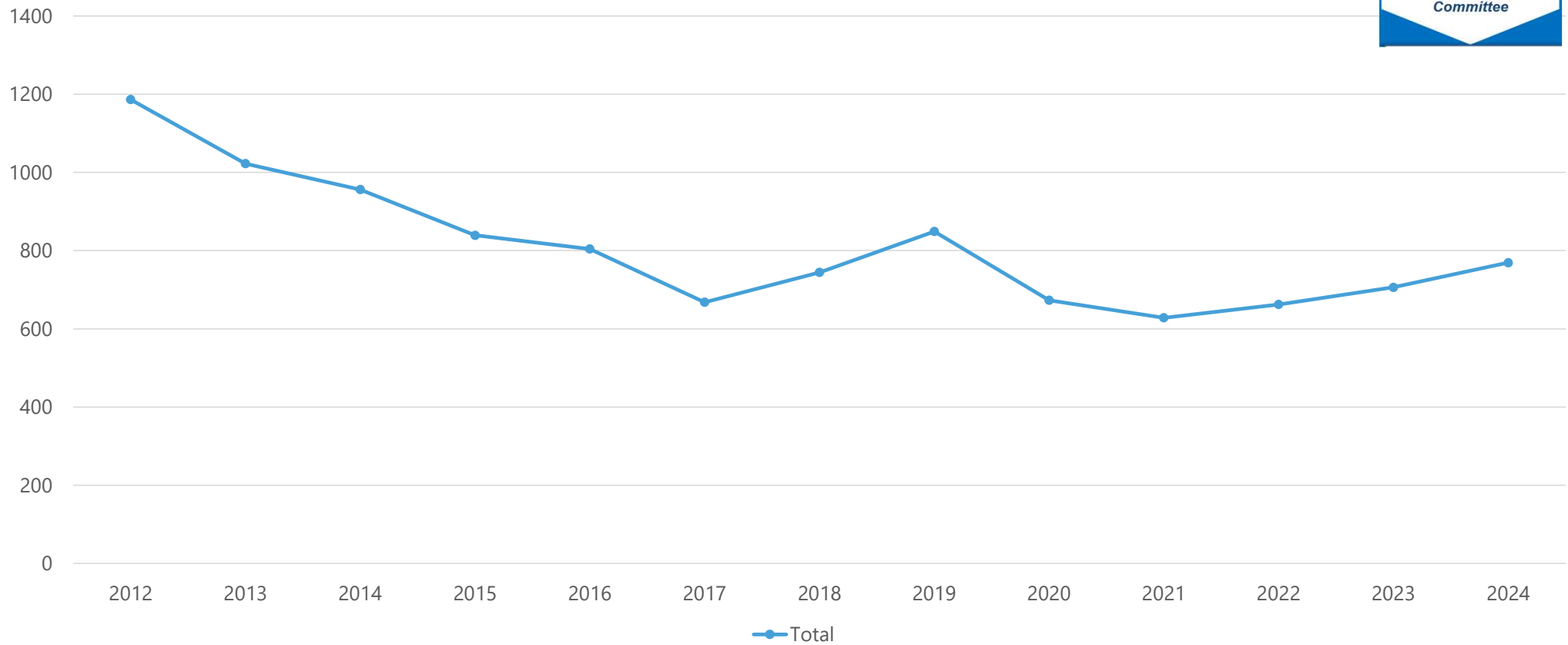

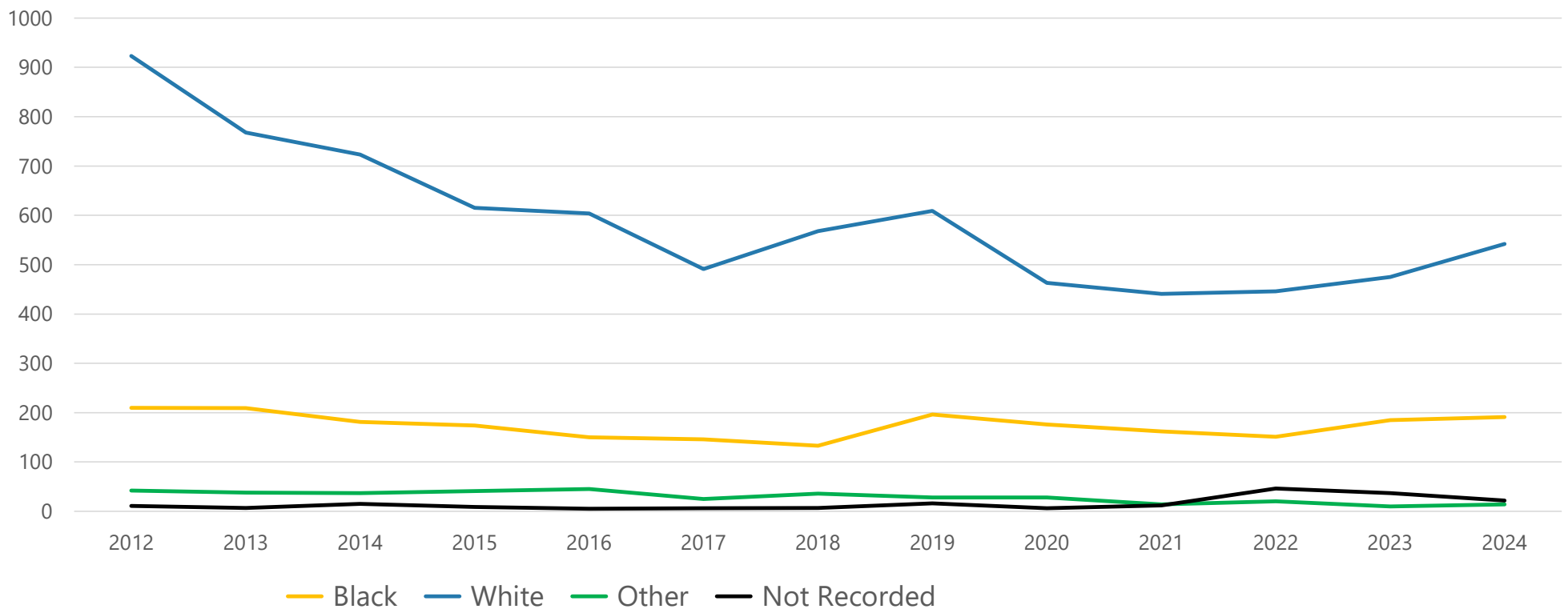


Total Ordered to JISP

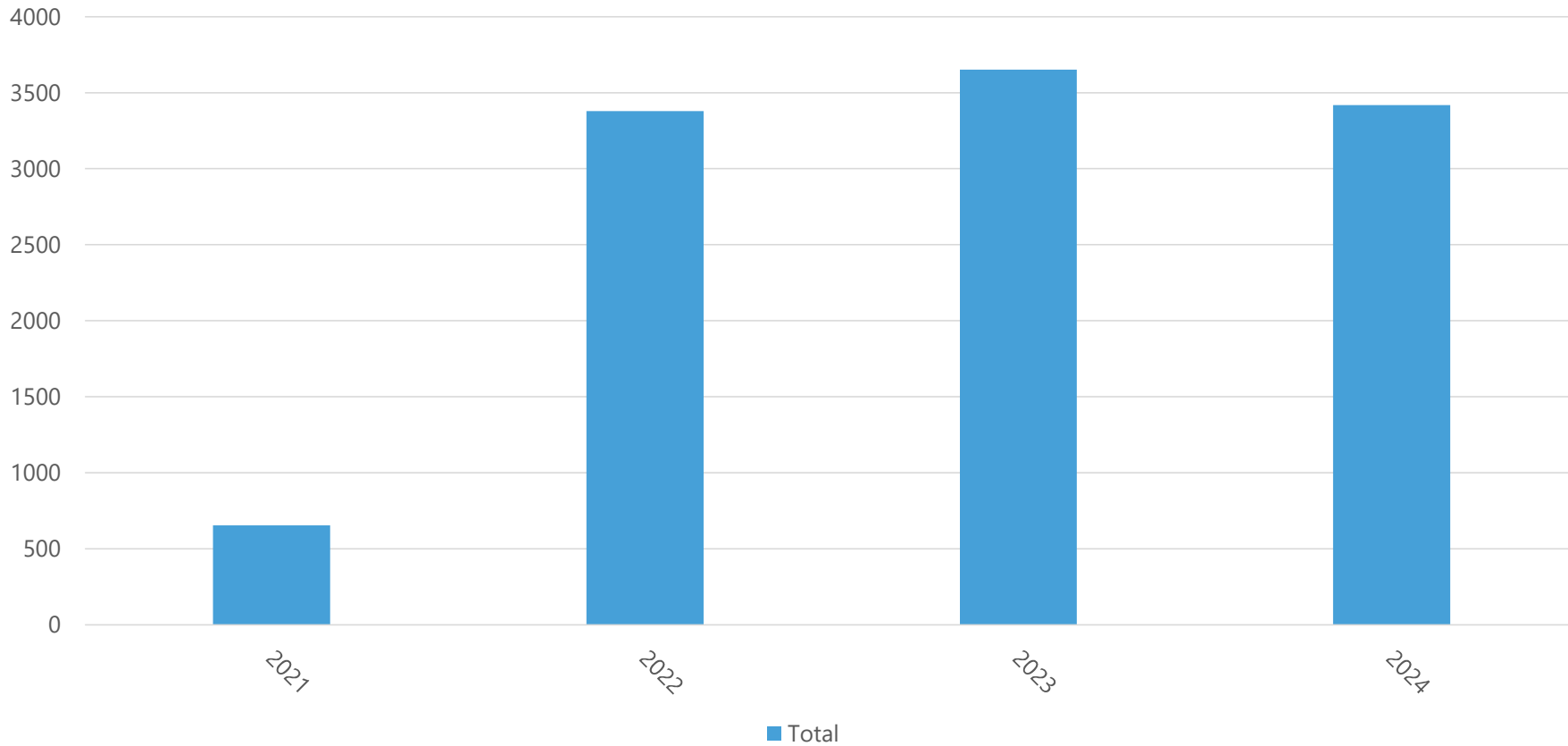

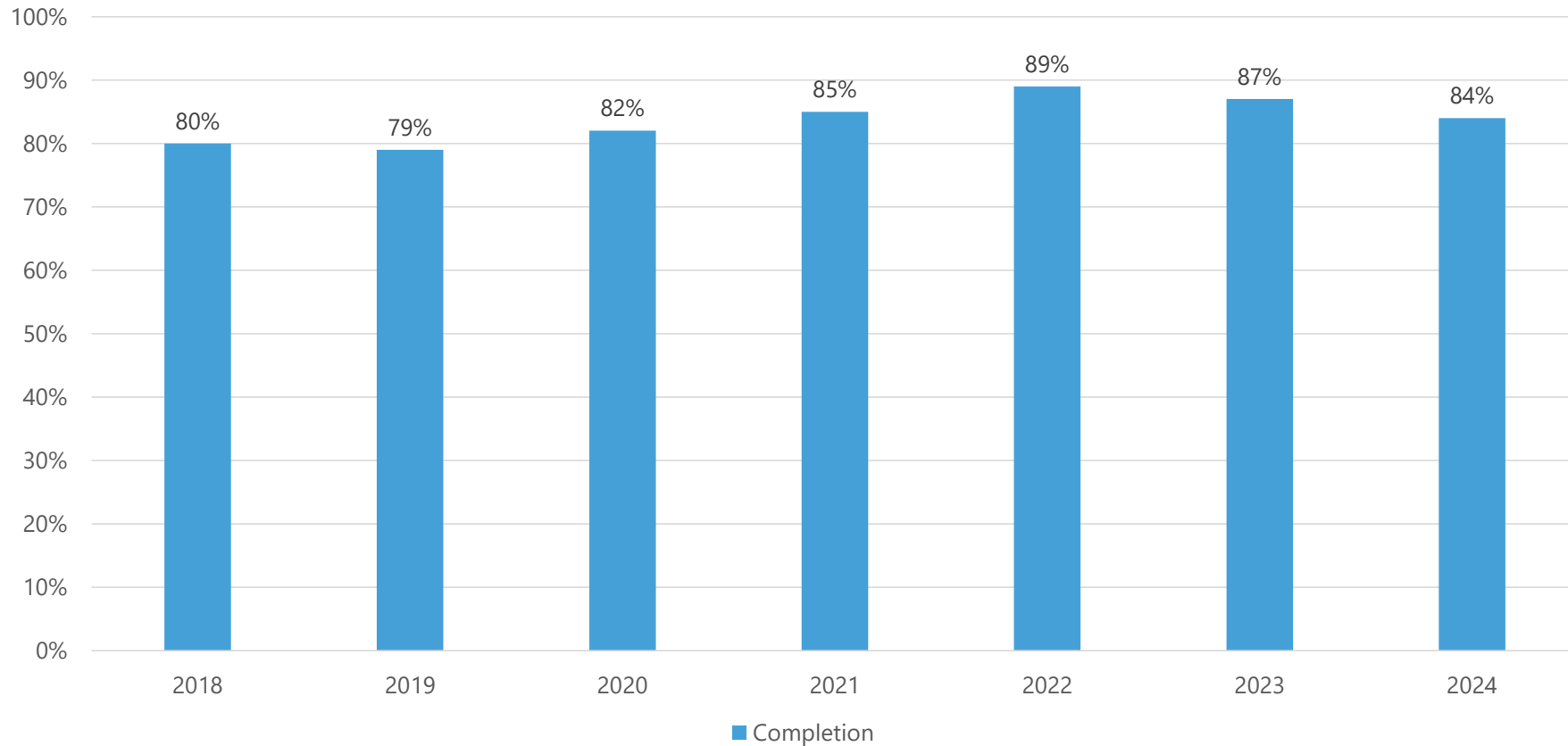
