

Crossover Youth Report SFY2005 - SFY2018


This report examines data for three milestones of service for youth entering the Department of Corrections Juvenile Services Programs.

Data from Prevention and Protection Services of the Department for Children and Families (DCF) and the Kansas Department of Corrections (KDOC) Juvenile Services was utilized to complete an analysis of youth 10 and over who have been in custody of the Secretary of DCF and out of home placement and who are then at some point served through Juvenile Services. Data for State fiscal years 2005 through 2018 was collected by both agencies and are incorporated in this report.

The full report includes Parts I, II, and III, which include detailed data for youth who have exited DCF custody and were subsequently served in KDOC Juvenile Services Juvenile Intake and Assessment (JIAS), Juvenile Intensive Supervision Probation (JISP), and Juvenile Correctional Facility (JCF) programs.

Executive Summary


Of all youth age 10 and older ending custody to the Secretary of DCF between SFY2005 through SFY2018 (n = 23,416); 16% (n = 3,745) were placed in the custody of the Deputy Secretary of Juvenile Services subsequent to ending custody to the Secretary of DCF.



Strong Families Make a Strong Kansas

Part I: Cross Over to Custody of the Kansas Department of Corrections Juvenile Service Division.

Of all youth age 10 and older who exited custody to the Secretary of DCF between SFY2005-SFY2018 (n=23,416), 1,675 (7%) have been placed in the custody of the Kansas Department of Corrections (KDOC) Juvenile Services Division at some point subsequent to ending DCF custody.

longitudinal reporting, the number of youth entering JIAS custody (after DCF release) will most likely increase over the years. For those youth exiting custody of the Secretary in SFY2018, 0.5% (n = 10) have entered JIAS custody since DCF release.

Across all years SFY2005-2018, 52% (n = 865) of youth who cross over from custody of the Secretary of DCF to JIAS are age 15 and older.

27% (n = 447) of all crossover custody youth are female.

73% (n = 1228) of all crossover custody youth are male.



Across all years SFY2005-2018, the greatest percentage of youth who enter JIAS Custody had their Child In Need of Care (CINC) case open in the DCF West Region 35% (n = 583).

Kansas City (n =319) and Wichita (n = 329) Regions have the lowest proportion of youth who enter JIAS custody subsequent to DCF custody at 19% and 20% respectively.


Of those ending custody to the Secretary in SFY2018 and entered JIAS Custody, the average length of time between the two programs is 1.2 months.

Across all year SFY2005 - SFY2018, for the 1,675 youth placed in the custody of JIAS, the average length of time between ending custody with the Secretary and starting custody with JIAS is 18.1 months.



Across all years SFY2005 - SFY2018, 'Person-Other Crimes' continues to be the highest juvenile offense adjudication at 43% (n = 725) and 82% of all offenses committed by youth occurred within the same CINC release county (n = 1,374).


Cross Jurisdictional Youth by Custody Adjudication Type



Part II: Cross Over to Juvenile Intensive Supervision Probation (JISP) case.

Of all youth age 10 and older who exited custody to the Secretary of DCF between SFY2005-SFY2018 (n = 23,416), 1,229 (5.0%) have been served in a JISP case at some point subsequent to ending DCF custody.

Due to the nature of grouping data by year for longitudinal reporting, the number of youth served in JISP programs will most likely increase over the years. For those ending custody to the Secretary during SFY2018, 1.2% (n = 22) entered JISP programs after DCF release.

Across all years SFY2005 - SFY2018, 46.4% (n = 570) of youth who cross over from custody of the Secretary of DCF to the JISP program are age 15 and older.


32% (n = 389) of all youth entering JISP programs subsequent to the custody of the Secretary are female; while 68% (n = 840) are male.

Of those youth ending DCF custody in SFY2018 and have entered JISP programs, the average length of time between the two custody programs is 2.8 months.


Across all years SFY2005 - SFY2018, for all 1,229 youth ending DCF custody prior to entering JISP programs, the average length of time between the two custody programs is 23.2 months.





Across all years SFY2005-SFY2018, 'Person-Other Crimes' continues to be the highest juvenile offense adjudication at 38% (n = 468) and 80% (n = 886) of all offenses committed by youth occurred within the same CINC release county.



Part III: Cross Over to Juvenile Correctional Facility (JCF) Placement

Of all youth age 10 and older who exited custody to the Secretary of DCF between SFY2005 - SFY2018 (n = 23,416), 841 (4.0%) have entered a JCF placement at some point subsequent to ending DCF custody.

Across all years SFY2005 - SFY2018, 57.1% (n = 480) of the youth who cross over from custody of the Secretary of DCF to a JCF adjudication are age 15 and older.


83% (n = 699) of youth who enter a JCF placement are male; while 17% (n = 137) are female.

Of those who ended DCF custody in SFY2018 and were committed to a JCF, the average length of time between the two agency's programs was 2.17 months.


Across all years SFY2005 - SFY2018, for all 841 youth ending DCF custody and were committed to a JCF, the average length of time between the two agency's programs is 24.1 months.



Across all years SFY2005 - SFY2018, 'Person-Other Crimes' continues to be the highest juvenile offense adjudication at 48% (n = 407) and 84% (n = 707) of all offenses committed by youth occurred within their same CINC release county.
