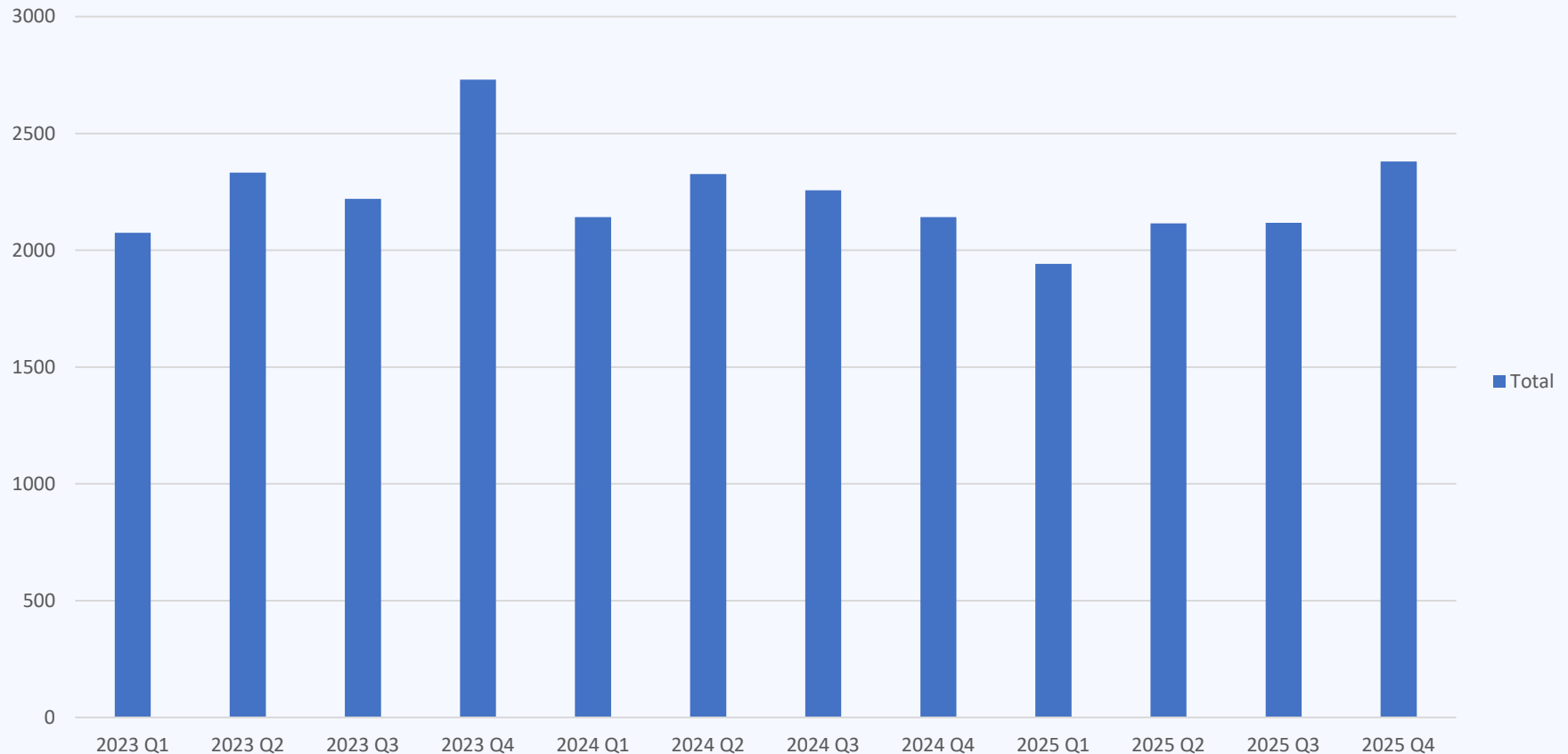

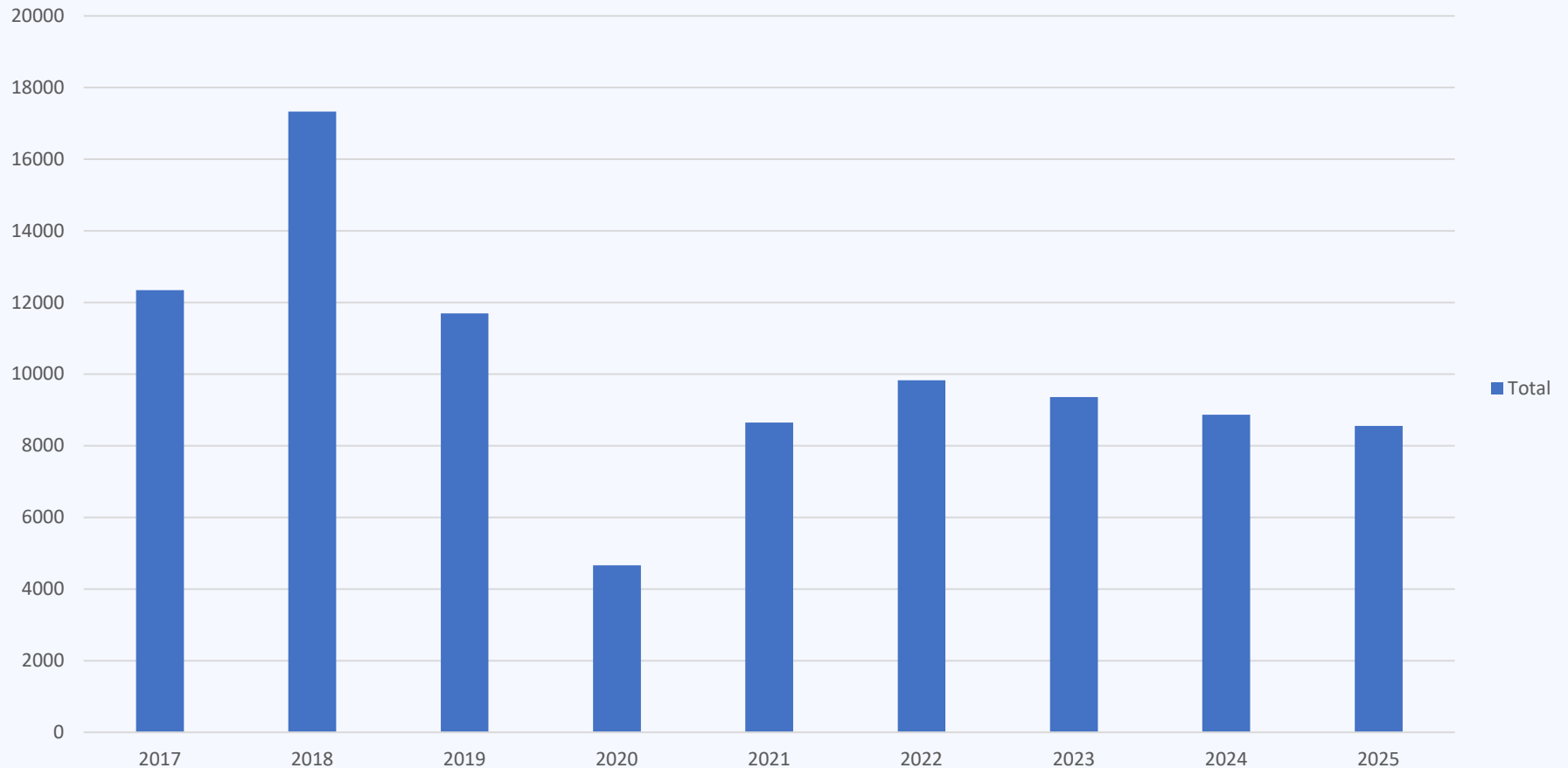


Total number of juvenile offender filings by quarters



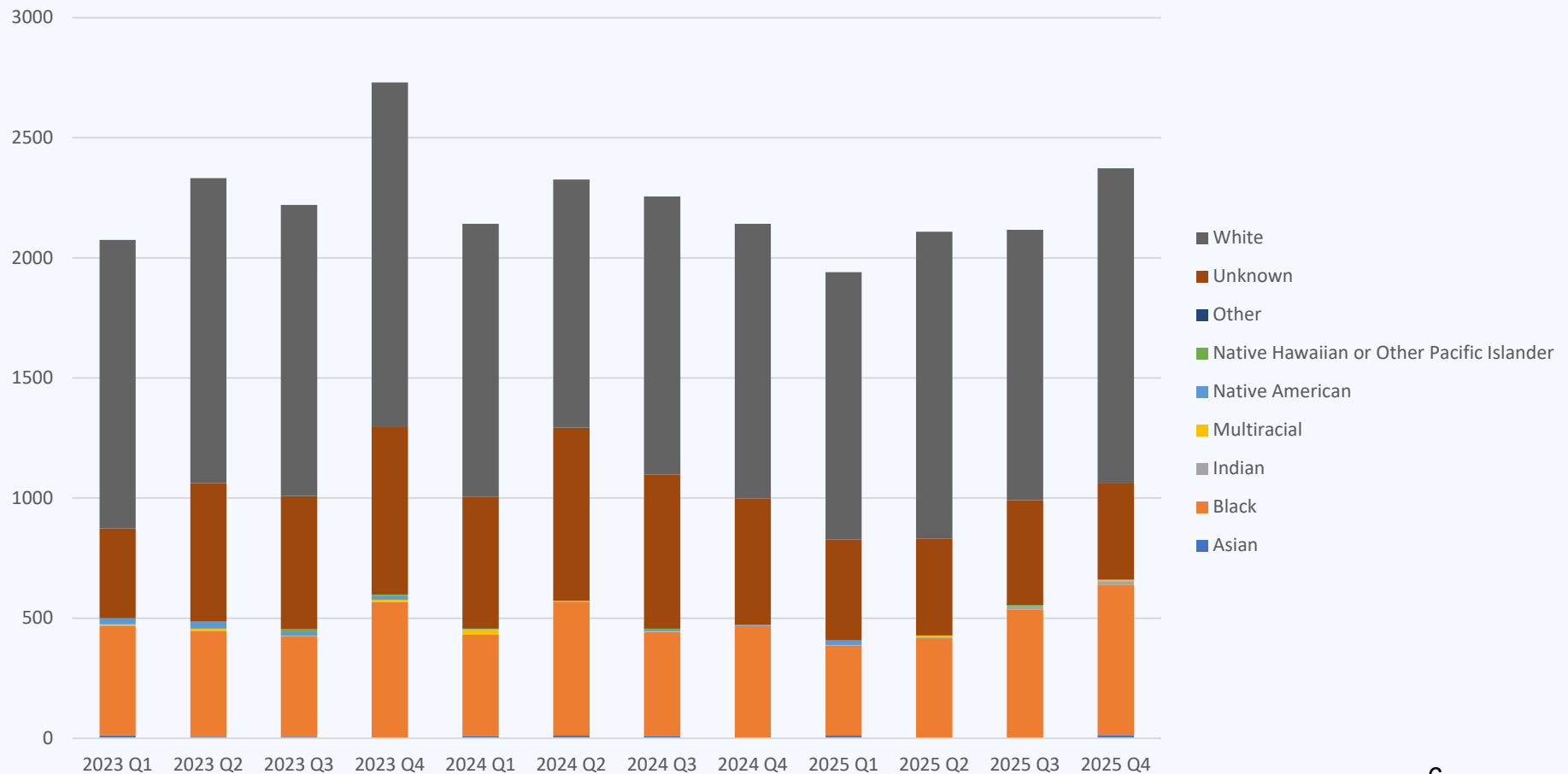


Total number of juvenile offender filings by fiscal year



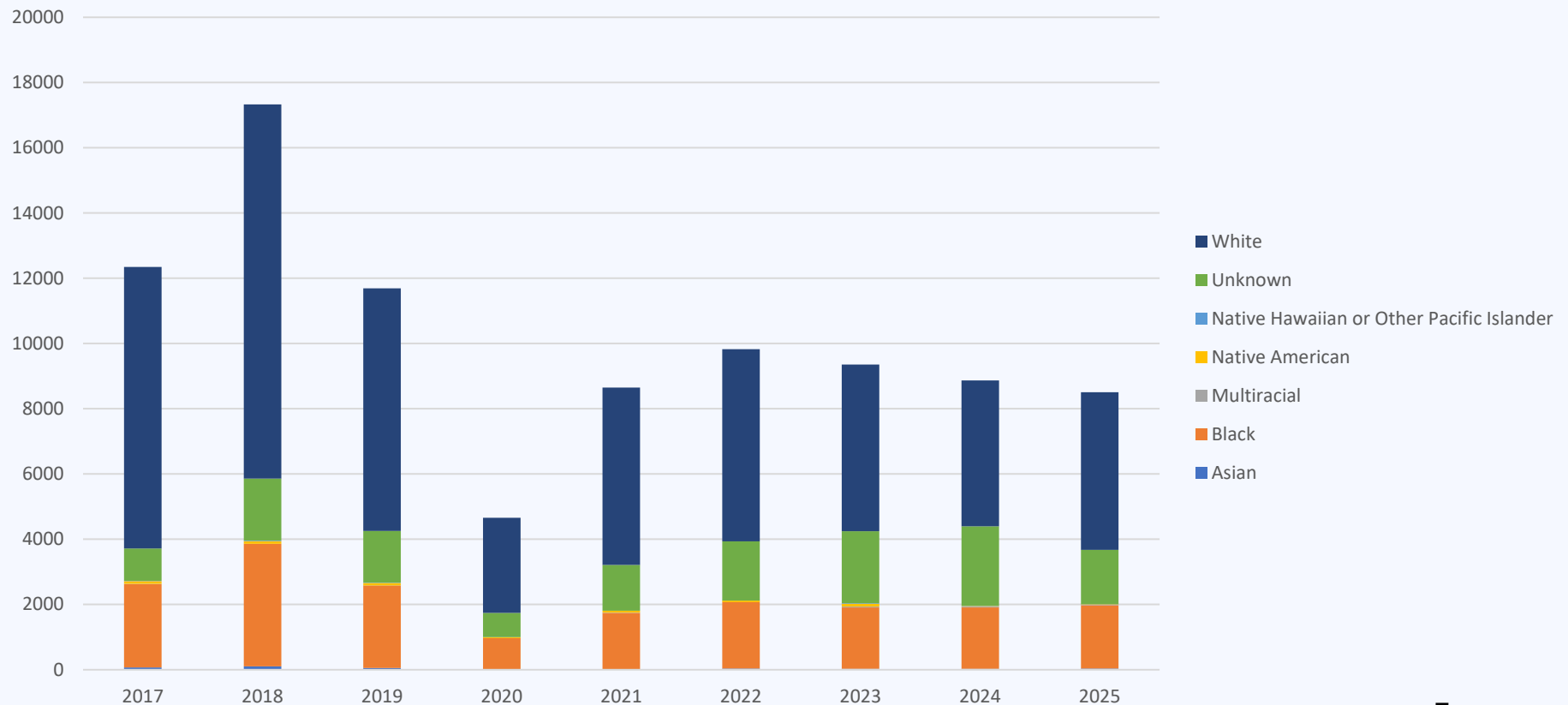


Total number of juvenile offender filings by race – quarters



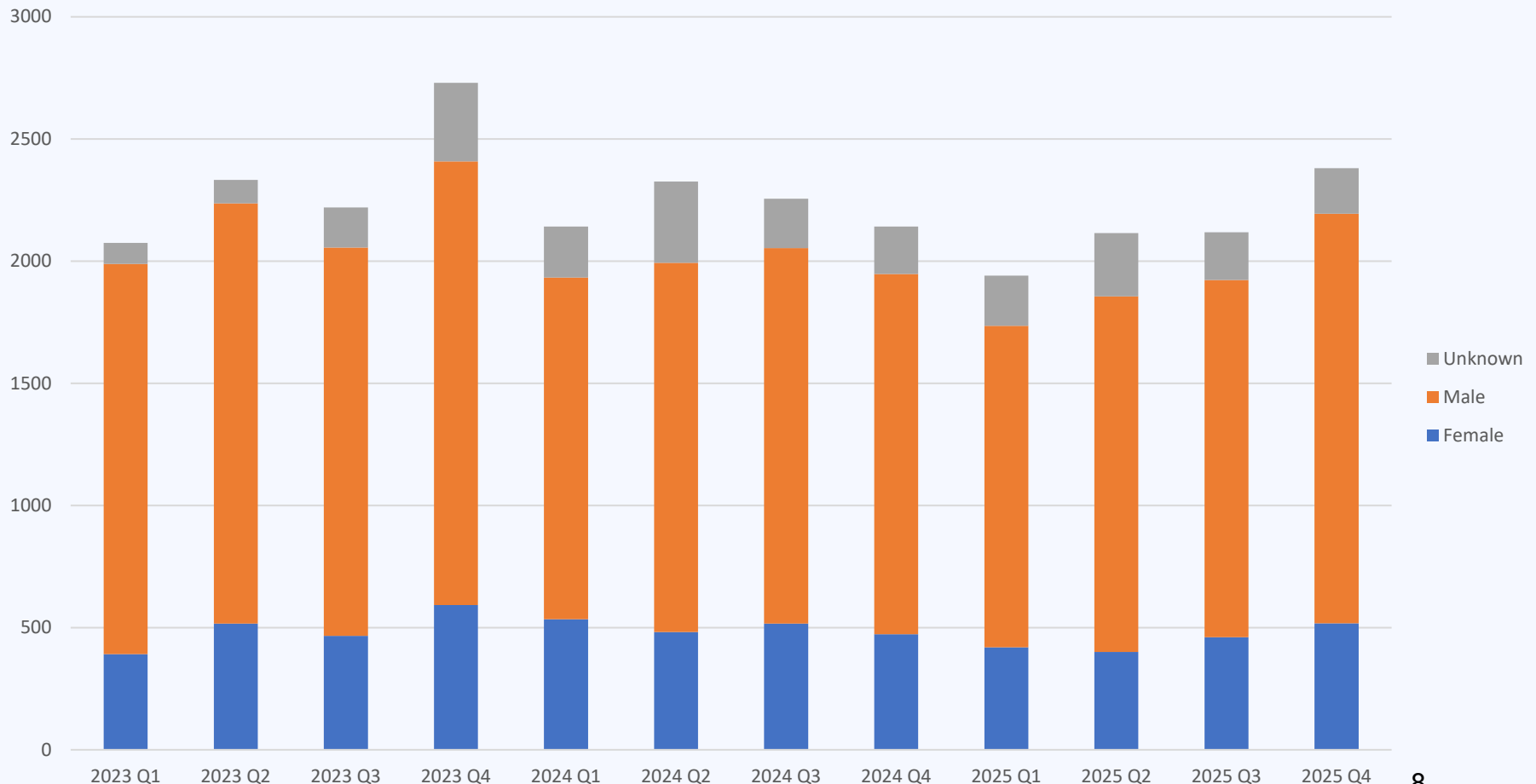


Total number of juvenile offender filings by race – fiscal years

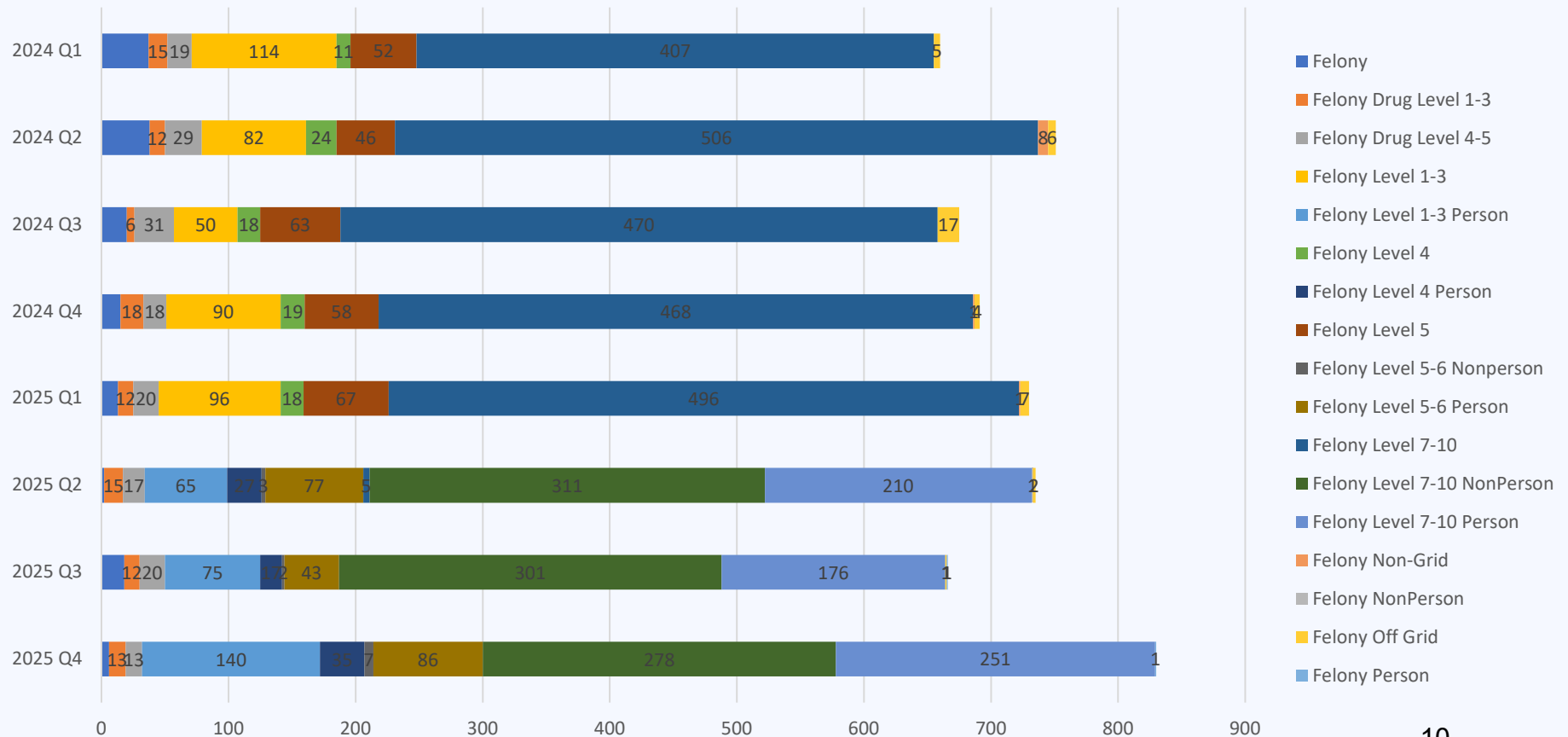

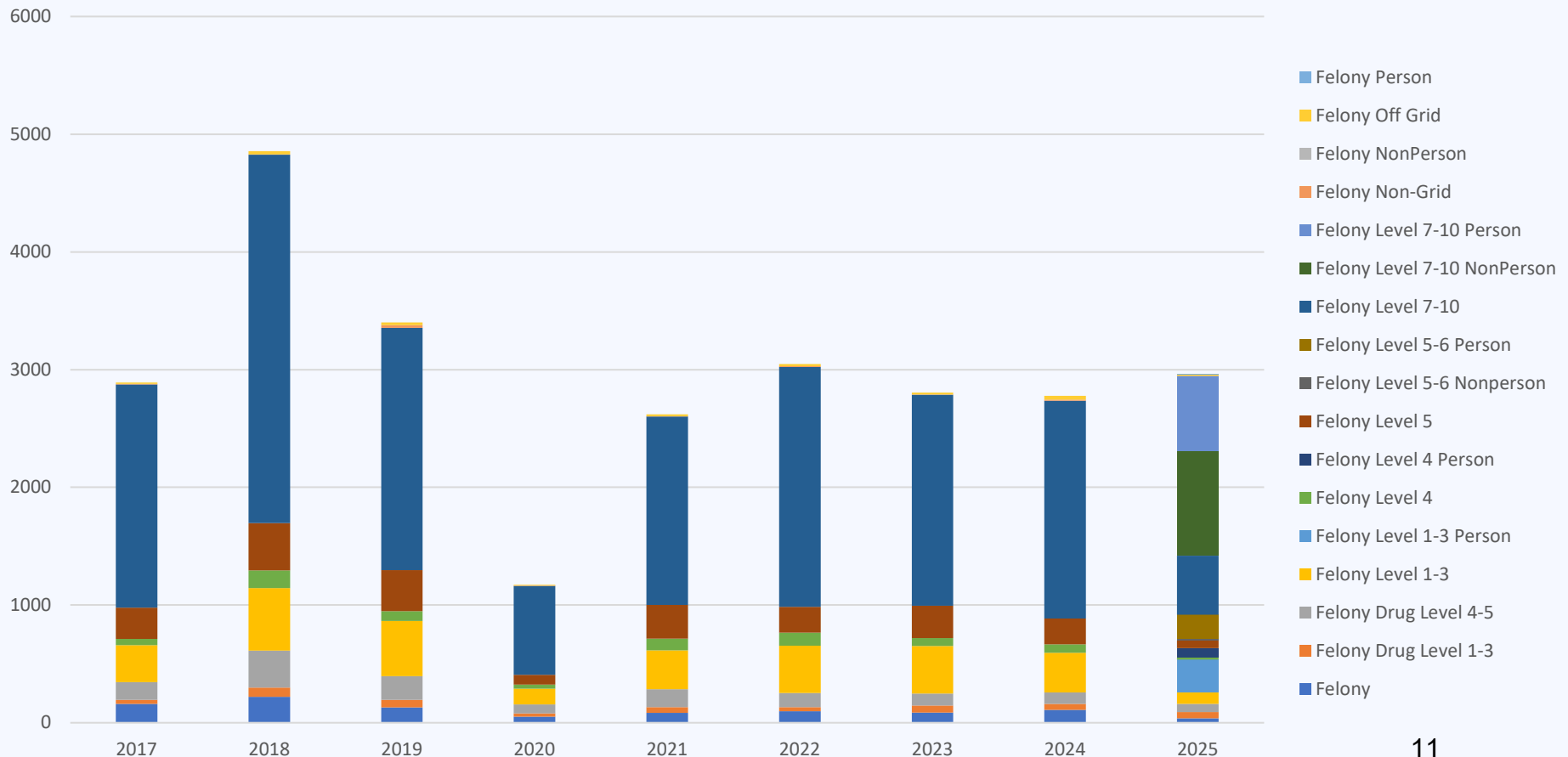


Total number of juvenile offender filings by felony offense type – quarters



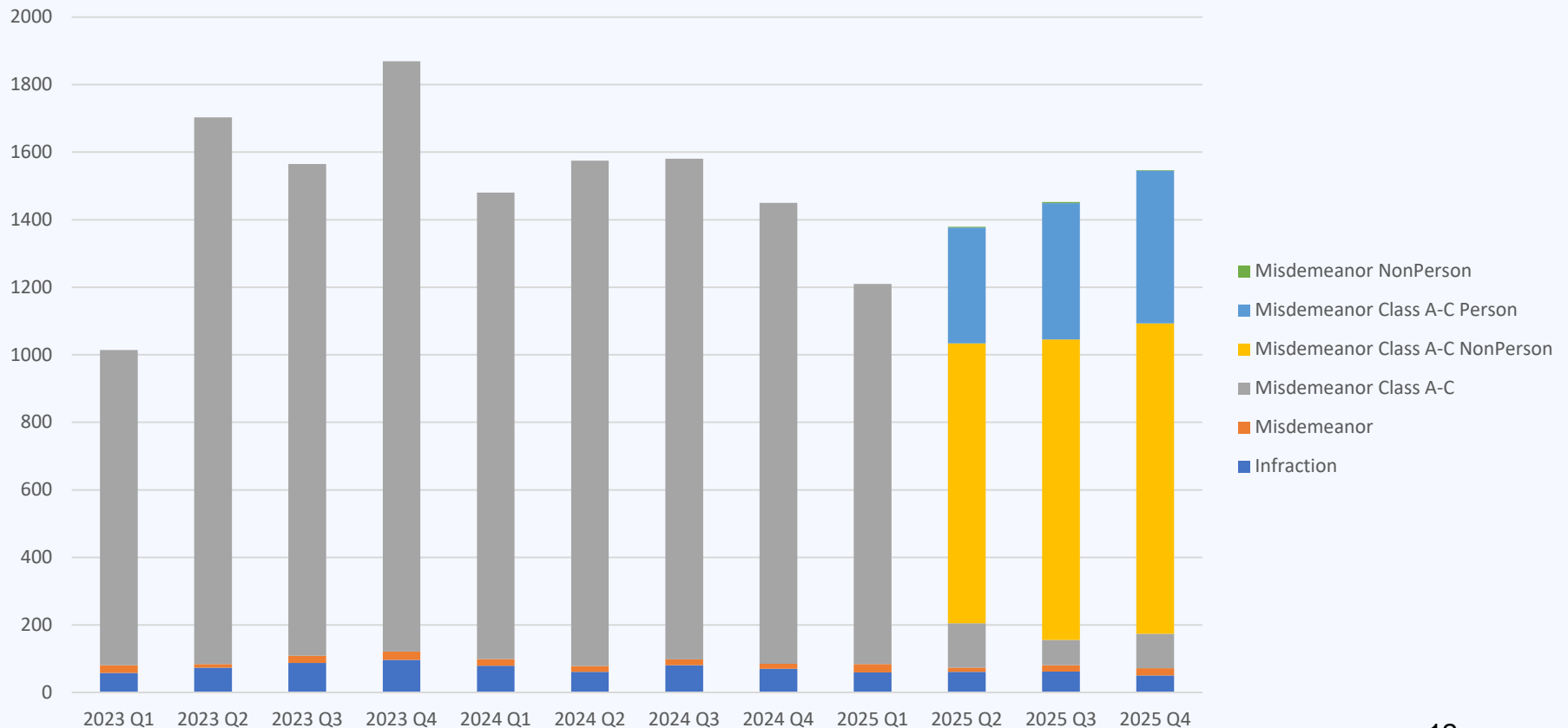


Total number of juvenile offender filings by felony offense type – fiscal years



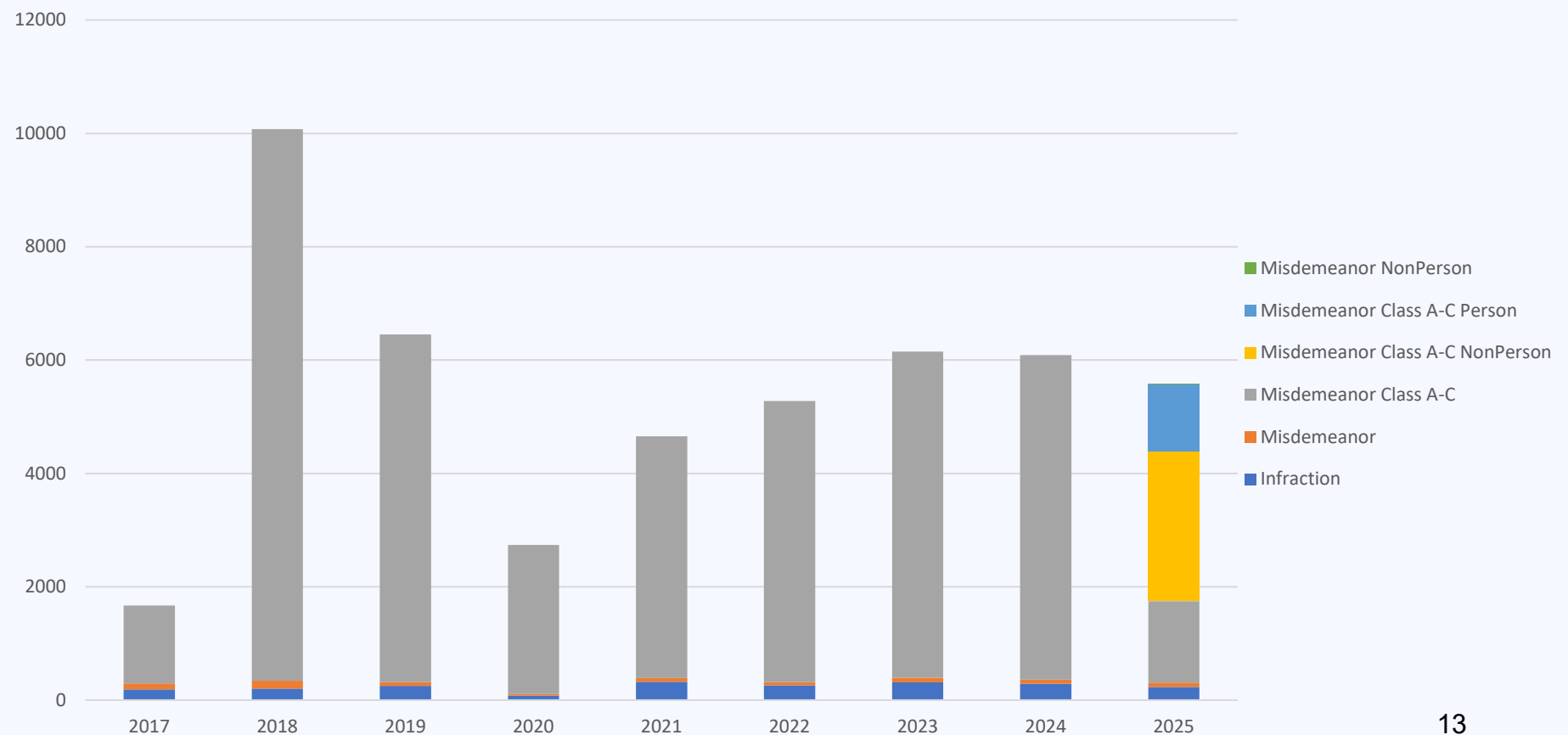


Total number of juvenile offender filings by misdemeanor offense type - quarters

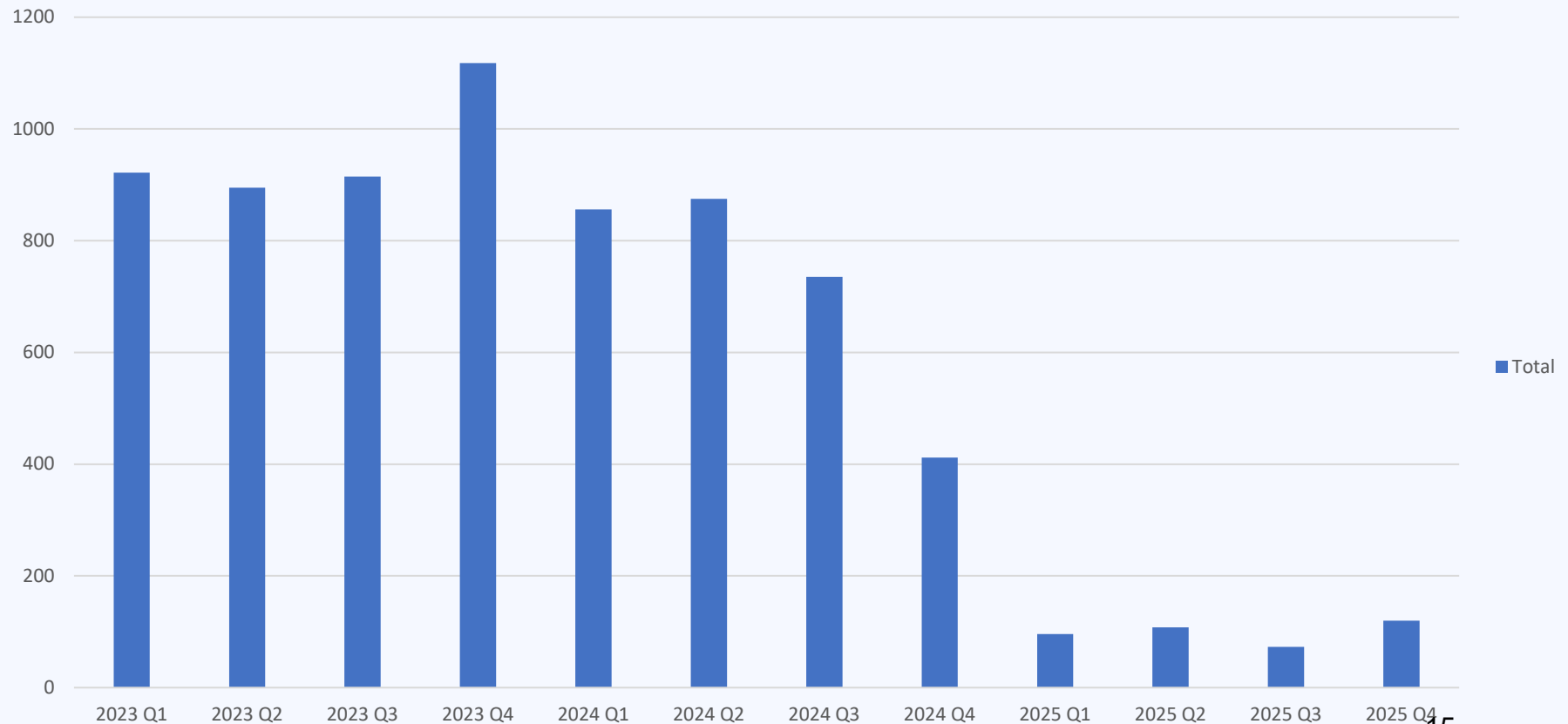

Total number of juvenile offender adjudications by quarter



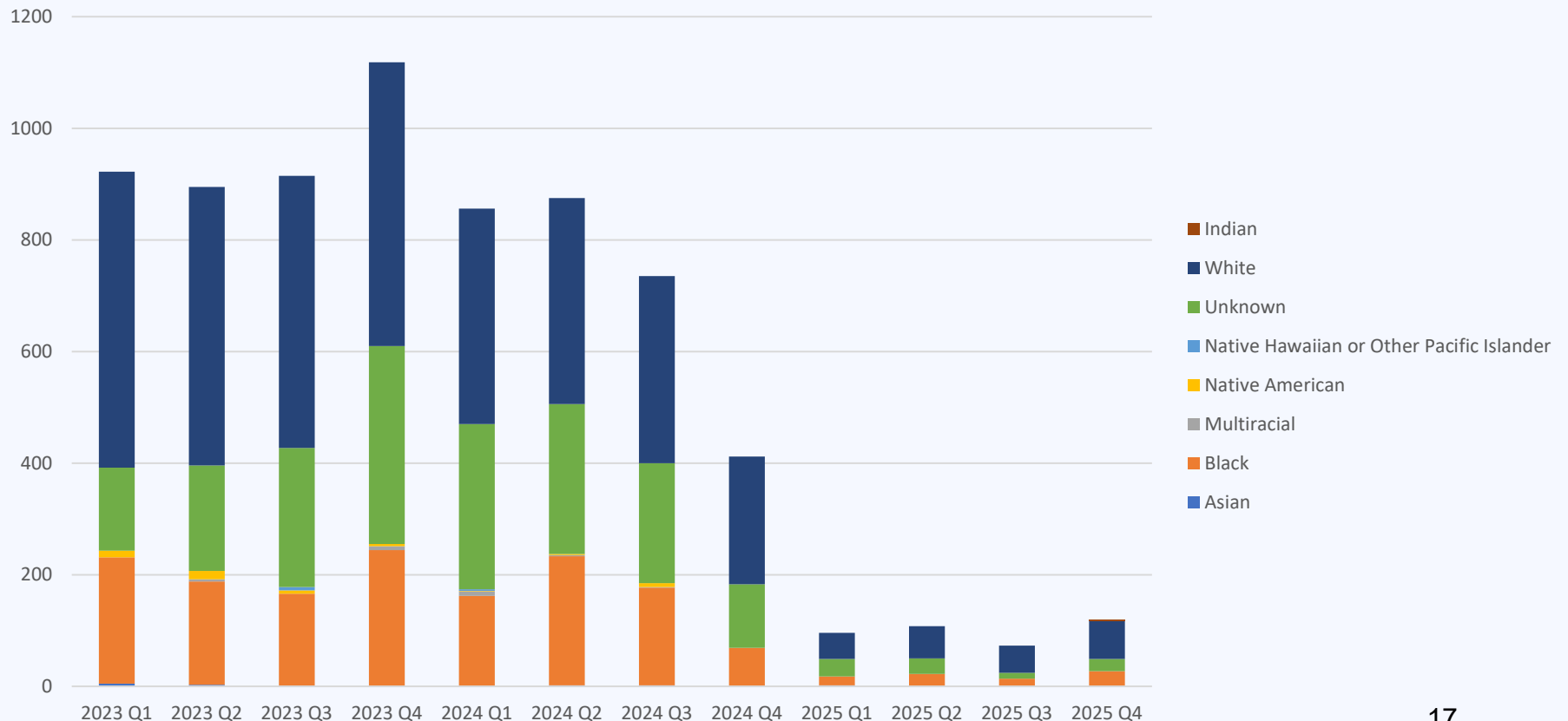


Total number of juvenile offender adjudications by fiscal year



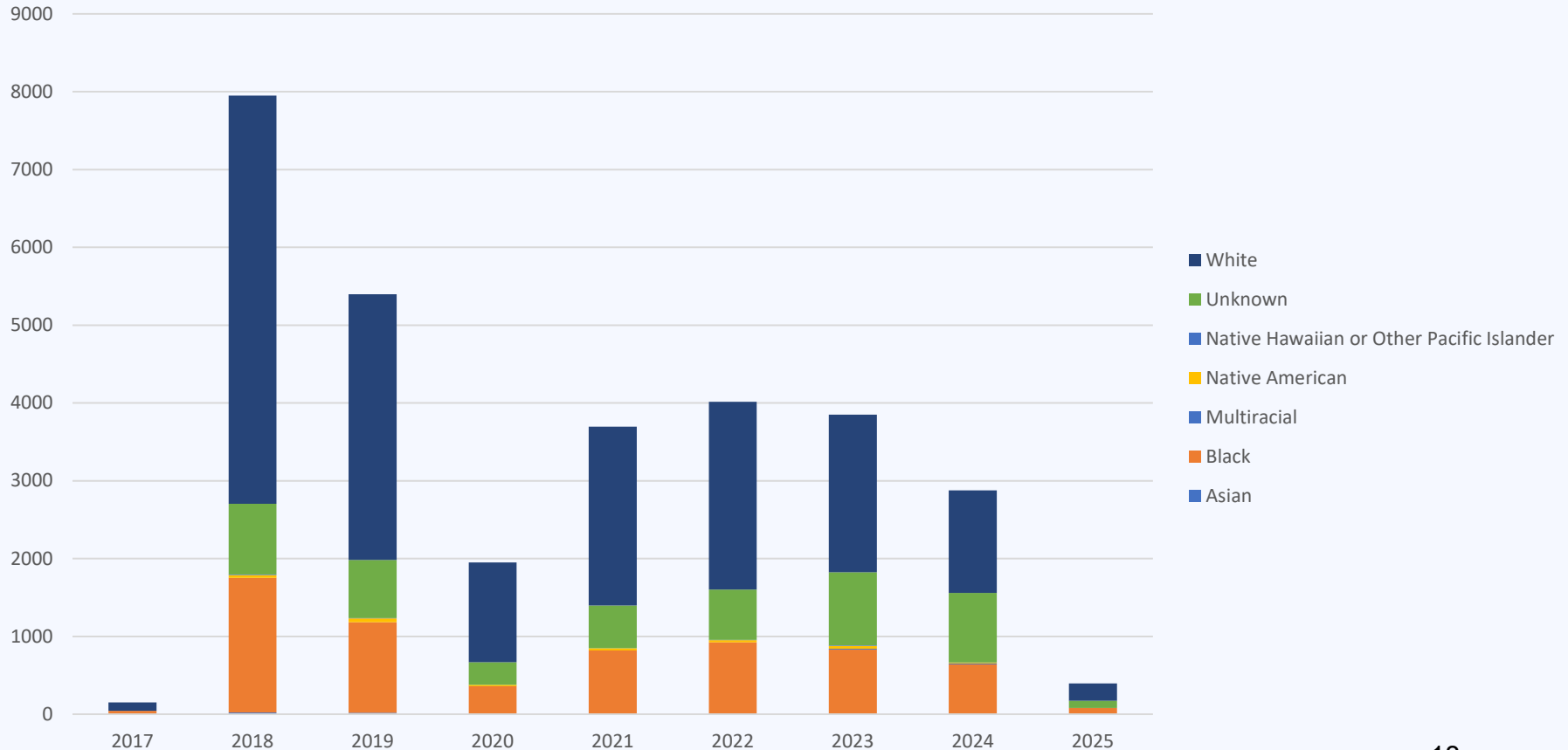


Total number of juvenile offender adjudications by race – quarters



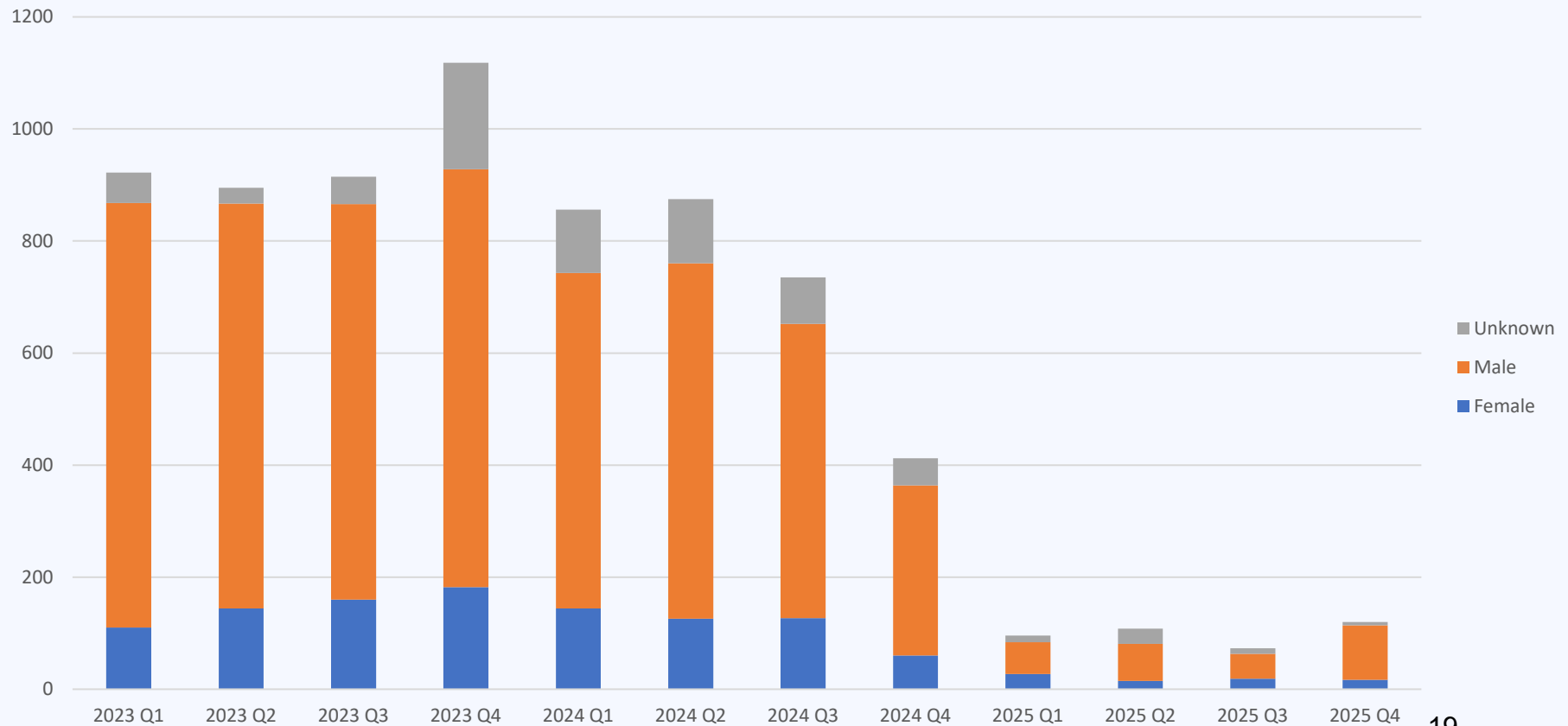


Total number of juvenile offender adjudications by race – fiscal years

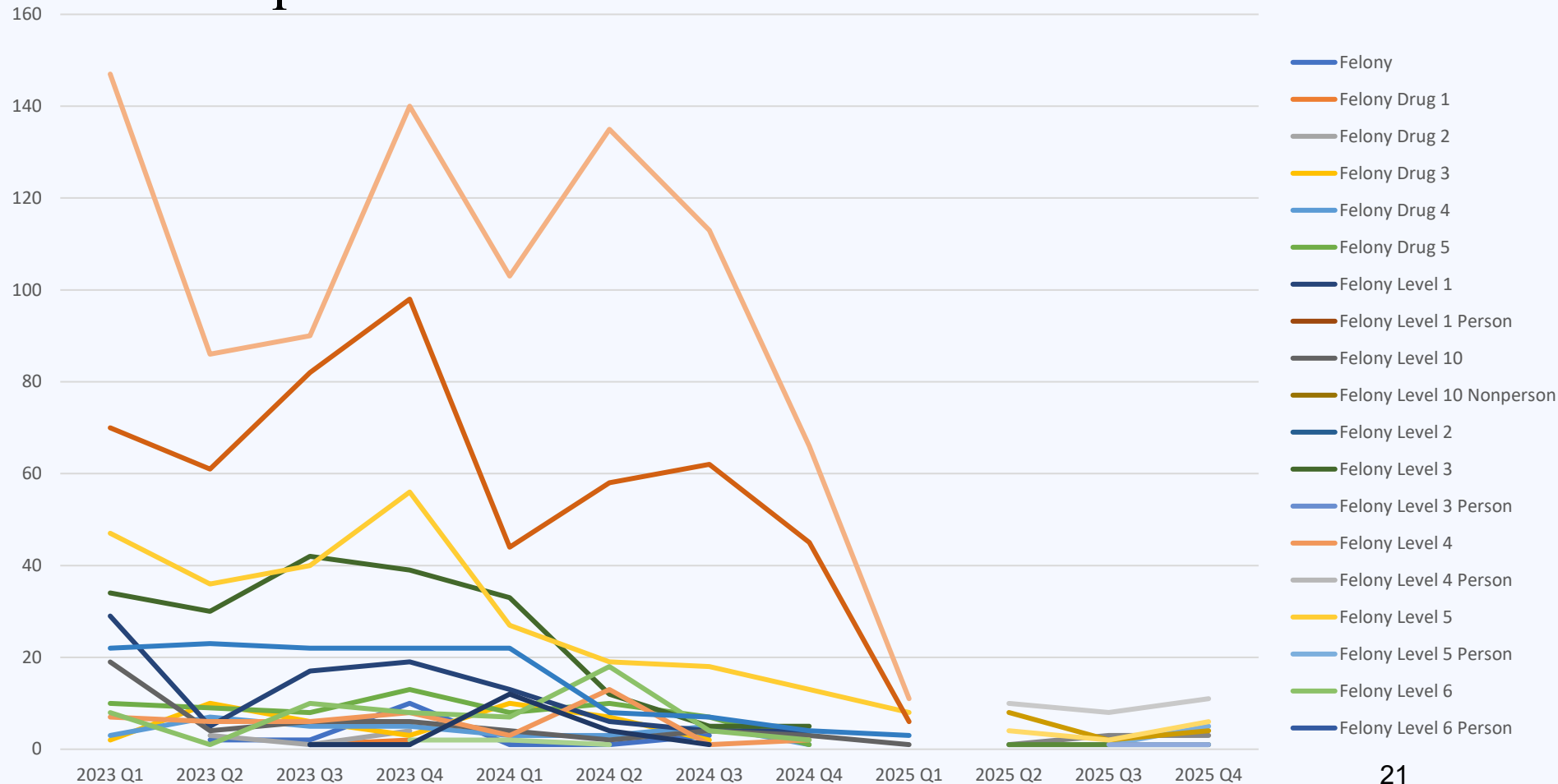

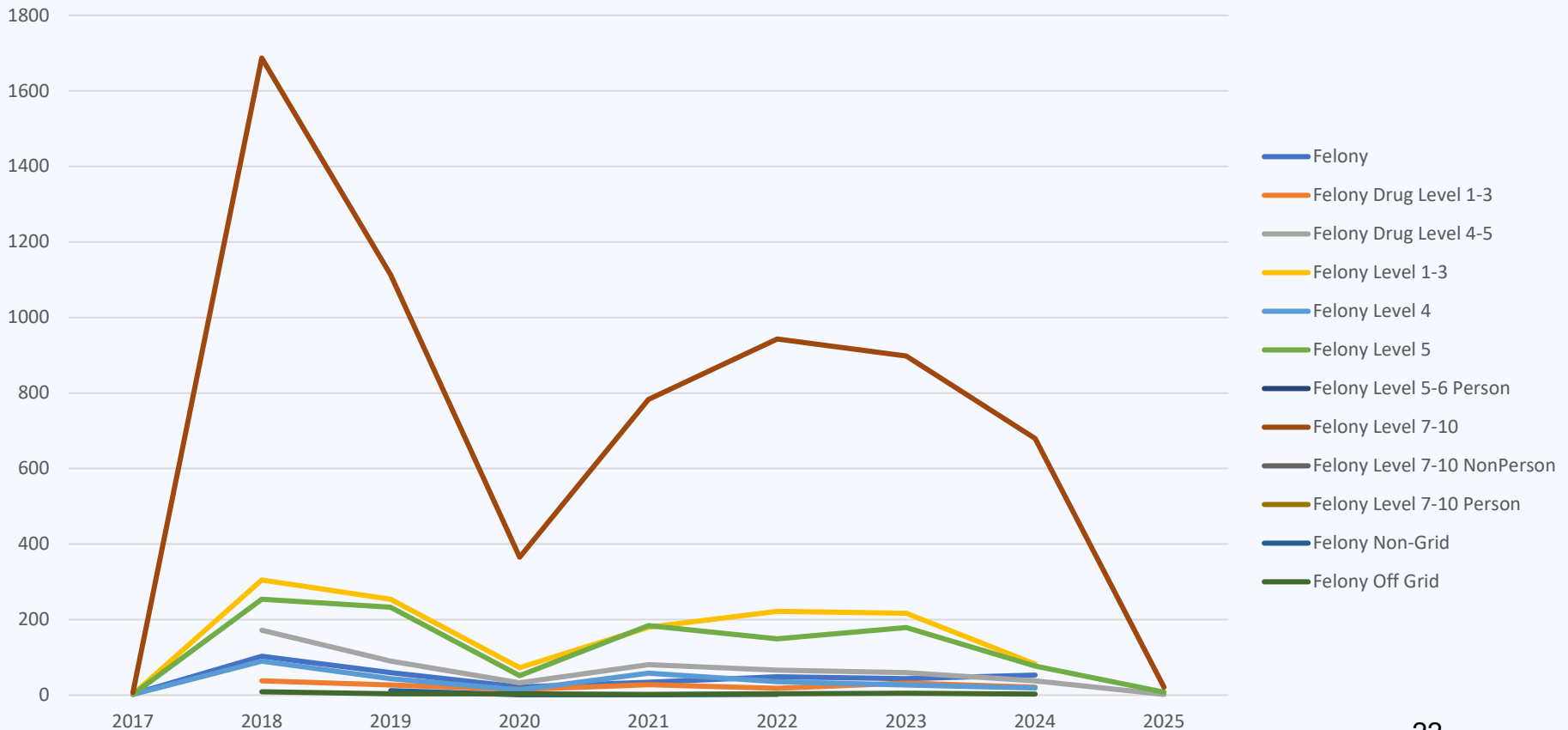


Total number of juvenile offender adjudications by felony offense - quarters



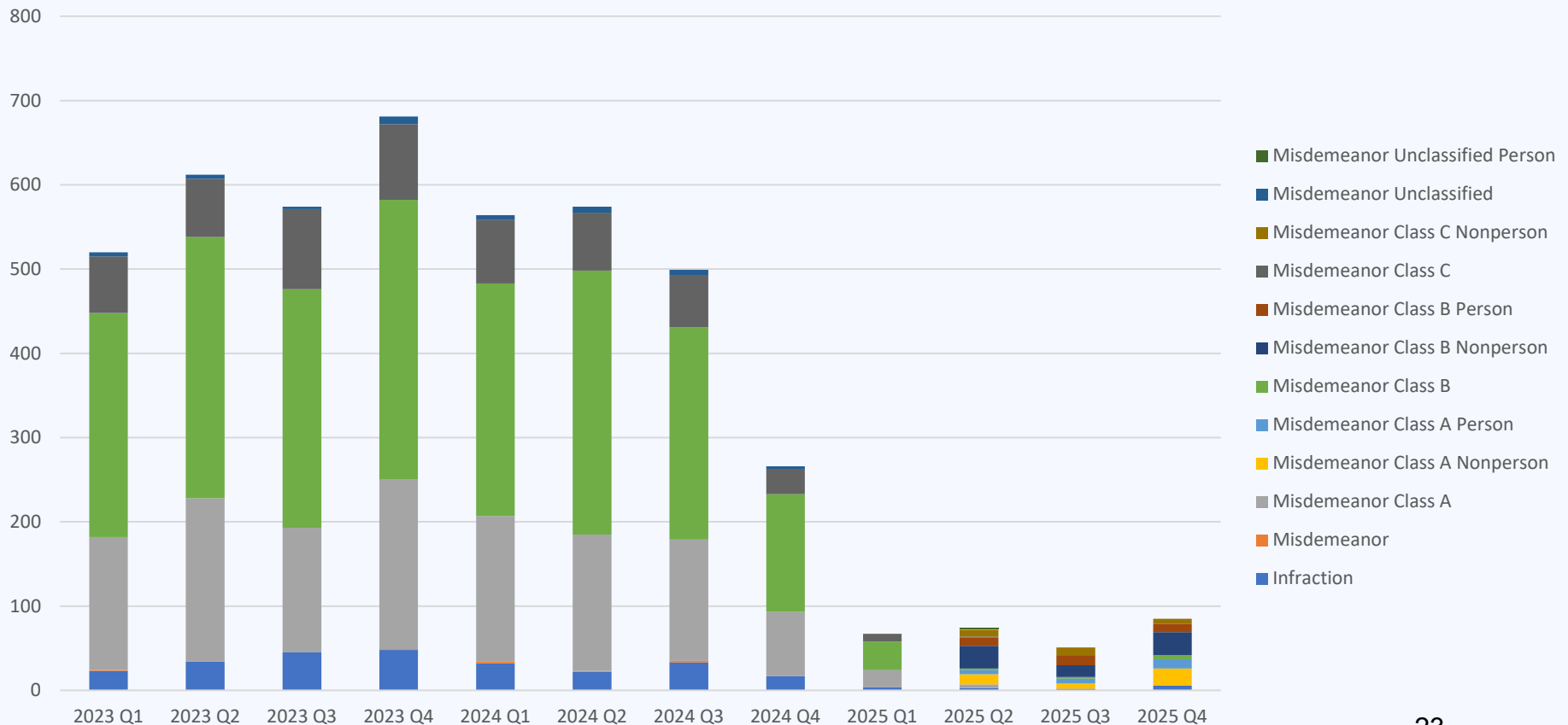


Total number of juvenile offender adjudications by felony offense – fiscal year



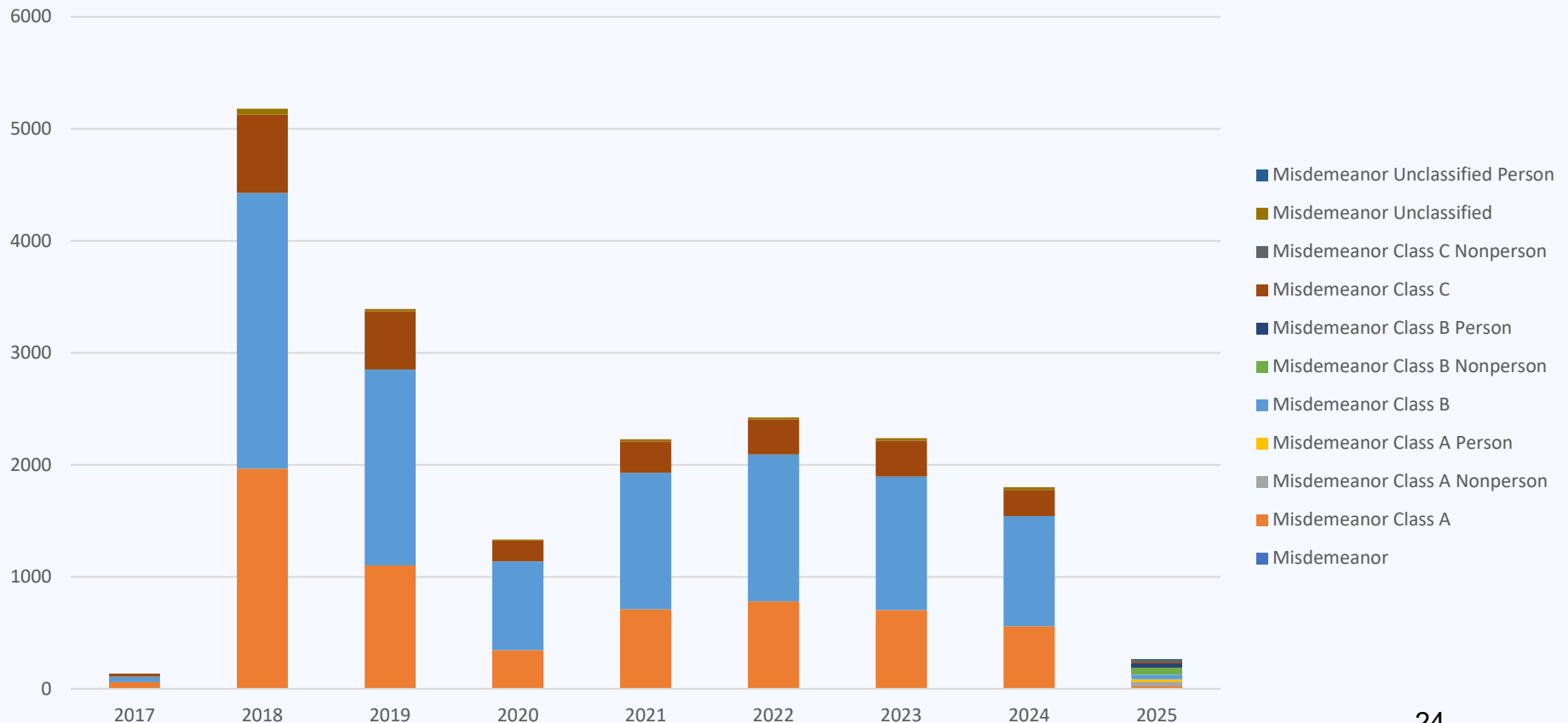


Total number of juvenile offender adjudications by misdemeanor offense - quarters

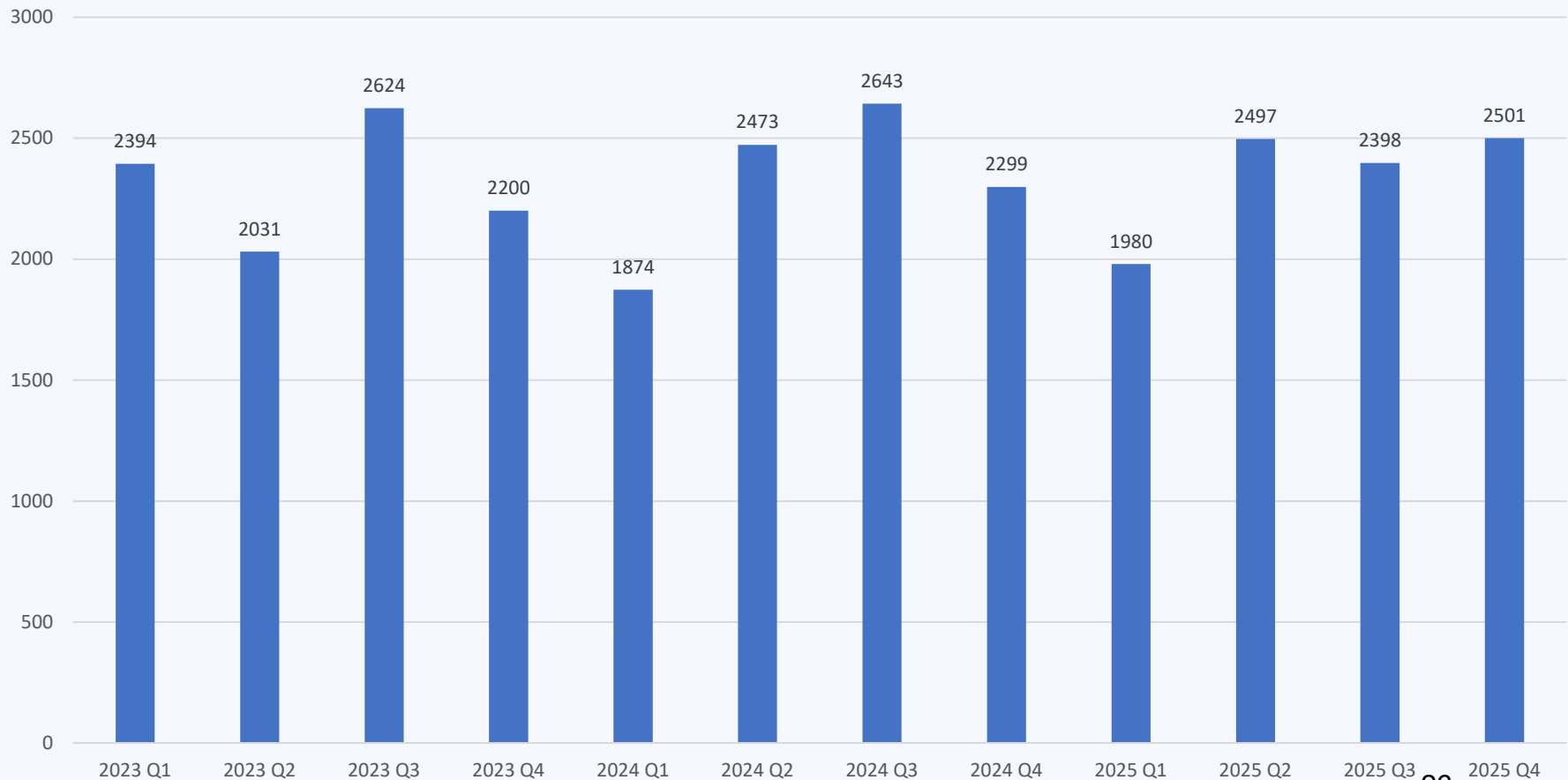

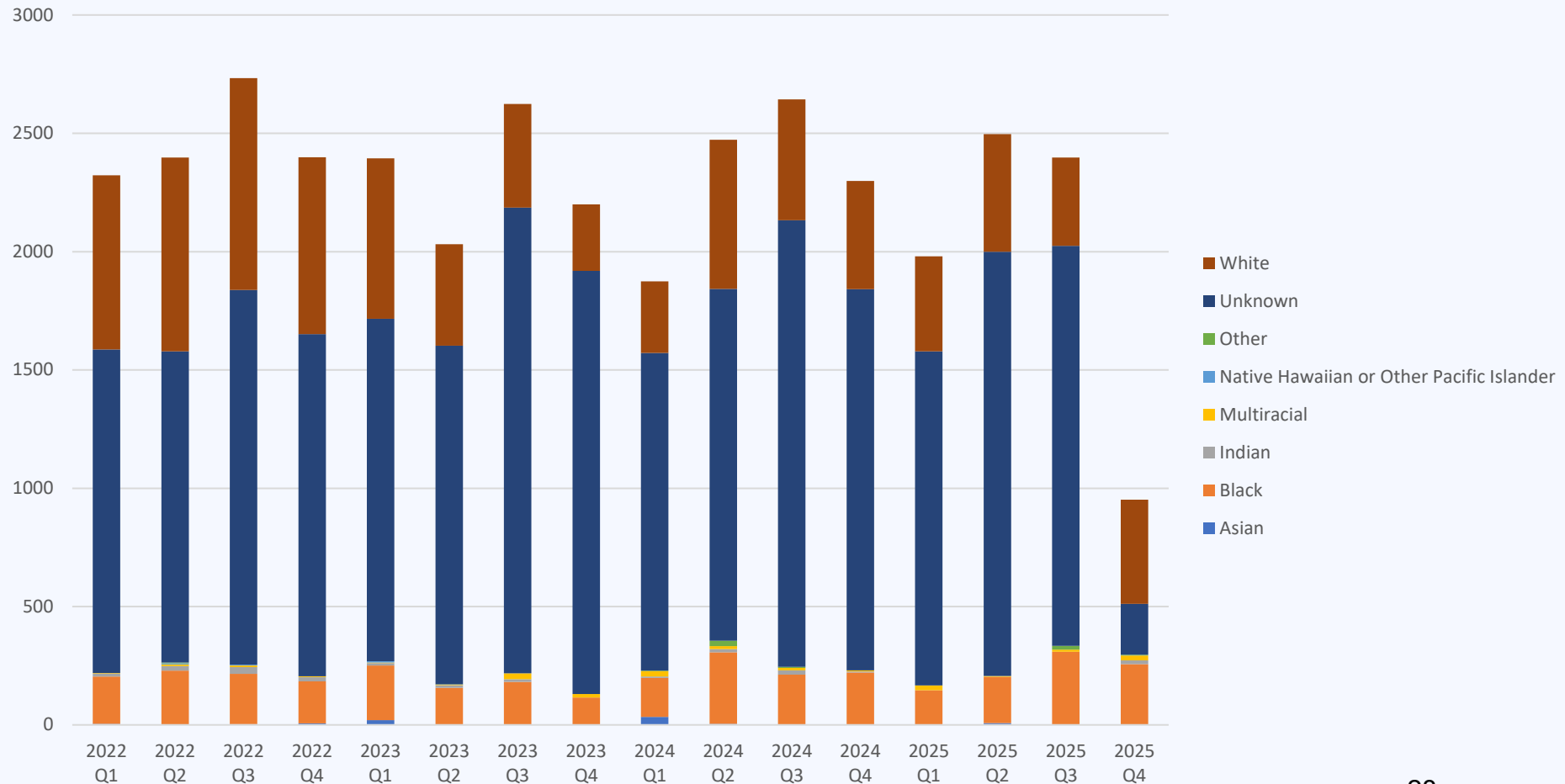


Total number of CINC filings –fiscal year



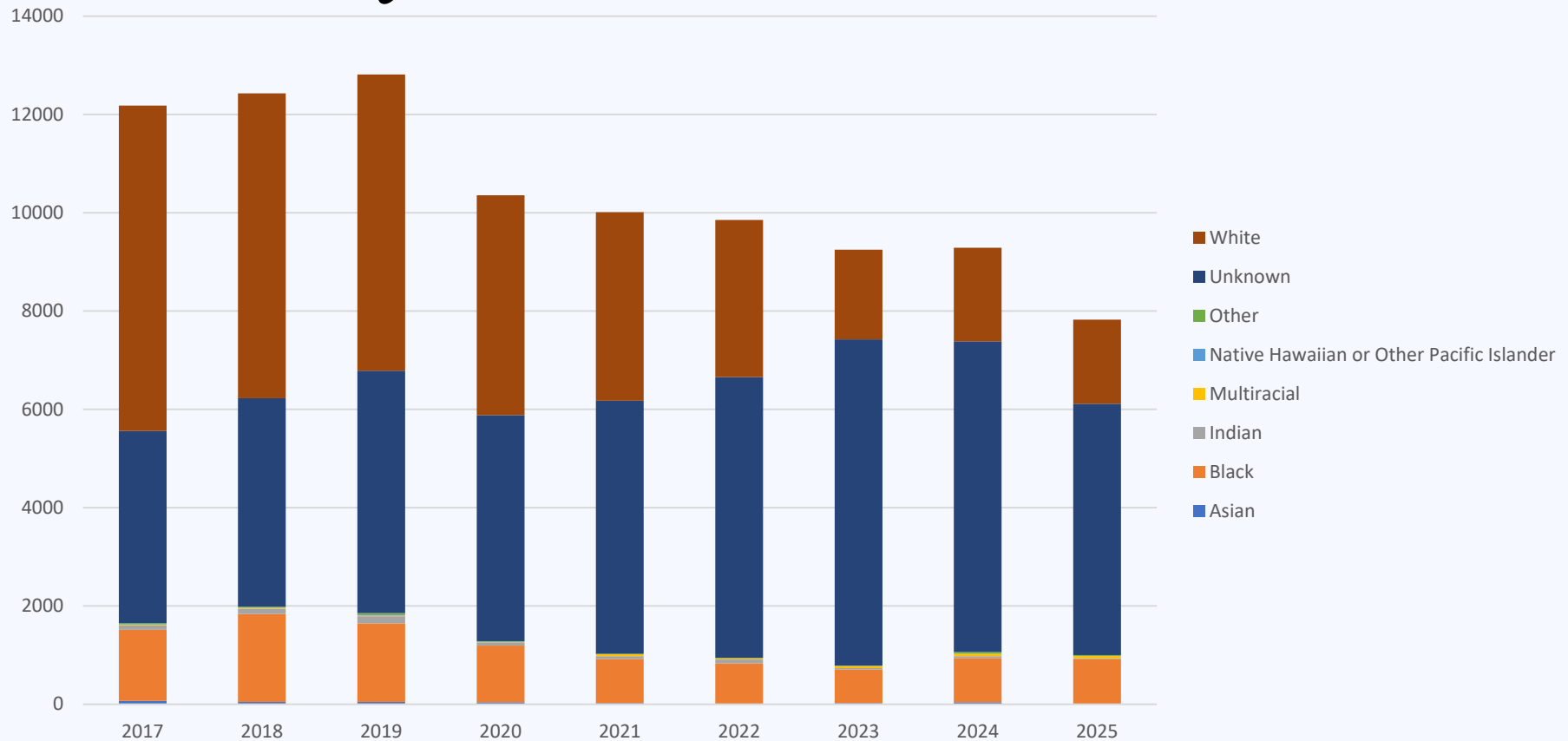


Total number of CINC filings by race - quarters



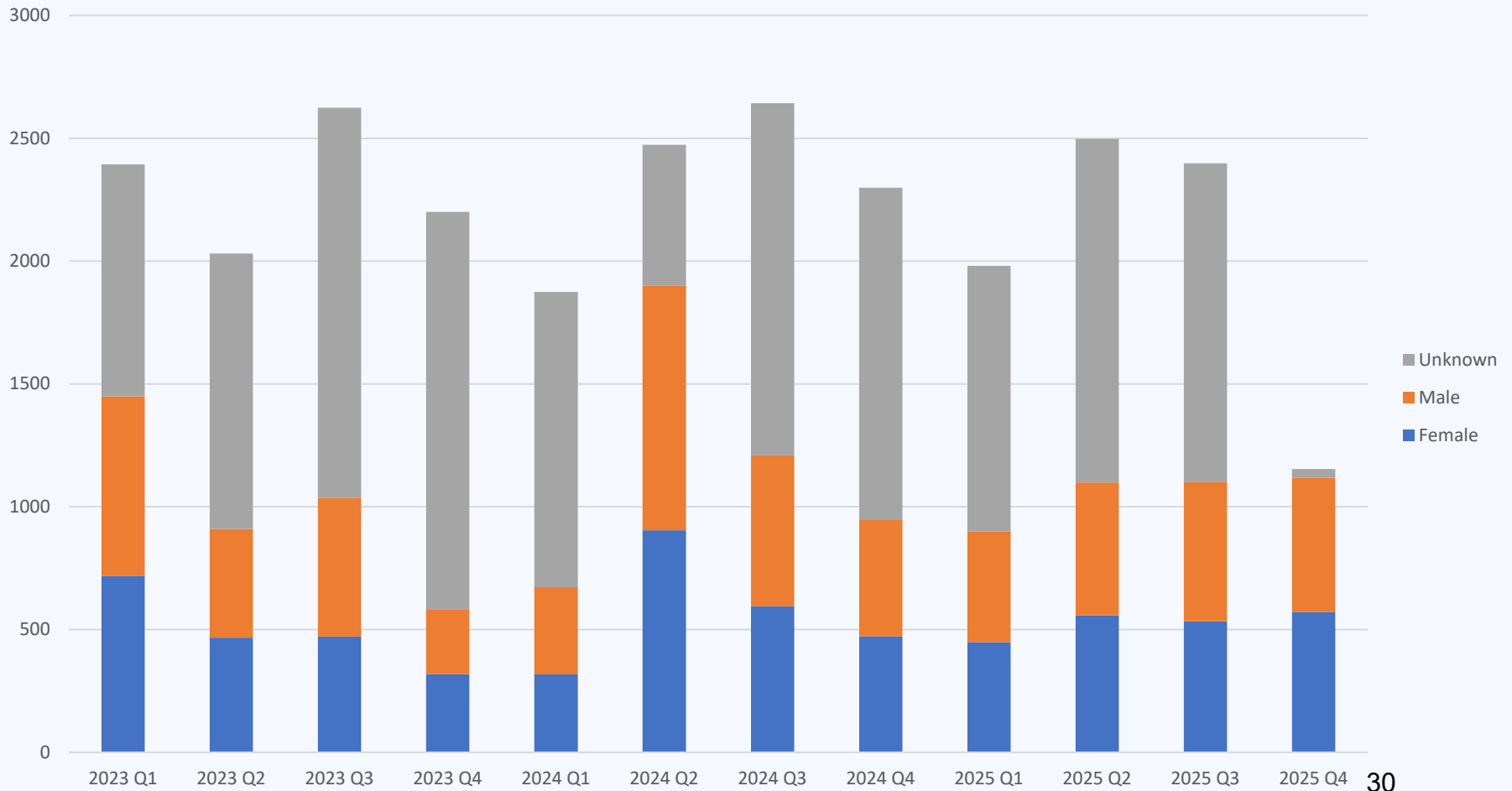


Total number of CINC filings by race – fiscal years



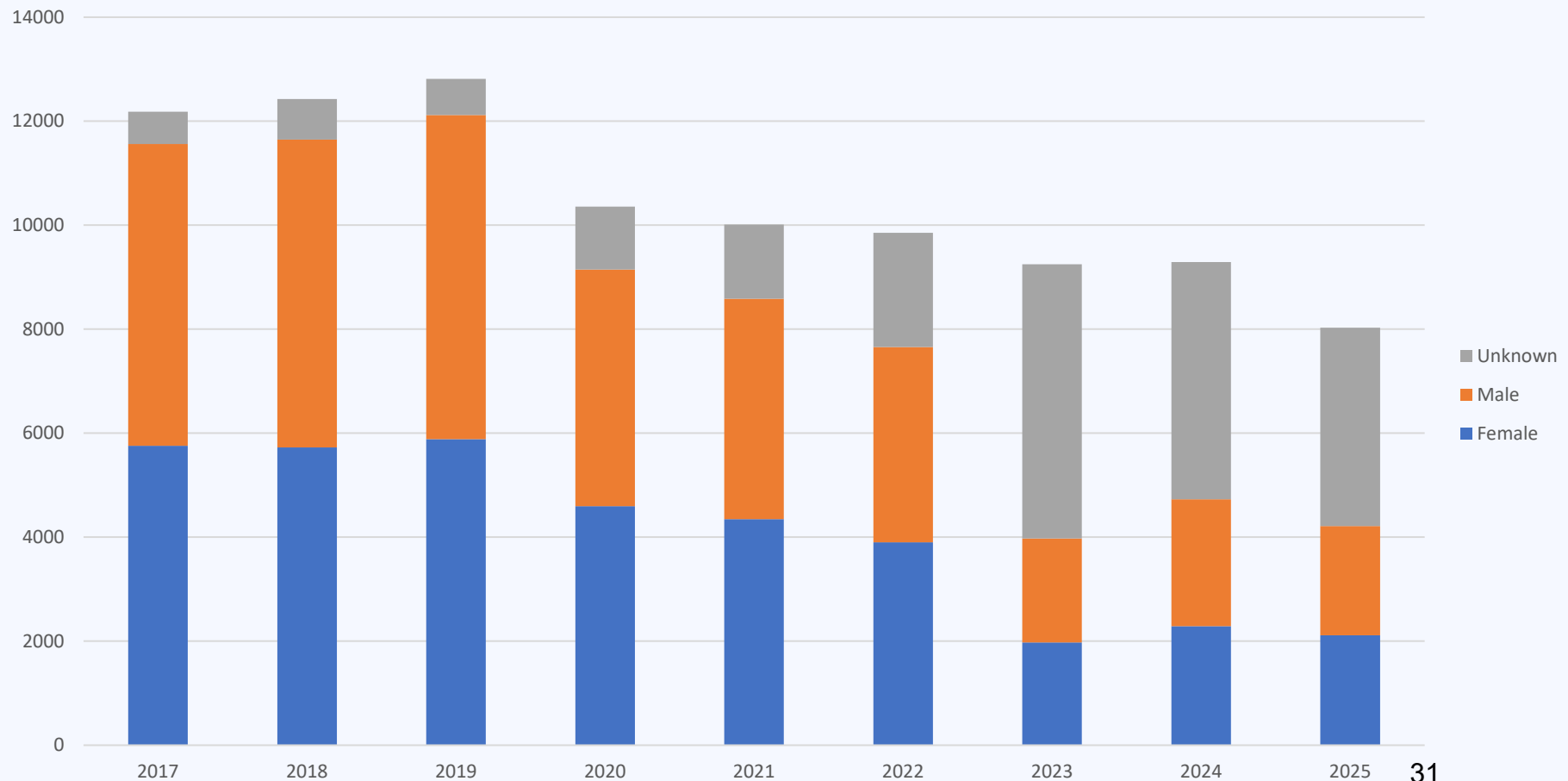


Total number of CINC filings by gender - quarters



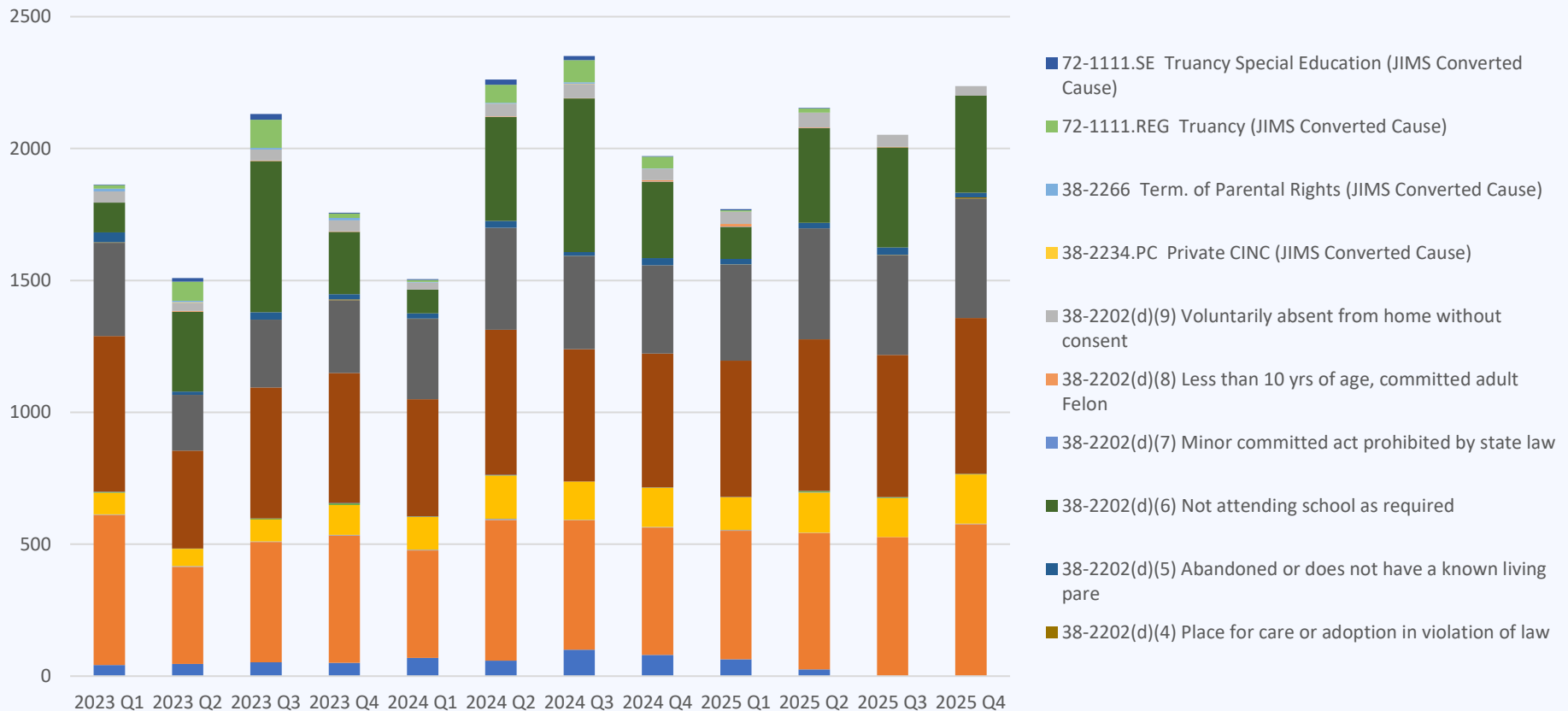


Total number of CINC filings by gender – fiscal years



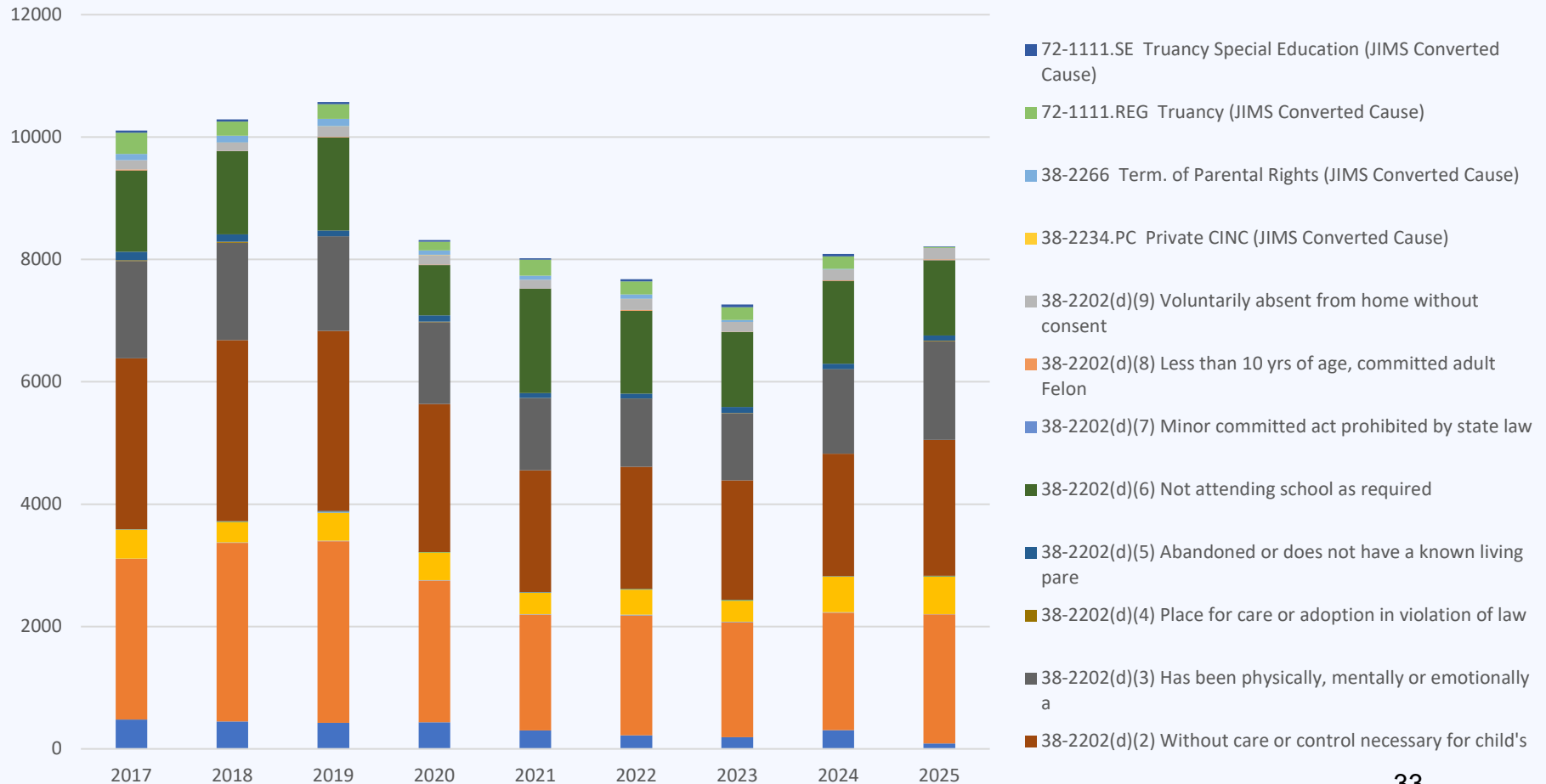


Total number of CINC filings by cause - quarter

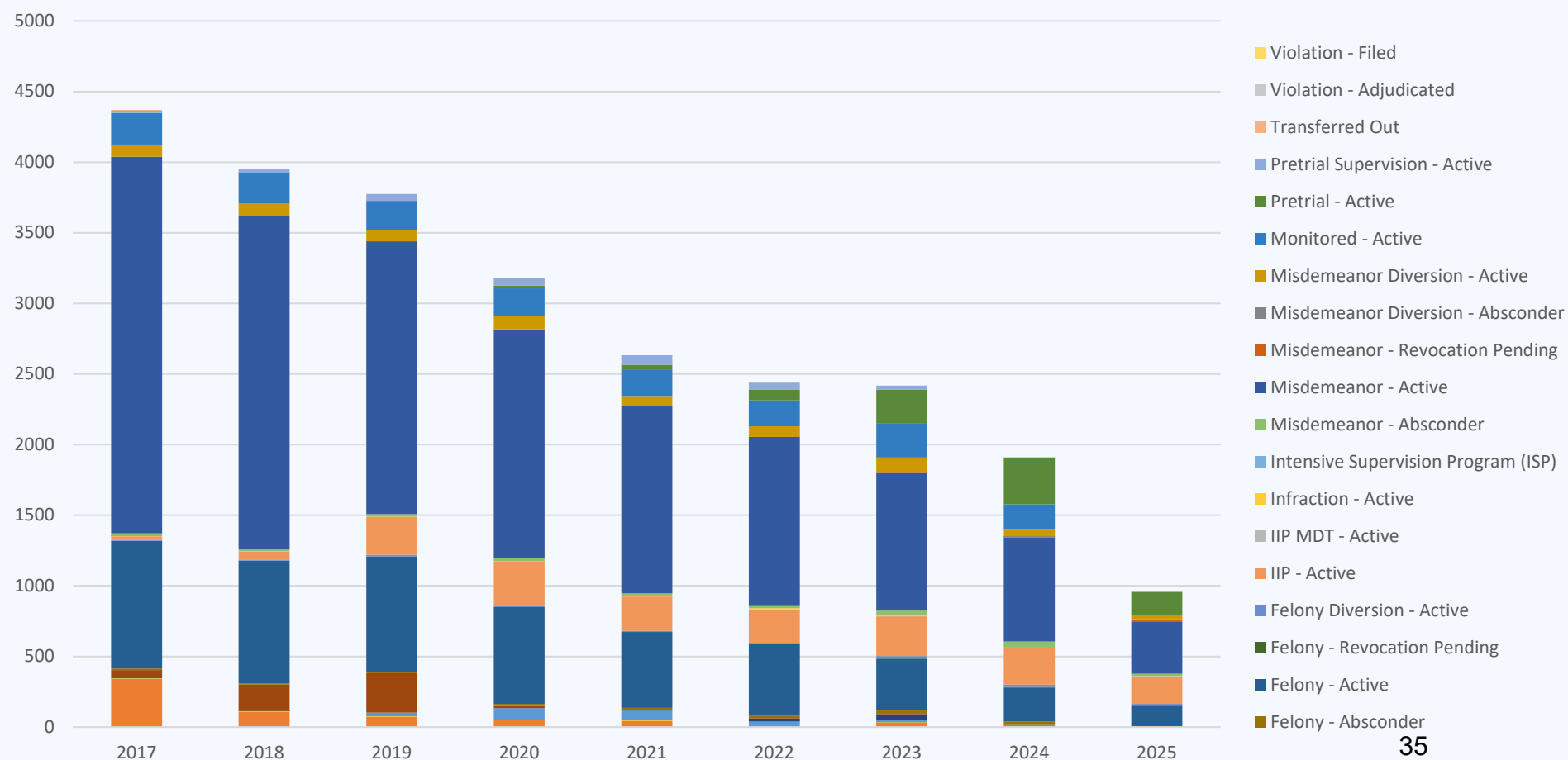

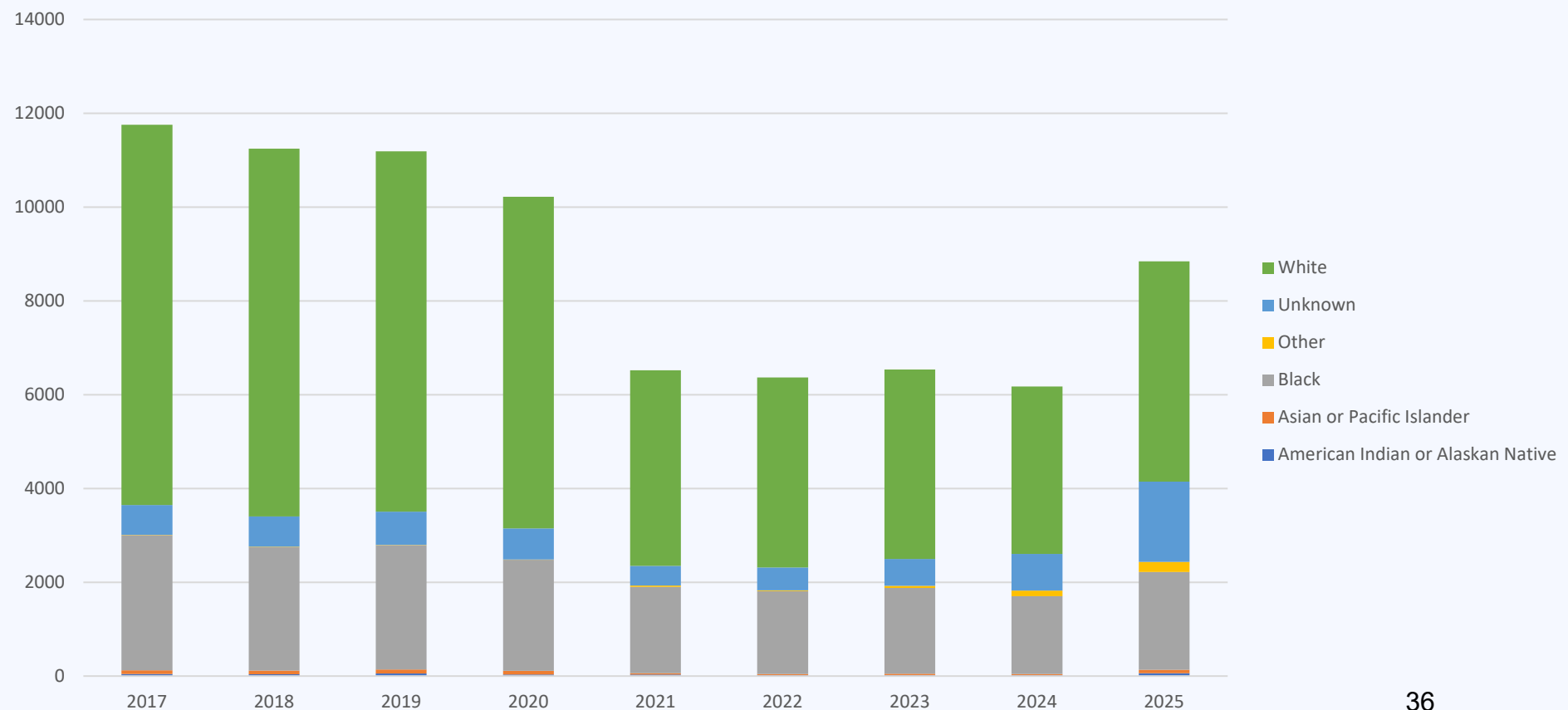


Total number of youth ordered to court services probation – fiscal years 2017-2025



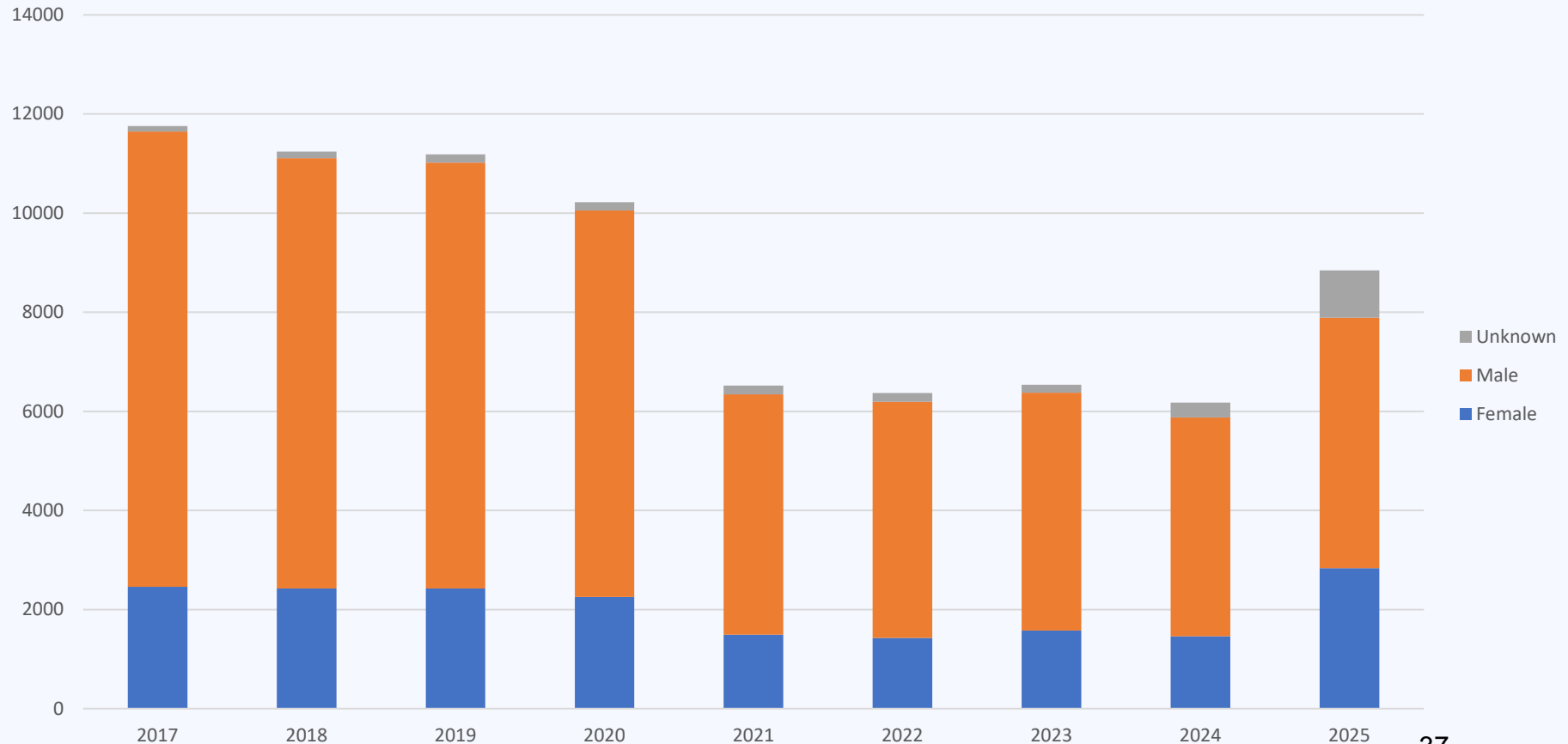


Total number of youth ordered to court services probation by race— fiscal year

Total number of youth ordered to court services probation by offense - July – March 2025



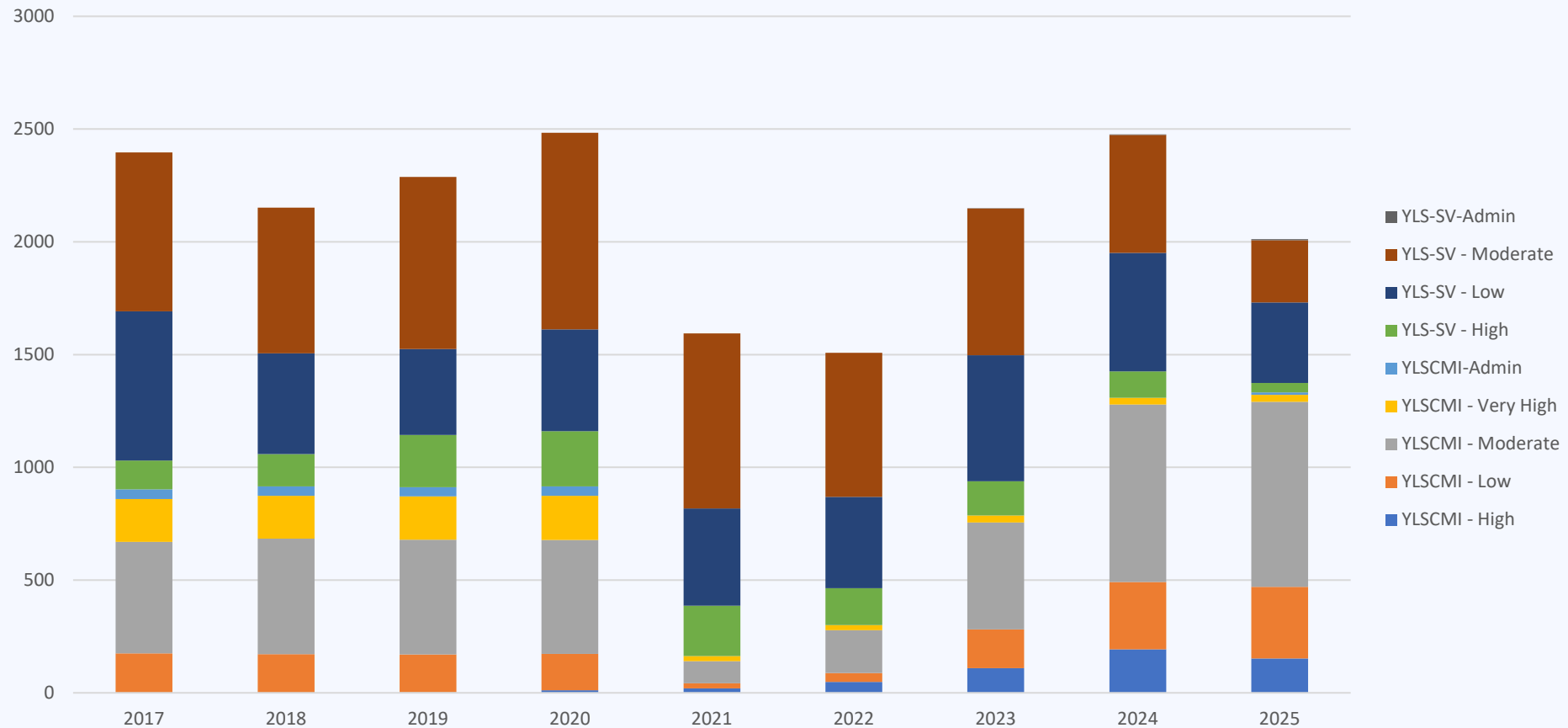


Total number of youth ordered to court services probation by offense – fiscal years 2017-2024

Average length of probation by race, gender, offense type



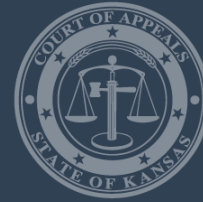
Average length of supervision for youth receiving EDC by race, gender, offense type

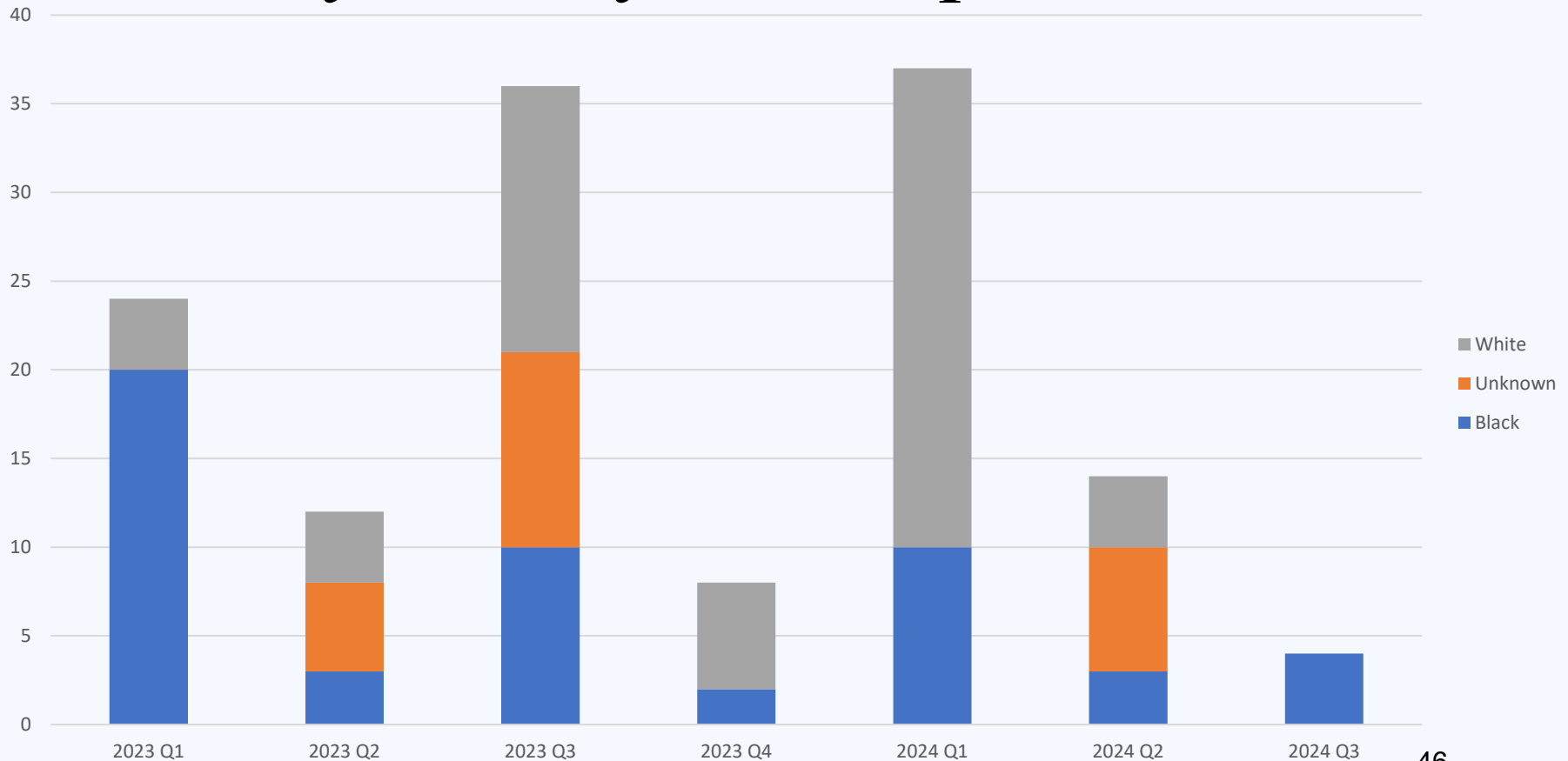

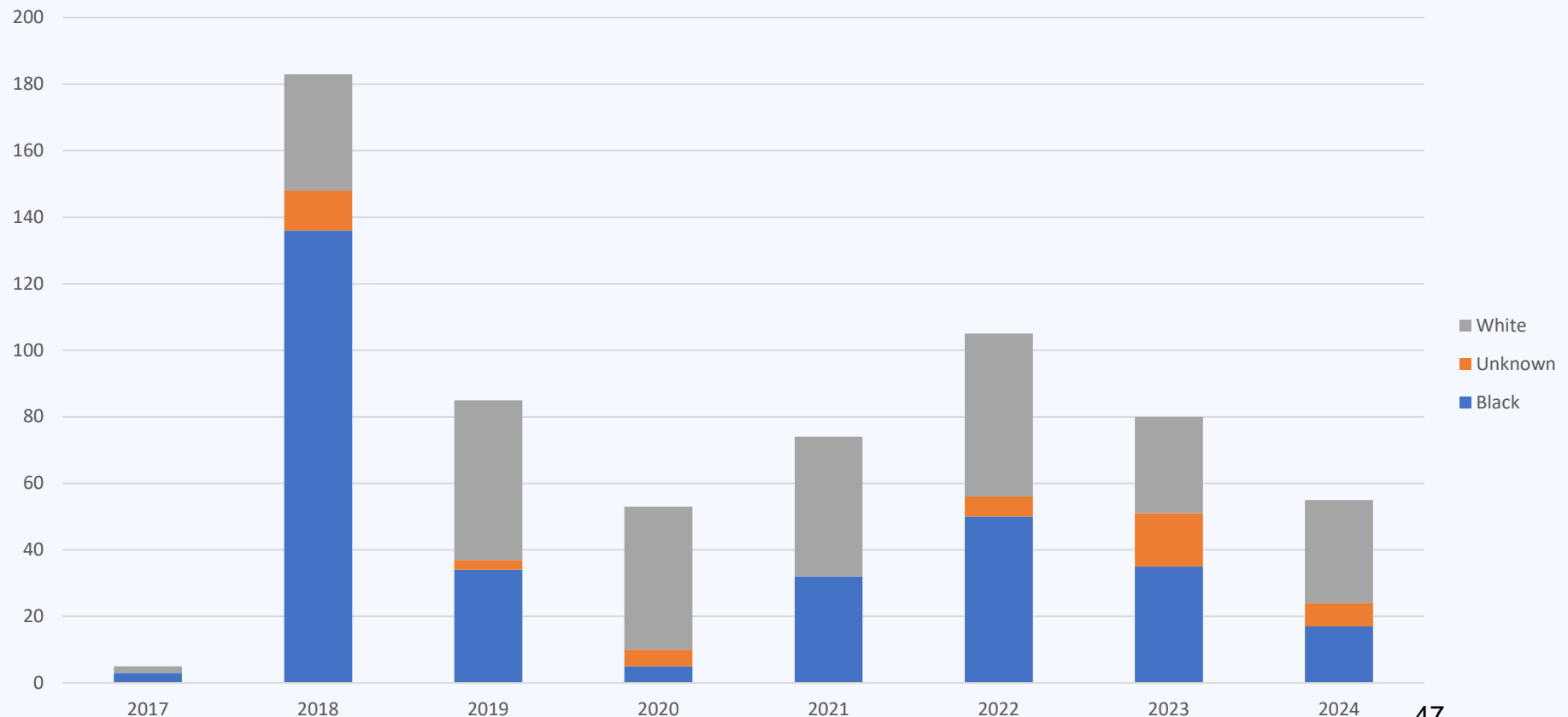


Number of cases transferred to the adult system by race - quarters



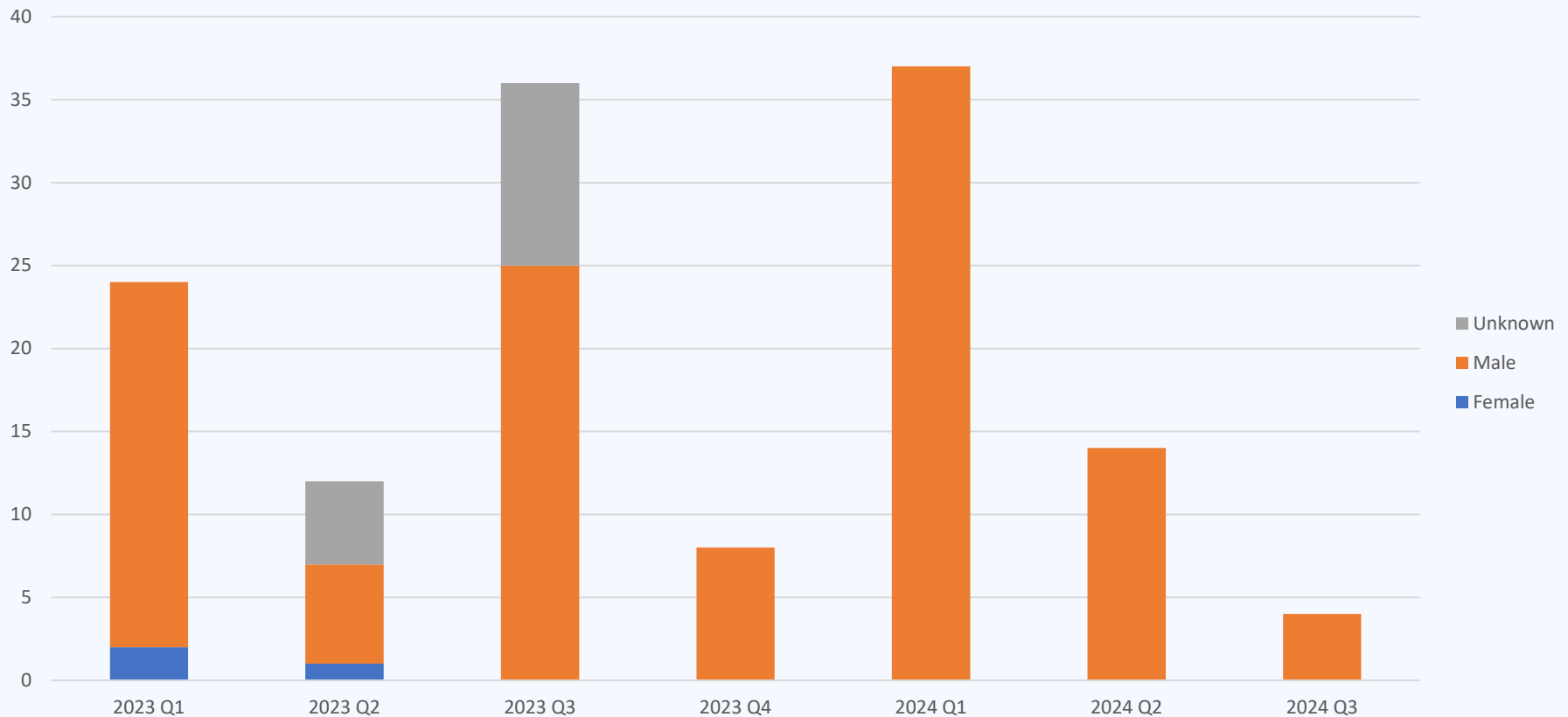


Number of cases transferred to the adult system by race – fiscal years



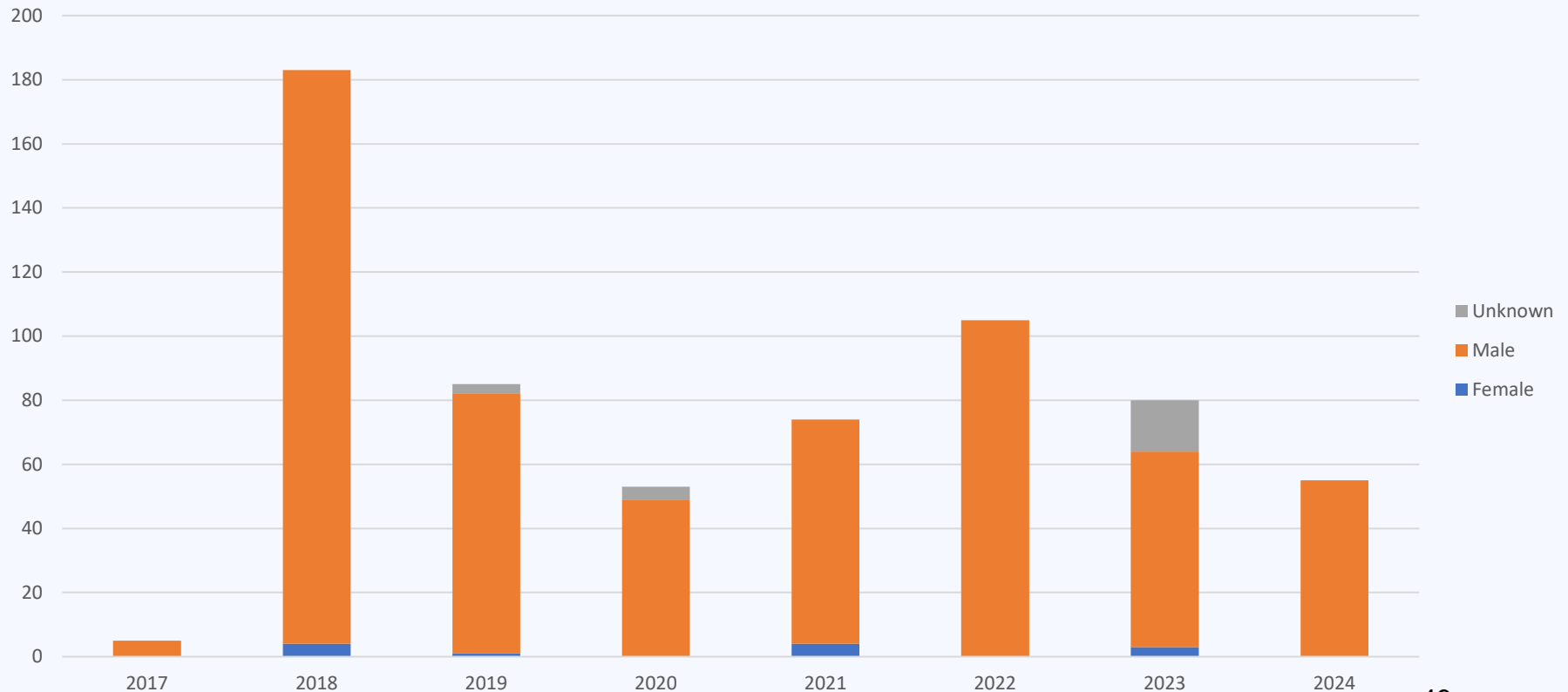


Number of cases transferred to the adult system by gender - quarters



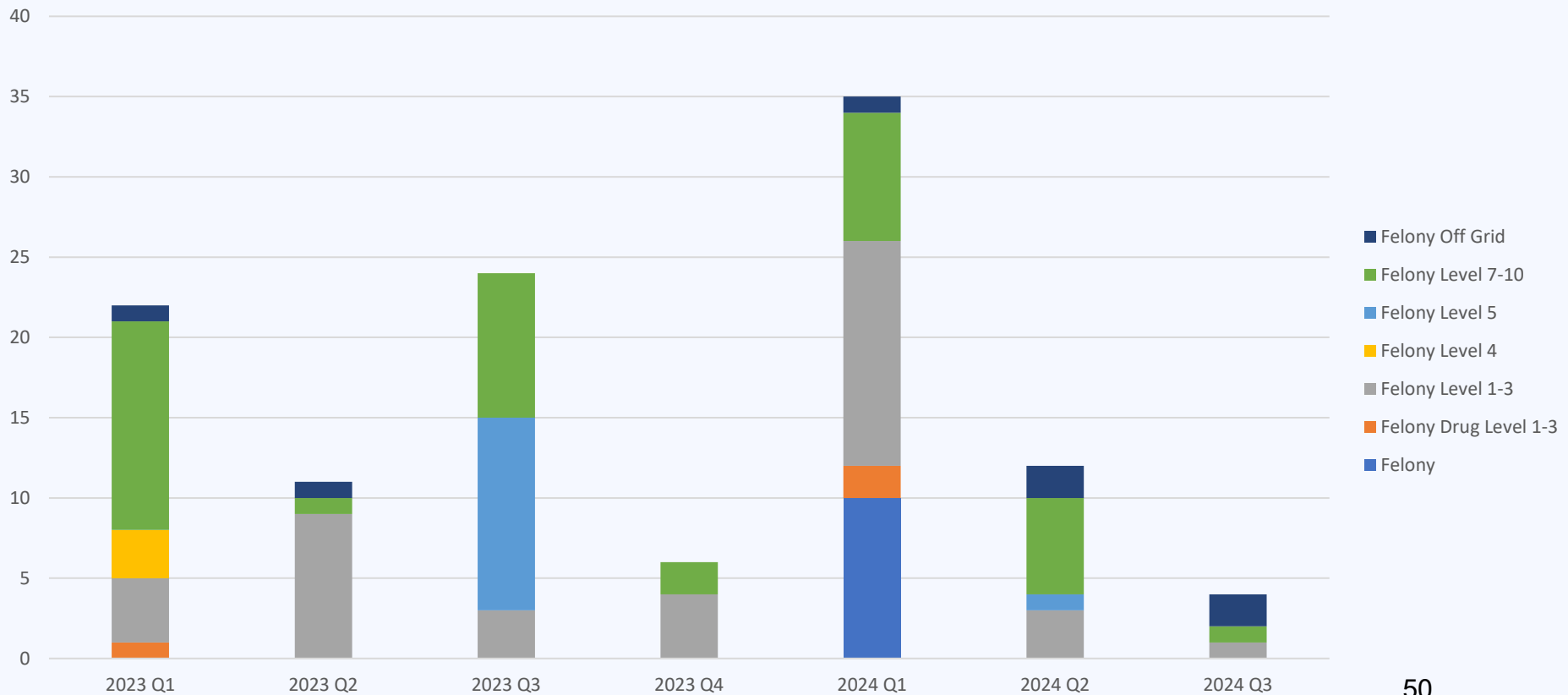


Number of cases transferred to the adult system by gender – fiscal years



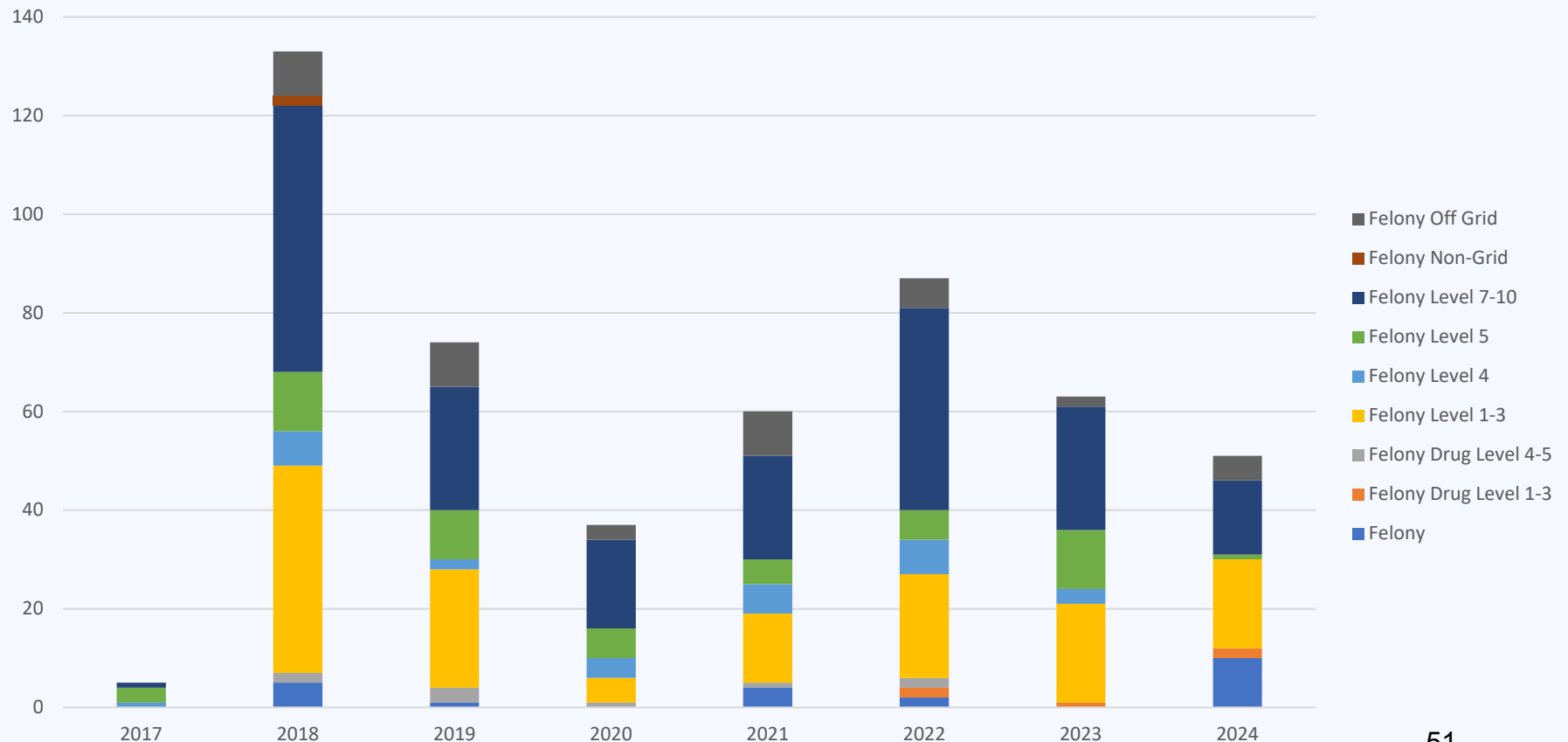


Number of cases transferred to the adult system by felony offense - quarters



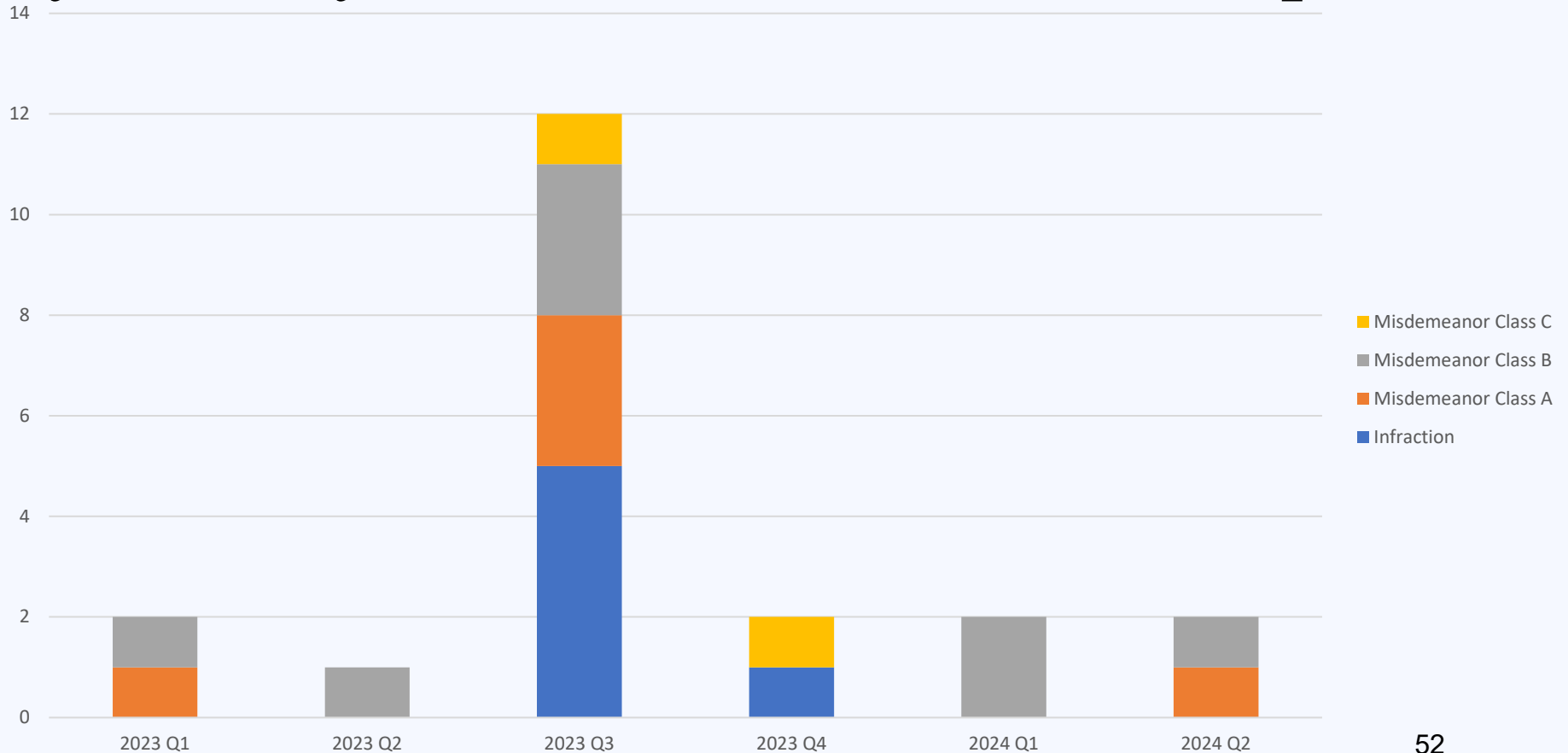


Number of cases transferred to the adult system by felony offense – fiscal years



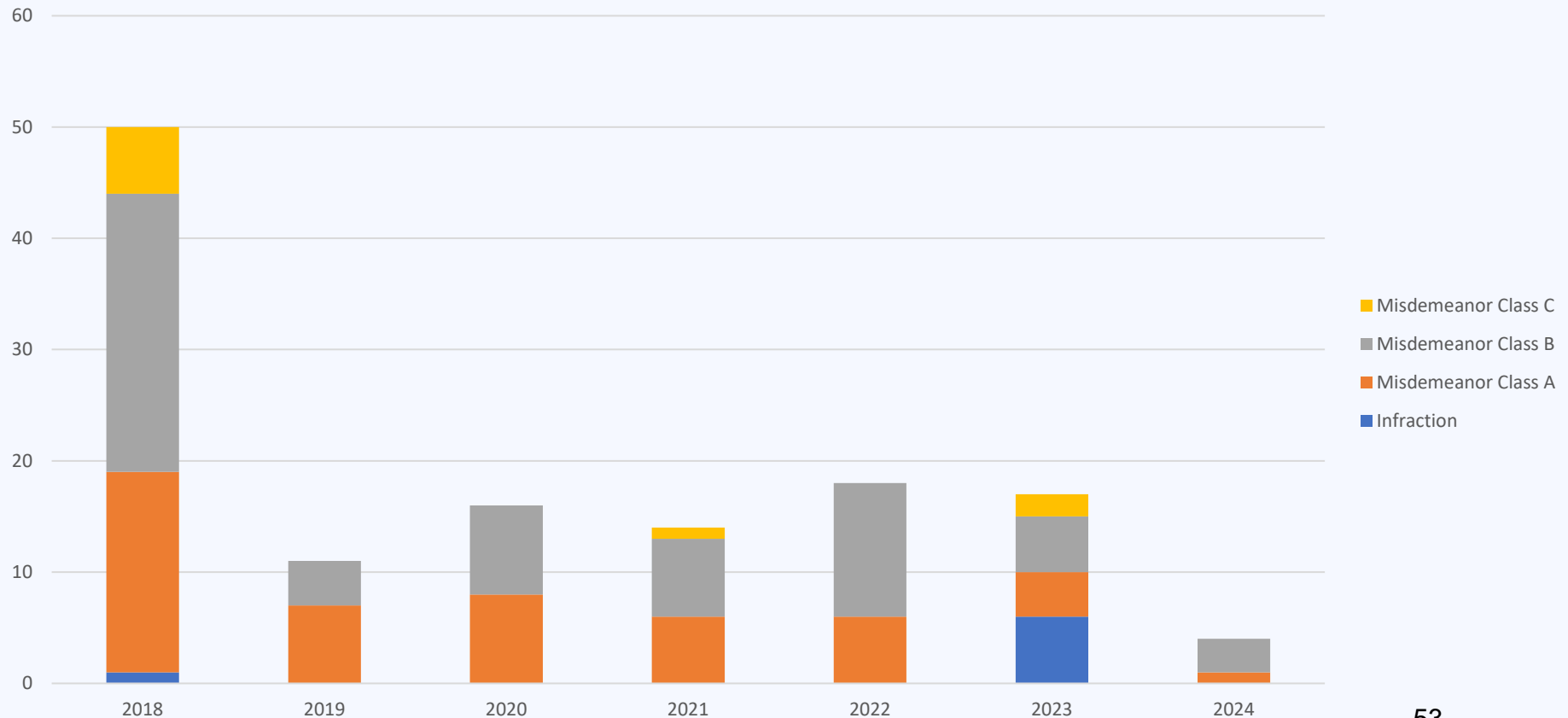


Number of cases transferred to the adult system by misdemeanor offense - quarters

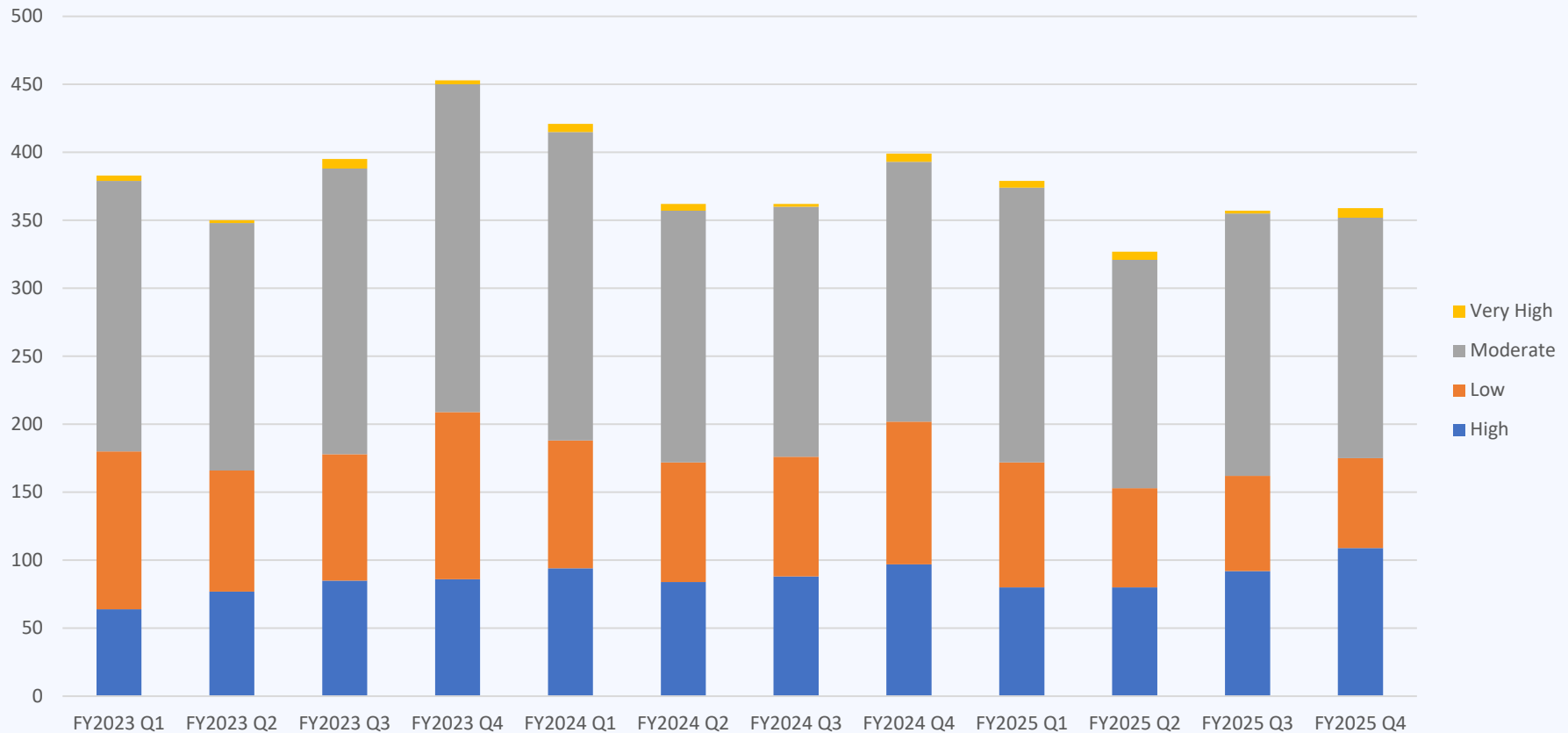

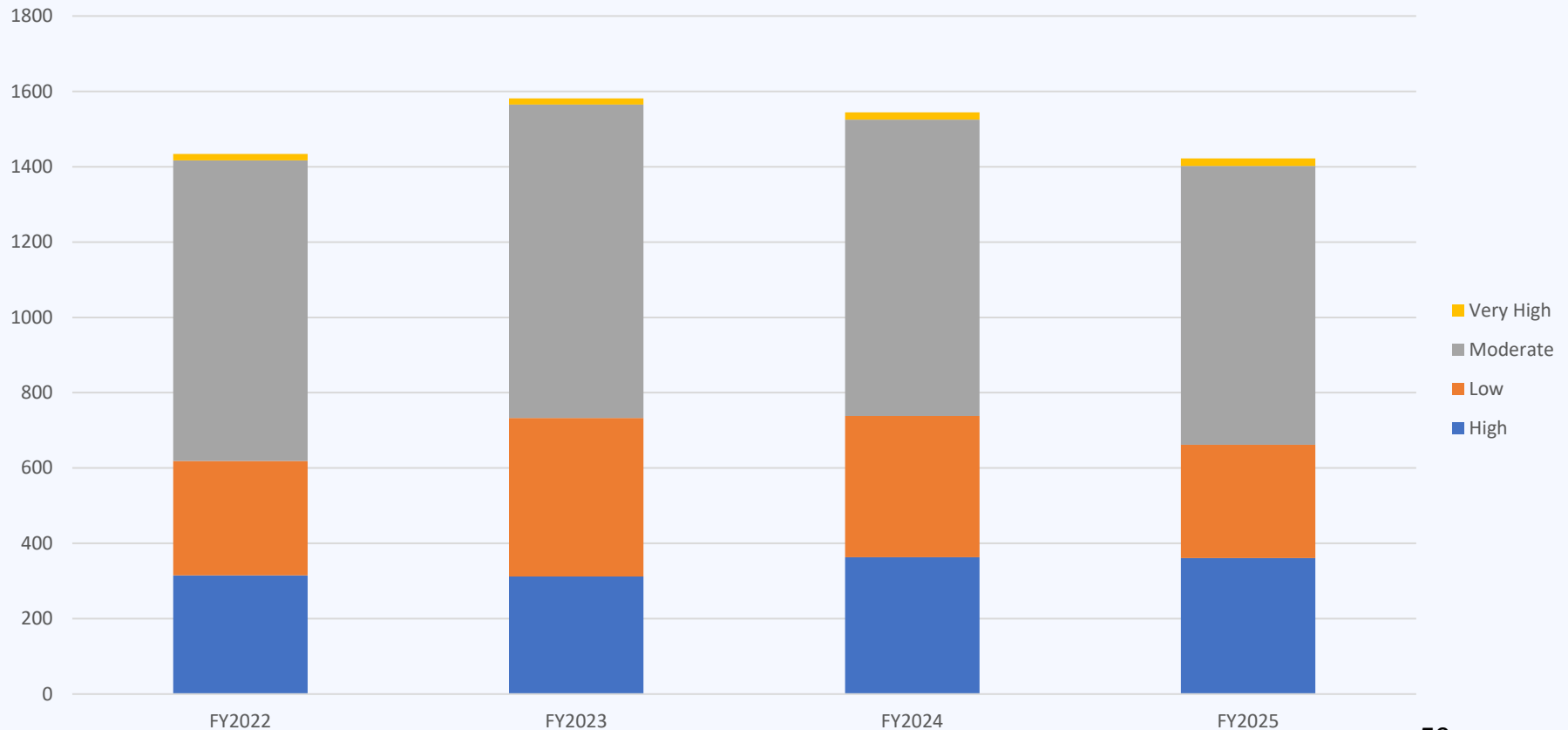


Total number of YLS/CMI completed and by risk level - quarters



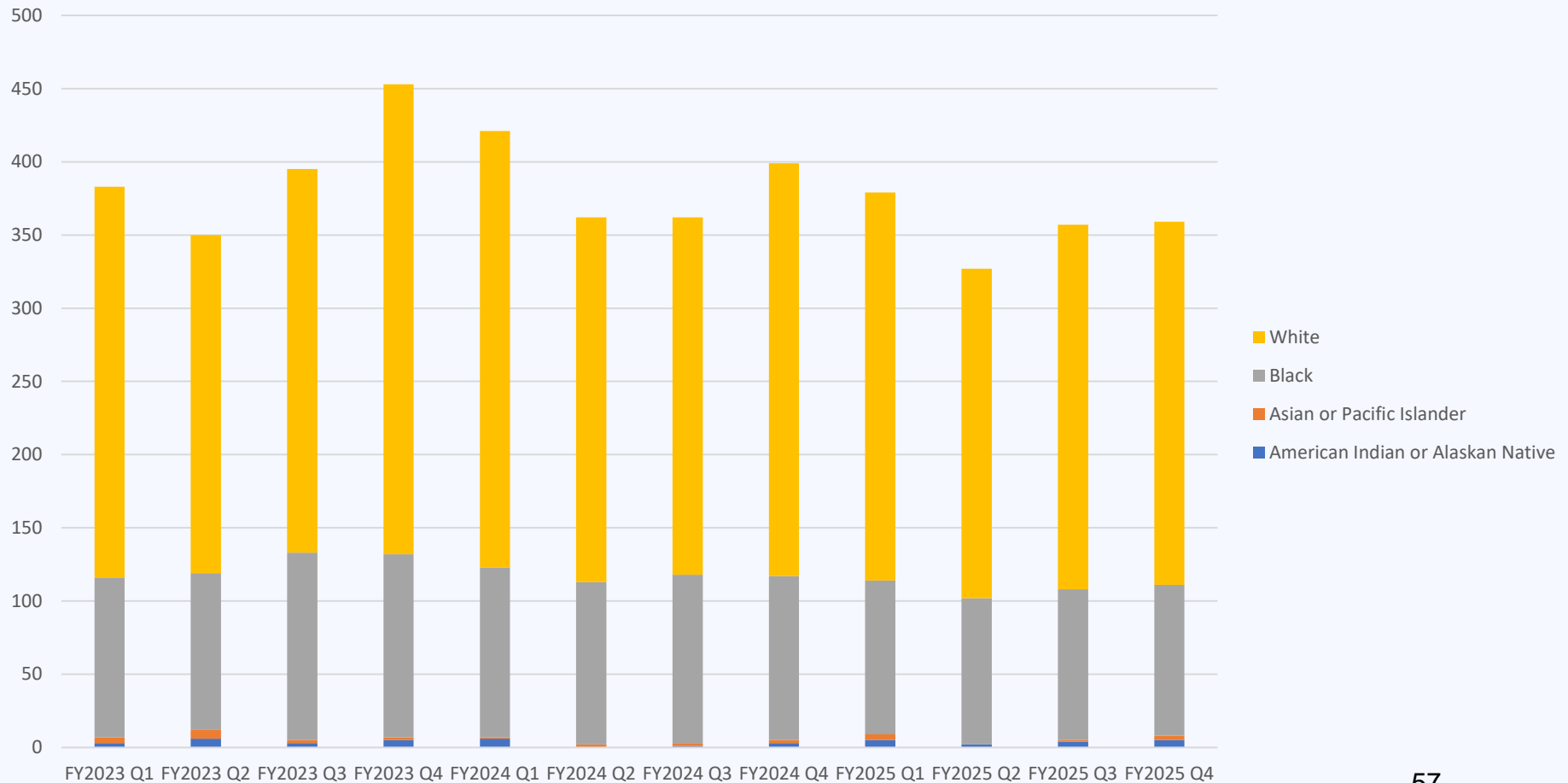


Total number of YLS/CMI completed and by risk level – fiscal years



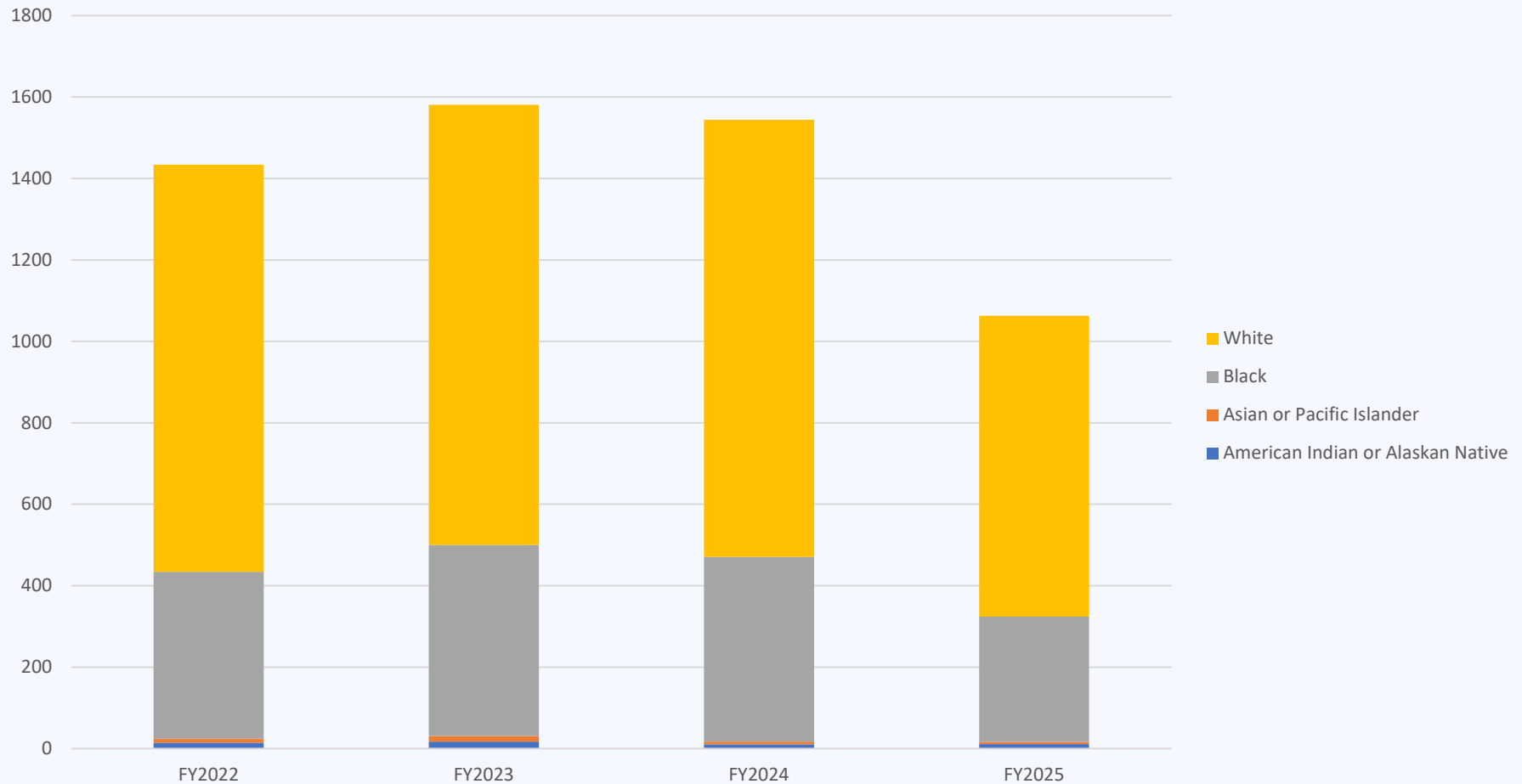


Total number of YLS/CMIs by race - quarters



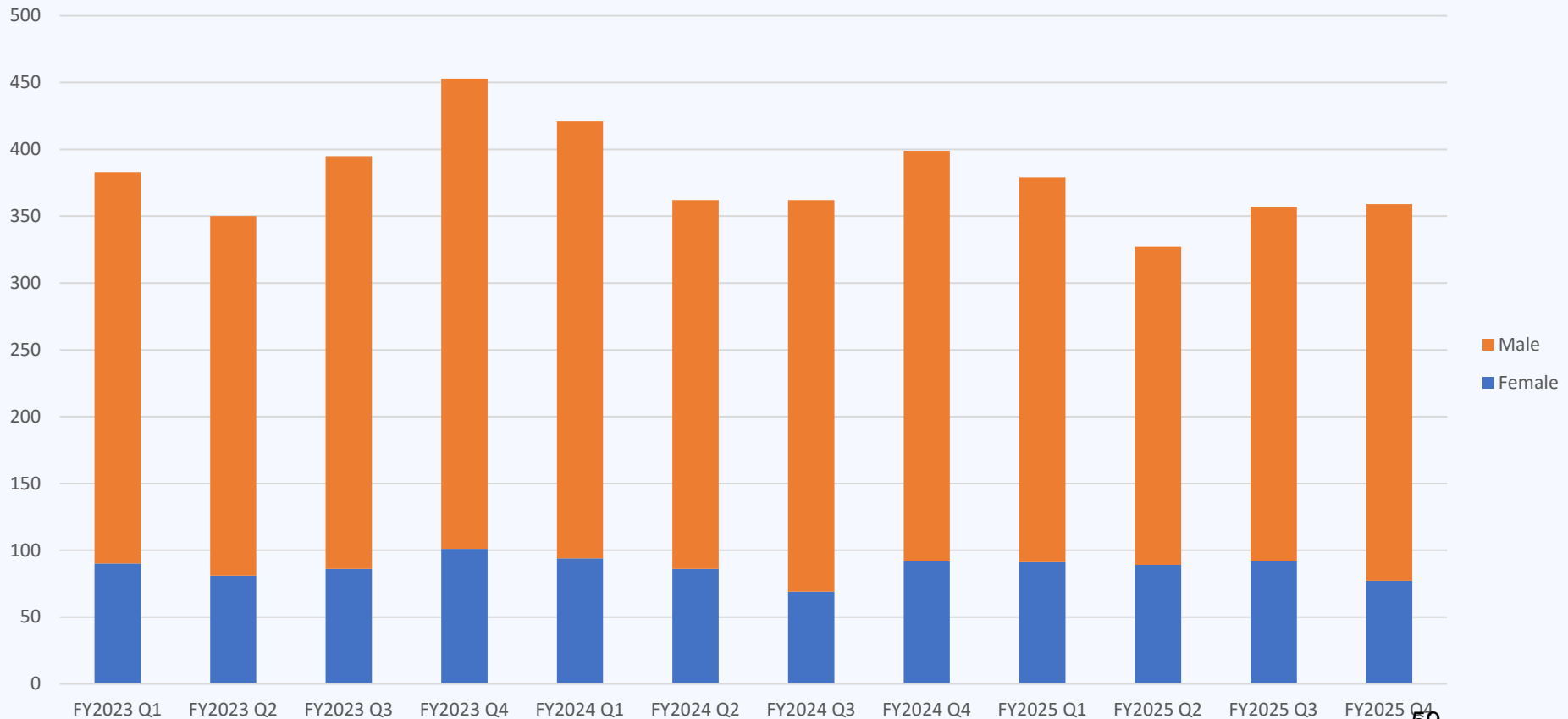


Total number of YLS/CMIs by race – fiscal years



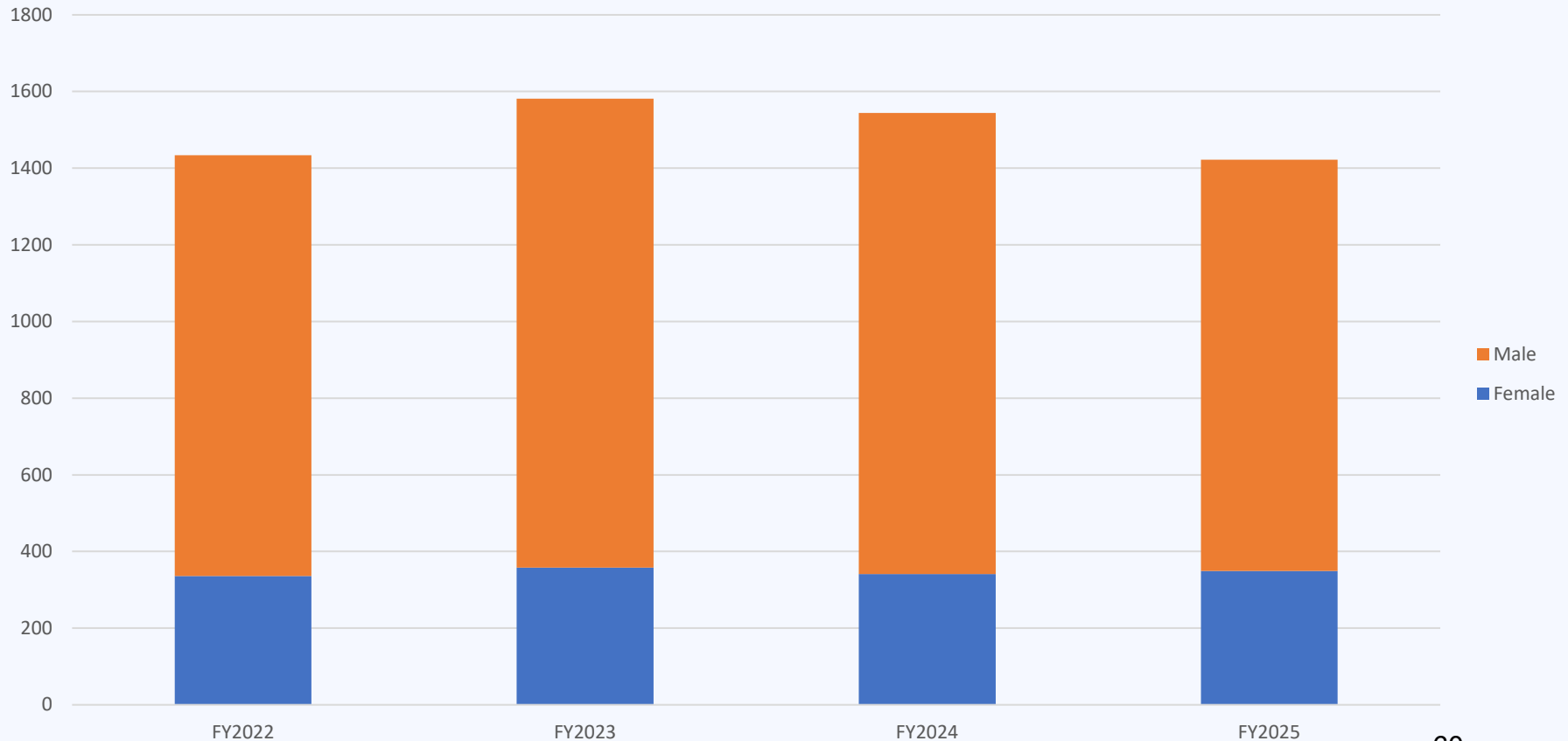


Total number of YLS/CMIs by gender - quarters

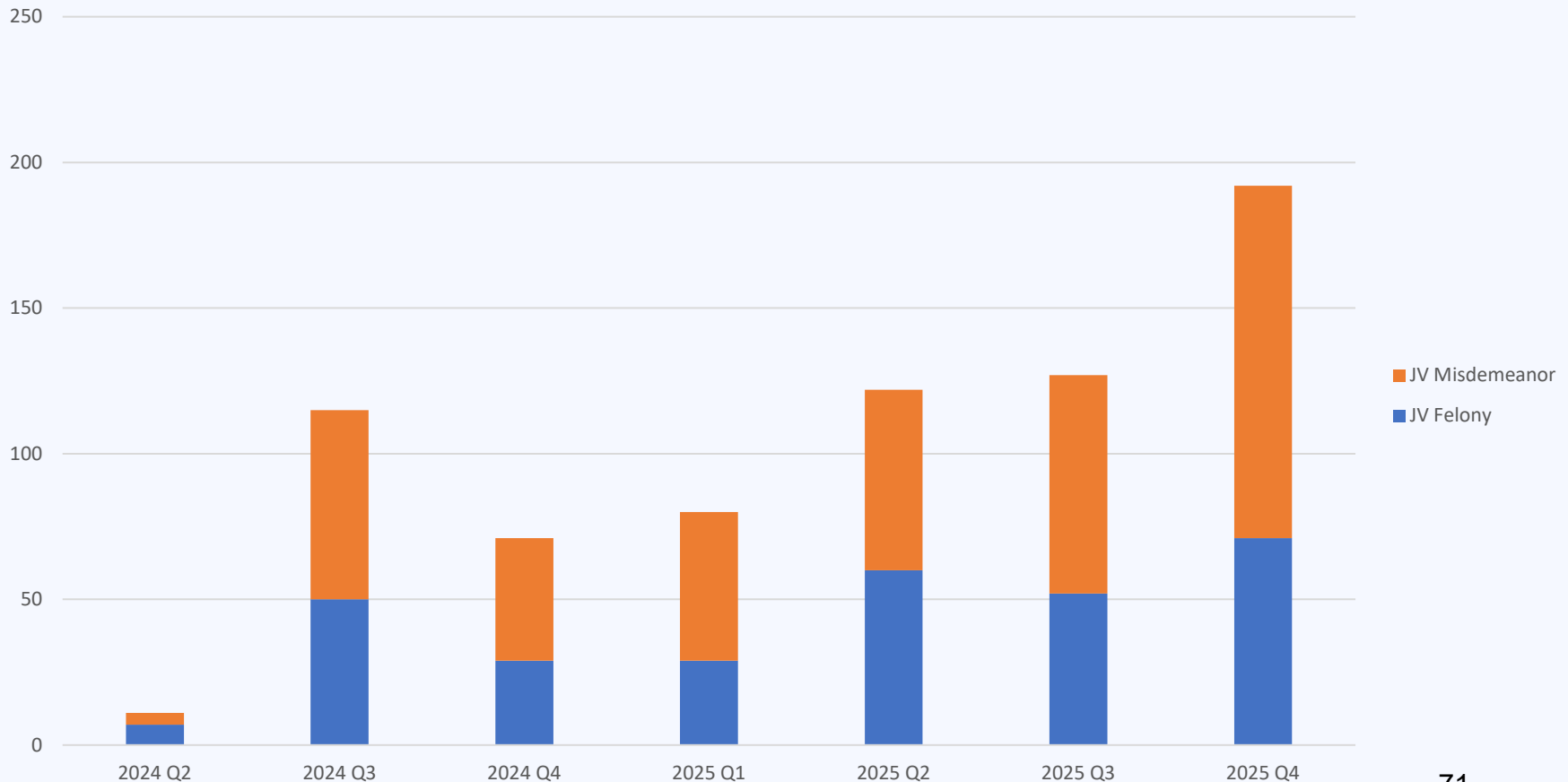

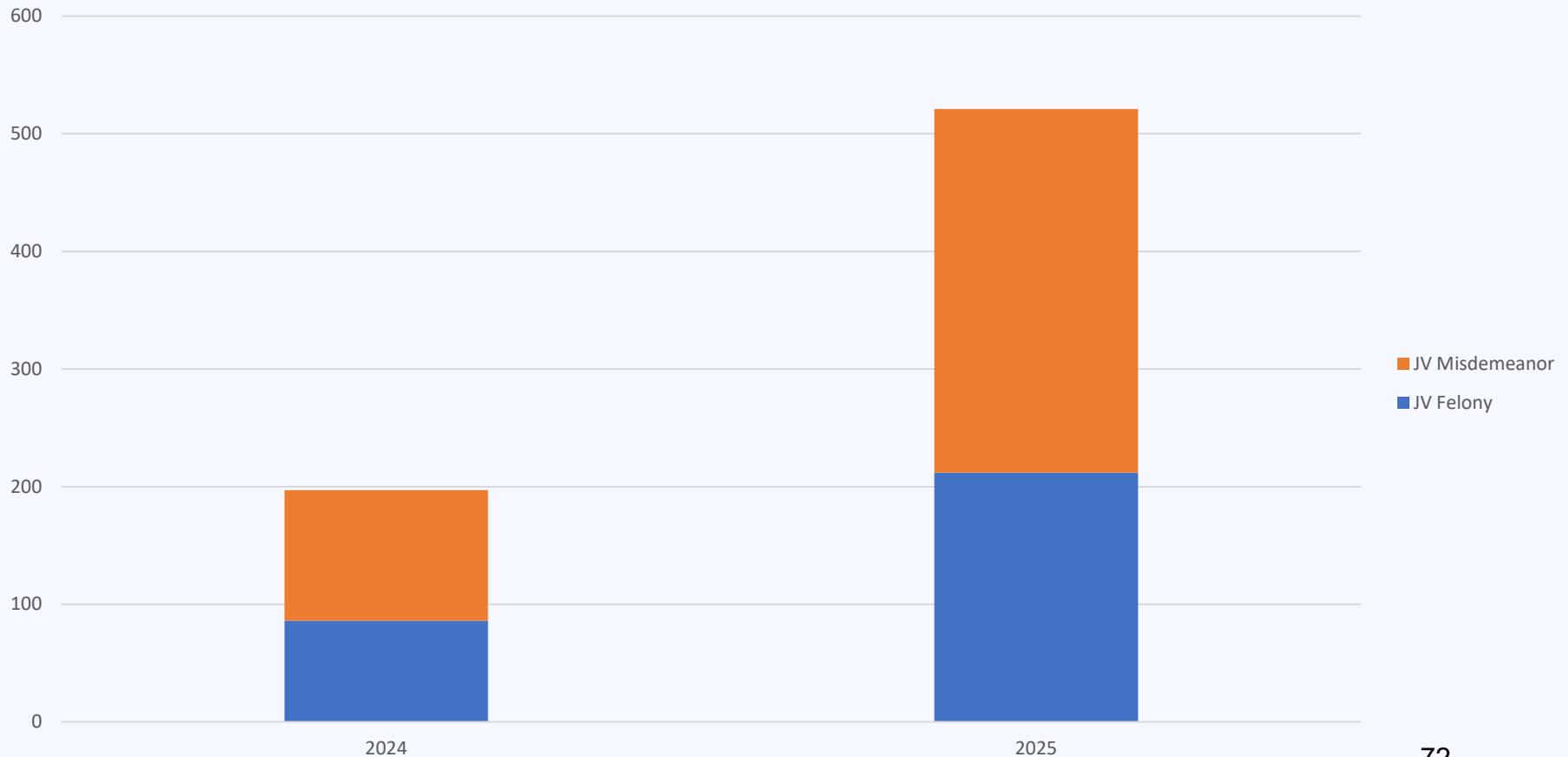


Total number of youth whose probation violation was reported to Court - quarters

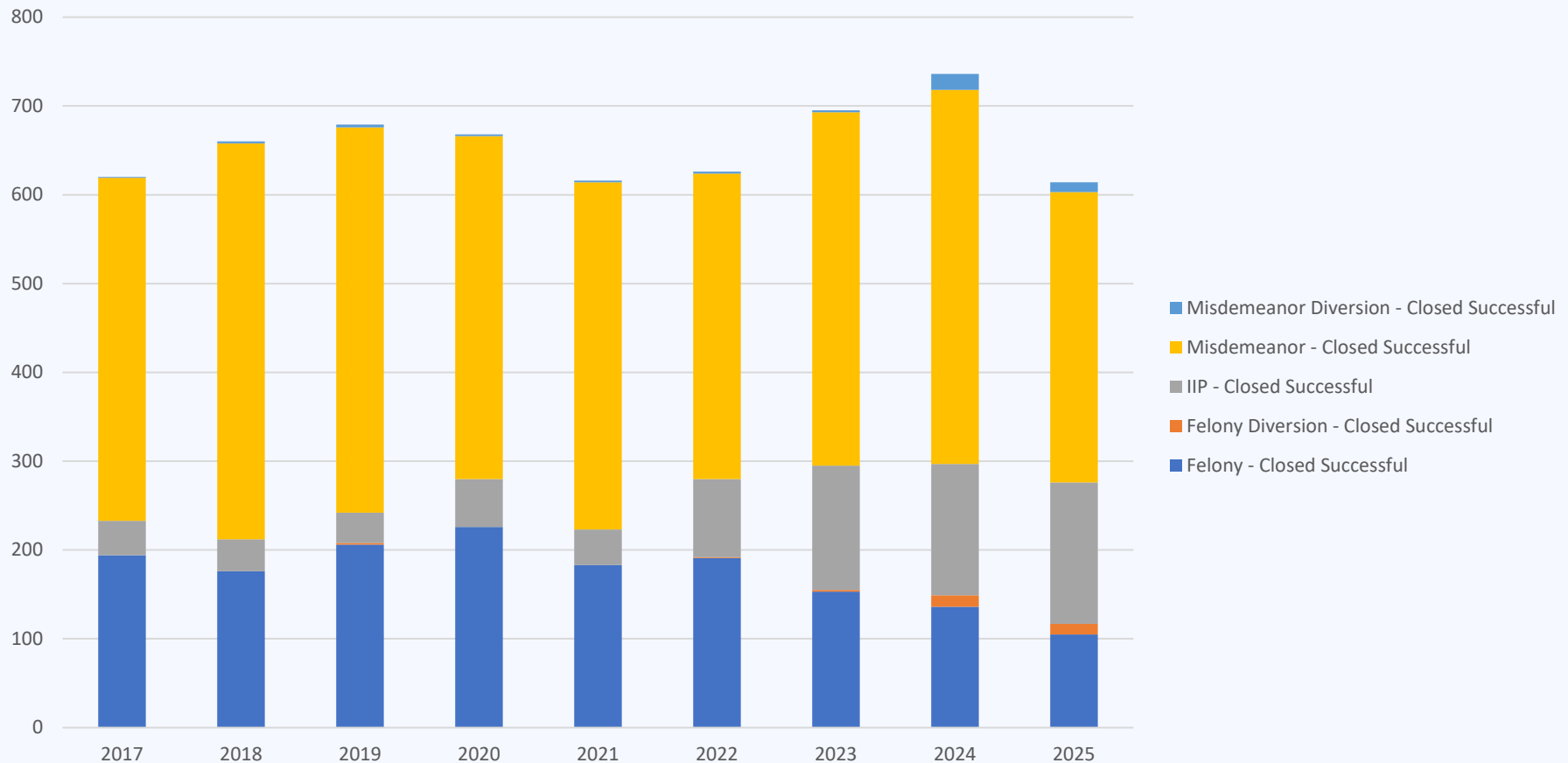


Total number of youth that probation length was extended.
