- 4. Approval of April 21st, 2023, meeting minutes: Motion by Megan Milner, 2nd by Shanelle Dupree, minutes approved.

5. Reinvestment

- i. EBF Allocation Recommendations Melody Pappan reported out on the work of the reinvestment subcommittee. The subcommittee discussed and is proposing allocations from the EBF fund. JJOC members discussed the different allocations. The discussion included working towards getting funds directly to the community. Members agreed that what is in the budget now is positive and no concerns, but that additional work should be done. If the allocation recommendations are approved, amendments can be approved at a later date.
 - 1. Motion to approve allocation recommendation by Steven Stonehouse, 2nd by Melody Pappan. Motion approved. (*During the initial vote on the motion, a member lost connection, causing a loss in quorum. A 2nd vote was conducted with 11 members present; motion approved.)*

- 8. Crossover youth report-out Ashley Brown informed us CYPM is working with pilot sites about protocol regarding youth being served. CYPM created an information flyer and video for Kansas schools and creating points of contacts in each Kansas school.

- 9. KAG Update Melody Pappan gave an update advising of a KAG retreat coming up.
- 10. MOU Validation OJA/KODC All agencies have signed and executed their MOU and the data collection is underway.
