Welcome & Introductions

Discussion Items

- Stepping Up A. Brown stated that the core team had a statewide webinar about the Stepping Up initiative and the role of the Council of State Governments. They will have listening sessions that are targeted toward professionals who serve youth.
- Change in SPT and Subcommittee meeting structure A. Brown stated that the
 coordinators discussed going to a quarterly meeting schedule for the main SPT and
 the subcommittees will continue to meet monthly. There were no objections from the
 members. M. Montgomery or D. Olson will send out a new Zoom invitation for the new
 meeting schedule.

Across the State

- KJCC Workgoup D. Olson reported that KJCC and DCF contractors agreed to the
 protocols for youth who are in foster care and are placed at KJCC. The next step is to
 discuss how to implement these protocols statewide. A. Miller stated that there were
 some concerns from agencies regarding the use of the term "agreement" and having
 agencies sign the form. The workgroup will meet regularly to check in on the status of
 the protocols and make changes as needed. The plan is to have staff trained by the
 end of August.
- KDOC Administrative Contacts/Directors June Meeting M. Montgomery provided an
 update on the work that has been done thus far, as well as plans for local and
 statewide CYPM work to the KDOC Administrative Contact/Directors.
- Additional District Crossover Work D. Browning stated he had no updates.

Updates

- Engagement with pilot sites
 - MGCO D. Olson reported that MGCO is close to completing the protocols. Once these protocols are finalized, they will plan trainings.
 - SGCO D. Olson stated that they are also very close to completing the protocols. Once finalized, they will schedule training on the new protocols.
 - SNCO A. Brown stated that SNCO will have their finalized protocol sent out this week. They are planning their training via webinar so that it can be recorded.
- Subcommittee Updates -
 - Policy Subcommittee A. Brown stated she has 4 policies that are ready to be presented to the permanency advisory committee. They will then be reviewed by the DCF policy work group. She shared these policies with changes that were made.
