<b>Overview:</b>	ART <sup>®</sup> is an evidenced-based, nationally recognized program that has been consistently shown to reduce aggressive, acting out behaviors while increasing pro-social behaviors in high-risk youth. ART <sup>®</sup> is a ten-week, multi-modal program with three coordinated and integrated components: Social Skills Training, Anger Control Training, and Moral Reasoning. Originally developed by Dr. Barry Glick and Dr. Arnold Goldstein, ART <sup>®</sup> has shown to be highly effective if delivered with integrity and fidelity to the program.
