RE: Summary of Changes to IMPPs – Distribution #587

The IMPPs listed below have been revised to address a number of outdated references. These include references to the Kansas Parole Board, accreditation references that have changed, and references to Kansas criminal statutes that have been re-numbered. Because these revisions do not include any substantive changes to policy or procedure, they have been presented directly to the Secretary without first advancing through the review procedures set forth within IMPP 01-101, as permitted under IMPP 01-101.III.B.3. Such references have been identified in approximately seventy (70) IMPPs, which will be similarly revised over the coming months.

Per IMPP 01-101, new and revised policies shall be distributed, prior to their implementation, to designated staff, contract personnel, volunteers, and when appropriate to inmates/offenders and designated agencies. The yellow highlighted IMPPs listed in this document are considered "STAFF READ ONLY" and shall not be included in the distributions to agencies or organizations not authorized such access.
